6. City Deal - Delivery and Performance Update Report

A collection of reports were presented which gave various delivery and performance updates. The following was highlighted for the Board's attention:

Sarah Parry, City Deal Programme Manager, Lancashire County Council, presented the Homes England monitoring report which stated that they had completed over 1700 units against the target of 4000, and 25% of currently delivered units were affordable or social rented units. Outline planning consent had been agreed on all sites, and £25 million of the £37.5 million grant which was agreed at the outset of the Deal had now been paid. The Infrastructure Projects Monitoring Report outlined that most schemes had been completed or were currently paused, except for the Preston Western Distributor and the Bamber Bridge safety works.

Deborah Holroyd-Jones, Homes England, reported to the Board that the remaining £12.5 million of the grant funding had provisional agreement to be paid in, subject to internal formal approvals and a continuation of the City Deal partnership.

Leigh Mclaughlin, Employment and Skills Coordinator, Lancashire County Council, reported the social and economic value of various projects and highlighted that 58 new jobs, 45 separate work placements, and over 30 apprenticeships had been created. It was further reported that legacy data sources used to track employment and skills was no longer available and it weas therefore requested that the Board accept the update provided as the final report in this series.

The steel frame is complete along with the roofing. The external façade is progressing on all sides, with the installation of the SFS walls, insulated cladding panels, decorative cladding and brickwork. The curtain walling and glazing is being installed, allowing the internal partitioning to commence. The works remain on programme for completion on the 28 October 2024, however the contractor has lost time on the external façade, due to the wet weather over the last few months. Progress is being closely monitored to ensure any mitigation plans can be implemented to maintain the completion date. The planned works over the next few months will see the external walls completing, and the internal fit out progressing.
