## **Executive Summary**

On 11 January 2013 the Cabinet Member for Children and Schools received a report on a proposal to close Out Rawcliffe Church of England Primary School.

After considering the report the Cabinet Member decided to:

"approve (determine) the proposal as detailed in the statutory notice: to discontinue Out Rawcliffe Church of England Primary School on 31 August 2013."

Following requests from five County Councillors in accordance with the Overview and Scrutiny "Call In" procedures, the Chair has called a special meeting of the Committee to consider calling in the above decision.

## Recommendation

In accordance with the Call In procedures contained in Procedural Standing Orders (Standing Order 23 and Appendix 3) the Committee is asked to consider:

- 1. Whether or not to request the Cabinet Member for Children and Schools to reconsider the decision made on 11 January 2013 to discontinue Out Rawcliffe Church of England Primary School on 31 August 2013.
- 2 If the Committee decide to request that the decision should be called in then to determine the grounds on which the request is to be based.

## **Background and Advice**

On 11 January 2013 the Cabinet Member received a report on the closure of Out Rawcliffe Church of England Primary School. A copy of the report is attached as **Annex 'A'.** 

After considering the report the Cabinet Member decided:



"to discontinue Out Rawcliffe Church of England Primary School on 31 August 2013"

On 16 January 2013 the Chief Executive received a request, signed by five County Councillors, for the Education Scrutiny Committee to consider whether that decision should be the subject of a Call In. The request was received in accordance with Procedural Standing Orders from County Councillors Vivien Taylor, Geoffrey Roper, Andrea Kay, Jim Lawrenson and Stan Leadbetter and means that the decision taken on 11 January 2013 cannot now be implemented until the call-in procedure is completed.

The reasons given for the request as submitted by the above Members are:

- Information provided by Action Group for initial consultation period was not considered by Cabinet member as this was not forwarded by officers – Action Group contacted LCC to confirm that they would resend the initial information however were informed by LCC that this would not be required, and therefore a significant amount of information was not available for consideration by the Cabinet Member
- 2) Information provided by LCC to Governing Body re type of Federation the school could become was incorrect and therefore the Governing Body could not provide the relevant information for LCC consideration for future of school
- 3) LCC commented in the report that they had only received 2 objections to the closure plus letters from the Chair of Governors and Headteacher when in fact 126 letters of objection to the proposed closure, plus a petition with over 1000 signatures, plus a proposal for a Nursery and letters of support for the school from the people who would run the Nursery, plus information detailing the proposed year on year headcount increase, plus information detailing approved planning permission for 14 units to be built within Out Rawcliffe had been provided
- 4) The LCC report recommending closure of the school stated that there was no evidence of community based activity by the school. Community activity was provided for the initial consultation and not forwarded to the Cabinet Member

To assist the Committee, the Call In procedures contained in Procedural Standing Orders (Standing Order 23 and Appendix 3) are summarised below:

- Any five County Councillors may, within three days of an executive decision being published, request that a special meeting of the relevant Overview and Scrutiny Committee be convened to consider that decision.
- The executive decision shall not be implemented until the Call In procedure is completed.
- An O&S Committee may request that an executive decision made but not yet implemented be reconsidered by the Decision Maker, or request that the Full Council decide whether to ask the Decision Maker to reconsider.

- The Committee must decide at the meeting whether or not to exercise its Call In powers.
- Any such request for reconsideration shall include the grounds upon which the request is based.
- Once the Committee has determined to make such a request, the request and the grounds upon which it is based must be registered with the Chief Executive in writing within three clear working days of the O&S Committee.
- If a request is made the Decision Maker must then reconsider the decision having regard to the grounds upon which it is based. The Decision Maker can affirm, amend or rescind their decision.
- The Decision Maker shall publish their response to a request for reconsideration and the reasons for their decision by writing as soon as is reasonably practicable to the Chair of the relevant Overview and Scrutiny Committee.
- The Decision Maker can only be required to reconsider the same decision once.
- An Overview and Scrutiny Committee shall not exercise its functions;
  - (1) where the decision has been designated by the Decision Maker as being urgent in that any delay in its implementation could adversely affect the efficient execution of the County Council's responsibilities; or
  - (2) in respect of day-to-day management and operational decisions taken by officers.

Of particular relevance in the above provisions are the requirements that the Committee must determine at the meeting whether or not to request that the decision be reconsidered, and if so to determine the grounds upon which the request is to be based.

The Committee is required to meet within 7 working days of the request being received in order to consider the call and following consultations with the Chair and Deputy Chair a special meeting has been arranged for Friday 25 January 2013 at 10;30am in Cabinet Room D at County Hall, Preston.

## **Executive Summary**

This report aims to provide sufficient information on:

- the proposal to close Out Rawcliffe Church of England Primary School with effect from 31 August 2013;
- factors that the Decision Maker must take into consideration when determining the proposal and commentary on how the proposal addresses these factors; and
- the responses received during the statutory notice period

in order for the Decision Maker to make a determination in respect of the proposal.

In the early months of 2012, local authority officers and officers representing Blackburn Diocese discussed the future of Out Rawcliffe CE Primary School with the school's governing body. The discussions arose as a result of concerns about the school's educational and financial viability due to rapidly declining pupil numbers and budgetary difficulties. After considering the feasibility of continuing as at present; collaborating or federating with another school; or consulting on the future of the school, on 22 March 2012 the governing body agreed to pursue the latter option.

On 8 May 2012, Cabinet Member for Children and Schools agreed to stage 1 consultation on a proposal to close Out Rawcliffe CE Primary School with effect from 31 August 2013.

Between 14 May 2012 and 20 July 2012 the authority consulted on a proposal to close Out Rawcliffe Church of England Primary School with effect from 31 August 2013. After considering the consultation outcome and agreeing (on 27 September 2102) to proceed with the proposal, the authority published a statutory notice on 8 October 2012. In accordance with the statutory process for school discontinuance proposals, the notice invited representations (objections or comments) within the statutory six week notice period, i.e. from 8 October 2012 to 19 November 2012.

Under the statutory school discontinuance procedure, a decision should now be taken about the proposal. If the authority fails to decide the proposal within two months from the end of the representation period, the proposal and any representations about the proposal must be passed to the schools adjudicator for decision.

The constitutional arrangements of the County Council provide for the decision to be taken by the Cabinet Member for Children and Schools.

This is deemed to be a Key Decision and Standing Order 25 has been complied with.

## Recommendation

The Cabinet Member for Children and Schools is recommended to:

- (i) consider the information in this report;
- (ii) approve (determine) the proposal as detailed in the statutory notice: to discontinue Out Rawcliffe Church of England Primary School on 31 August

2013; and

(iii) approve that an appropriate statutory decision letter be sent out as specified under legal requirements to give the reasons for the decision to those who are to be informed of them.

## Background and Advice

After the authority's publication of a statutory notice on 8th October 2012 and expiry on 19 November 2012 of the six week statutory period for representations to be made about the proposal, the authority is now at stage 4 of the 5 stage statutory process. This is summarised below:

Full details of the school discontinuance proposals to be considered are in Appendix 'A'. The information contains the published notice and complete proposal.

## Checks on receipt of Statutory Proposals

Before judging the merits of a statutory proposal, DFE Guidance 'Closing a Maintained Mainstream School, a Guide for Local Authorities and Governing Bodies' advises that there are four key issues which the Decision Maker should consider:

- Is any information missing?
- Does the published notice comply with statutory requirements?
- Has statutory consultation been carried out prior to the publication of the notice?
- Are the proposals 'related' to other published proposals (and should therefore be considered together)?

There is no information missing. The information is provided in the published notice and complete proposal at Appendix 'A'.

The published notice complies with statutory requirements.

Statutory consultation was carried out prior to the publication of the notice. Cabinet report dated 27 September 2012 provides details of the stage 1 consultation and responses received.

The proposal is not 'related' to any other published proposals.

## Representations

By the close of the representation period on 19<sup>th</sup> November 2012, the local authority had received four written representations: two joint responses from the associate headteacher and chair of governors of Out Rawcliffe CE Primary, on behalf of the governing body, and two individual objections as follows:

#### Joint responses

The associate headteacher and chair of governors responded on behalf of the governing body to state that the relevant documentation regarding their representations was already with the local authority (at stage 1 consultation) and they had nothing significant to add. A separate letter was later received from the same individuals, on behalf of the governing body, stating that the associate headteacher would be willing to take on a collaborative headship at Out Rawcliffe CE Primary School on a permanent basis and outlining a plan for dealing with the budget deficit at the school.

#### Individual objections

The two individual objections, one from a local resident, and one from a former governor of the school who is also a local resident and former local GP, cited the following reasons against closure:

- The school has played an important role in educating children of the parish successfully since it was founded in 1847;
- It is vital that primary education is provided in the parish close to home within their own supportive community;
- Rural areas need village schools in order to prosper and the school enables children to connect with rural life;
- Up until the last four years the school has had an outstanding record inclusing a succession of glowing OFSTED reports;
- The population of Britain is growing;
- The school building is designed to a very high standard;
- The governing body should be given the professional help they need to resolve the issues at the school that have led to the fall in pupil numbers;
- The community values the school and it is essential for community cohesion.

## **Comments**

The Decision Maker (in this case the Cabinet Member for Children and Schools) took into account the views of respondents during the stage 1 consultation process when making the decision to progress to the next stage in the process (the publication of statutory notices). The Decision Maker is required, at this stage, to take account of statutory objections and comments made during the representation period.

Officers responded to the second letter from the associate headteacher and chair of governors to say that, in order for the Decision Maker to fully consider the outlined

plan and make an informed decision on the statutory proposal, the following was required:

- Written confirmation from the governing bodies of both schools that they are committed to enter into a hard federation;
- An indication of a strategy around the delivery of education to pupils in both schools, given the significant distance between the schools; and
- Information on how a hard federation would address the financial situation it would inherit as a result of the budget deficit at Out Rawcliffe CE.

Correspondence was received by the authority on 6<sup>th</sup> December 2012 from the Chairs of Governors of Out Rawcliffe CE Primary School and Melling St Wilfrid's CE Primary School confirming that the schools had agreed to enter into a soft federation and further information on a strategy for dealing with the budget deficit was provided. This information is provided at Appendix 'B'.

Comments in relation to the points made during and after the representation period are covered in the information in the next section 'Factors that the Decision Maker must take into consideration when determining the proposal'.

All responses received have been placed on a file available in the Members' Retiring Room. All consultation responses are available for public inspection through Lancashire County Council Pupil Places and Access Service (Telephone 01772 531957).

## Factors that the Decision Maker must take into consideration when determining the proposal

Local Authorities are under a duty to deliver excellence and equity in the school system and to create a school system shaped by parents. Central Government expects that weak schools should be closed and that the best schools are able to expand.

The Education and Inspections Act 2006, and Regulations made thereunder, provide that Decision Makers must have regard to guidance issued by the Secretary of State when taking a decision on closure proposals. Department for Education guidance 'Closing a Maintained Mainstream School' provides the following statutory guidance.

## Standards

Decision Makers should be satisfied that proposals for a school closure will contribute to raising local standards of provision and will lead to improved attainment for children and young people.

## Comment

Out Rawcliffe CE Primary School was inspected in January 2012 and was judged to be satisfactory in all areas (achievement of pupils, quality of teaching and leadership and management) apart from one area (behaviour and safety of pupils) which was judged to be good. The school's overall effectiveness rating was satisfactory. A satisfactory judgement means that features are of a reasonable quality and the school is providing adequately for its pupils.

Should the closure proposal be approved, pupils at Out Rawcliffe CE can access available places at neighbouring schools (the section on Provision for Displaced Pupils provides more information). Standards of education at schools neighbouring Out Rawcliffe CE as judged by the most recent Ofsted reports, are either good or outstanding as follows:

#### Provision for Displaced Pupils

The Decision Maker should be satisfied that there is sufficient capacity to accommodate displaced pupils in the area, taking into account the overall supply and likely future demand for places. The quality and popularity of these schools should also be considered.

Pupil numbers on roll (NOR); published admission numbers (PAN); and the physical capacity of Out Rawcliffe CE and neighbouring schools are listed below:

Since the Census return was completed Out Rawclifffe CE has lost one pupil, reducing the total number on roll to 10.

The above information demonstrates that there are enough available places at Great Eccleston Copp CE (one of the closest schools to Out Rawcliffe CE) to admit all of the current pupils at Out Rawcliffe CE if they chose to apply there. However, there are sufficient places available at other schools to provide parents with an element of choice in alternative provision.

The Cabinet report dated 27<sup>th</sup> September 2012 demonstrated that the births in the area associated with children in the current Reception year are higher than for the following two years (the 2013 and 2014 Reception intakes) and the forecast 2015 intake is only slightly higher. In addition, there are currently no known plans for significant amounts of new housing in the area. Even with 10 fewer primary school places per year, there are more than sufficient school places in the area for the foreseeable future.

## **Surplus Places**

The Decision Maker should normally approve proposals to close schools in order to remove surplus places where the school proposed for closure has a quarter or more places, and at least 30 surplus places.

## Comment

There are 60 unfilled places at Out Rawcliffe CE, amounting to 86% surplus places.

## Diversity

The Decision Maker should consider how proposals will impact on local diversity by considering the range of schools in the area and how the closure of the school will impact on the aspirations of parents, help raise local standards and narrow attainment gaps.

## Comment

There are six schools within four miles of Out Rawcliffe CE that offer parents a choice of provision should Out Rawcliffe CE close. There are two community; one Church of England; and two Catholic schools that are maintained by Lancashire County Council and one Academy school. All have higher standards of education than Out Rawcliffe CE, as assessed by Ofsted.

## Balance of Denominational Provision

The Decision Maker should not normally approve the closure of a faith school where the proposal would result in a reduction in the proportion of denominational places in the area. However, this guidance does not apply where the school is severely under-subscribed.

## Comment

Out Rawcliffe CE is severely under-subscribed with an admission number of 10 and one child in each of years Reception and Y1, and 86% surplus places overall. The proposed closure is supported by the Blackburn Church of England Diocese.

## Impact on Community

Where schools are a focal point for family and community activity, providing extended services for a range of users, the Decision Maker should consider the effects of closure on families and the community, including consideration of alternative venues for the delivery of extended services.

## Comment

Prior to and throughout the stage 1 consultation period and the representation period no evidence has been provided as to what extended activities the school actually provides for families or the local community. The school was investigating the establishment of a nursery / forest school during stage 1 consultation but no further information on this possible development has since been provided.

## Travel and Accessibility for all

The Decision Maker should bear in mind that proposals should not have the effect of unreasonably extending journey times or increasing transport costs or result in too many children being prevented from travelling sustainably.

## Comment

Out Rawcliffe CE is located in a sparsely populated area and some of the pupils already receive assistance with school transport. The closest alternative schools, as measured by walking distances are St Mary's Catholic, Great Eccleston at 2.28 miles away and Great Eccleston Copp CE at 2.77 miles distant. Other schools such as Hambleton Academy, Nateby Primary, St Williams Catholic Primary and Stalmine Primary are all within 4 miles of the school and may present reasonable alternatives for some pupils currently at Out Rawcliffe CE but living reasonably close to one of the other schools. The local authority will pay the costs of crossing the Cartford Toll Bridge for children and parents/carers needing to access schools on the other side of the bridge, provided that children are eligible for assistance with school transport.

## **Rural Schools and Sites**

Out Rawcliffe CE is designated as a rural school and there is a presumptions against the closure of rural schools. Any case for closure should be strong and clearly in the best interests of education provision in the area. Evidence must be provided to show that the proposers have carefully considered:

- Alternatives to closure, including federation with another local school to increase the school's viability; or the scope for extended services to provide local community services;
- The transport implications; and
- The overall and long term impact on local people and the community.

## Comment

The transport implications and impact on community have been covered above.

The case for closure is primarily based on the financial viability of the school and its ability to set a balanced budget whilst sustaining sufficient quantity and quality of staff in order to provide a high standard of education for pupils. There is an immediate and urgent issue with the school budget that cannot be addressed through the provision of extended services on the same site, even if suitable services could be found. The school carried forward a deficit of around £29,500 to the 2012/13 financial year, representing around 14% of the Individual School Budget.

The local authority has provided a range of support for Out Rawcliffe CE Primary School over recent years, including financial support for the budget deficit over the last three consecutive years. In the months leading up to the start of stage 1 consultation, local authority officers and officers representing Blackburn Diocese had been in discussion with the governing body over the future of the school. It was the view of the authority and Blackburn Diocese that, unless the school collaborated or federated with another school, the school would be unable to continue in its present form. After considering the feasibility of continuing as at present; collaborating or federating with another school; or consulting on the future of the school, on 22 March 2012 the governing body agreed to pursue the latter option. This is because earlier attempts to secure collaboration with other primary schools had failed. No new offers came to light during the stage 1 consultation process and it is only in the latter stages of the representation period that there was an indication from Out Rawcliffe CE that collaboration with another school may be possible. Confirmation of agreement to a soft federation between Out Rawcliffe CE and Melling St Wilfrid's CE was received from the Chairs of Governors of both schools outside of the representation period and the documentation is attached at Appendix 'B'.

Officers had requested written confirmation from both Out Rawcliffe CE and Melling St Wilfrid's CE governing bodies that they were committed to entering into a hard federation. A hard federation was specifically requested as this requires a statutory process under the School Governance (Federations) (England) Regulations 2012 made under Section 24 of the Education Act 2002 for the establishment of a single governing body for both schools. The process requires consultation with the school community including staff and parents and demonstrates a real commitment to changed governance arrangements to facilitate streamlined decision making across all areas of responsibility including budgetary and staffing decisions.

A soft federation retains the existing governing bodies and a joint committee is established, with representatives from both governing bodies, which makes recommendations to the individual governing bodies on issues such as the budget and staffing. A soft federation is far less robust than a hard federation in terms of decision making around staff appointments and the deployment of staff and budgets. For these reasons, a soft federation does not offer the same level of sustainability for individual schools compared to that offered by a hard federation. A summary of the main differences between types of federations, produced by the National Foundation for Educational Research, is attached at Appendix 'B'.

A number of schools in Lancashire already have soft federation arrangements but the schools concerned are in different circumstances to Out Rawcliffe CE – having larger pupil numbers, more sustainable budgets and being geographically located more closely to their partner school(s).

Whilst the budgetary proposals submitted by Out Rawcliffe CE may be sustainable in the first year of the new formula funding arrangements applying to the Dedicated Schools Grant (DSG) there is no guarantee that this will be the case in future. The amount of lump sum funding per school is only guaranteed for one year by the Department for Education. Any reduction in future years will impact heavily on very small schools with less flexibility in their budget and staffing arrangements.

The submission by Out Rawcliffe CE around a strategy for the delivery of education to pupils in both schools, given the significant distance between the schools (26 miles), did not address concerns around the ability to effectively deal with emergency situations or how, in practice, the school would attract and retain a sufficient calibre of staff to take on the role of assistant head with a full time teaching commitment.

The authority has since received a communication from the Blackburn Diocese stating the Board's position concerning the sustainability of a high standard of education for the school's pupils. The position of the Diocese is that, if the school is to remain open, the only option is a hard federation with another school. A copy of the letter from the Blackburn Diocese is included at Appendix D.

Out Rawcliffe CE Primary School has not provided evidence of providing extended services to the wider community.

## **Every Child Matters**

The Decision Maker should consider how proposals will help every child and young person achieve their full potential: to be safe; enjoy and achieve; make a positive contribution to the community and society; and achieve economic well-being.

## Comment

If the proposal to close the school is approved, children will be able to access places at surrounding schools with higher Ofsted ratings; therefore the potential to enjoy and achieve and, ultimately, to achieve economic well-being is improved. The ability to make a positive contribution to community and society may also be improved, (the implementation of the proposal should not have a detrimental impact on this); and the safety of children should be unaffected as all schools should be a safe environment.

## Equal Opportunity Issues

The Decision Maker should consider whether there are any sex, race or disability discrimination issues that arise from the changes being proposed.

## Comment

A full Equality Analysis is attached at Appendix 'C'. There are no sex, race or disability discrimination issues that arise from the changes being proposed.

## Community Cohesion and Race Equality

The impact on community cohesion should also be considered by the Decision Maker, taking account of the community served by the school and the views of different sections within the community.

## Comment

Out Rawcliffe is a very sparsely populated community and the pupils live some distance away from the school and each other. The closure of the school may impact on friendship groups between pupils and their respective families. However, there is no evidence of a wider impact as the school does not provide a range of extended services for the local community and, therefore the impact of its closure on the community is difficult to measure.

## Views of Interested Parties

The Decision Maker should consider the views of all those affected by the proposals or who have an interest in them.

## Comment

A summary of written representations are included in the report and will be available for viewing in the Members Retiring Room.

#### Consultations

Full details of the consultation process are set out in Appendix 'A'.

## Conclusions

Following a period of support by the local authority to Out Rawcliffe CE and discussion about the future of the school with the governing body and Blackburn Church of England Diocese, the governing body agreed, at a meeting on 22<sup>nd</sup> March 2012, to begin consultation on the future of the school. The local authority, therefore, made a proposal to close Out Rawcliffe CE and consulted upon the proposal. A recommendation is now being made for closure based on the following factors:

- rapidly falling pupil numbers over the past five years, from 50 in 2007/08 to 10 in 2012/13;
- little prospect of pupil numbers improving as more recent birth levels are below those for 2007/08 (children that are in the current Reception year) and minimal potential for new housing in the area;
- the school's budget deficit situation for the last three years, which has worsened and is now at around 14% of the Individual School Budget;

• the significant number of surplus places, requiring a disproportionate amount of the schools budget to be spent on fixed costs such as energy and maintenance, rather than on staffing and educational resources.

In considering the impact of the proposal the following additional factors should be considered:

- displaced pupils will be able to attend other surrounding schools that are of a higher quality, as judged by Ofsted, than Out Rawcliffe CE, thereby increasing the potential for improved educational attainment for those affected; and
- the school has not provided evidence of community activities for the rural community it serves and, therefore, the practical impact of closure on the surrounding community is unlikely to be significant.

The Blackburn Diocesan Board's position is that the only option for the school, if it is to remain open, is a hard federation. Since a hard federation has not been agreed to by either Out Rawcliffe CE or the identified partner school then the recommendation is that the proposals should be determined as published: to discontinue Out Rawcliffe Church of England Primary School on 31<sup>st</sup> August 2013.

## Implications:

This item has the following implications, as indicated:

#### Risk management

The Authority has a statutory duty to secure high quality school places for its residents. A failure to address the falling numbers and consequent concerns around the future educational viability of the school runs the risk of the Authority being seen by DfE and Ofsted to be failing in its statutory responsibilities. Alternative school places can be secured for children affected by the proposed closure at schools with good or outstanding standards of education, as judged by Ofsted.

There are implications for staff employed in the school but the Authority has experience in staff redeployment and retraining and a good record in avoiding compulsory redundancies.

## Financial Implications

The closure of Out Rawcliffe CE Primary School would not have an impact on the Dedicated Schools Grant (DSG). Any saving arising from the closure of Out Rawcliffe CE Primary School, remains within the DSG and can then be allocated to the benefit of pupils attending other Lancashire schools. Out Rawcliffe Primary CE School staff would be at risk of redundancy at 31<sup>st</sup> August 2013 and the cost of the redundancies would fall to the Authority.

## Consultation

The statutory consultation requirements, as prescribed by the Education and Inspections Act 2006 and the School Organisation (Establishment and Discontinuance of Schools) (England) Regulations 2007, as amended, have been complied with.

4. Evidence of the consultation before the proposals were published including:

a) a list of persons and/or parties who were consulted;

b) minutes of all public consultation meetings;

c) the views of the persons consulted; and

d) copies of all consultation documents and a statement of how these were made available.

The authority issued a consultation document on 14 May 2012 and the consultation period ran from that date to 20 July 2012.

The main consultees that consultation documents were sent to included governors, staff, pupils and parents/guardians at Out Rawcliffe Church of England Primary School ; Headteachers and Governing Bodies of other primary and nursery schools within a five mile radius of Out Rawcliffe in the Wyre and Fylde areas; Blackpool Unitary Authority and Wyre and Fylde Borough Councils. A complete list of consultees is included at page 14 of the consultation document, which can be viewed at the link below.

The consultation documents were distributed in hard copy and electronically and were also published on the Internet at

www.lancashire.gov.uk/schoolorganisationreviews

The consultation document forms an integral element of these complete proposals. Copies of the complete proposals can be inspected at Out Rawcliffe Church of England Primary School, the Area Education Office (North) at the White Cross Education Centre, Quarry Road, Lancaster, LA1 3SQ, Lancaster City Hall, Wyre and Fylde Councils and local libraries. Hard copies of the complete proposal documentation will be made available on request and can be obtained from the Directorate for Children and Young People, Provision and Planning Team, PO Box 61, County Hall, Preston, PR1 8RJ. They will also be available on the above website.

As part of the consultations, meetings were held with a range of people including members of the governing body and staff employed at Out Rawcliffe Church of England Primary School. An appointment led event, rather than a public meeting was held between 3.00pm and 8.00pm on Thursday 24 May 2012 at Out Rawcliffe Church of England Primary School. This format of meeting is preferred as it allows the local authority to manage the process effectively, minimise waiting times and ensure that appropriate officers are available to offer any interested parties, either individually or in small groups, advice and guidance to enable them to gain a better understanding on all of the aspects of the proposals.

A school closure consultation was held on June 11<sup>th</sup> 2012 for the pupils of Out Rawcliffe CE Primary School. The whole school, 12 pupils of mixed age and sex, took part in the consultation which was facilitated by a LCC non school employee with a teaching assistant supporting the session. Activities were undertaken to explore how the children felt and enable them to express their opinions. The pupils were unanimous in that they did not want the school to close and they explored the reasons for this during the activities.

The views from the meetings and the 396 written responses to the consultations are detailed and analysed in the report to the Cabinet Member

for Children and Schools that was considered on 27 September 2012 and forms an integral element to these complete proposals. The responses in support of the proposal were from governors and teachers at another school and a parent/guardian of a future pupil of Out Rawcliffe School. The respondents who neither agreed nor disagreed with the proposal were from interested members of the local community. 97% of respondents either disagreed or strongly disagreed with the proposal to close the school. 79% of these responses were from interested members of the local community. Those that responded as 'interested members of the local community' consisted of people living in Out Rawcliffe, Great Eccleston and Little Eccleston in the main, with some respondents from more outlying areas. In addition there was opposition from parents, staff and some individual governors of Out Rawcliffe CE School; the local MP; Parish and Borough Councillors; a school governor and members of staff at other schools; and former staff, parents or pupils of Out Rawcliffe CE School.

All relevant statutory requirements regarding consultation on these proposals were complied with.

## Objectives

5. The objectives of the proposal.

The objective of the proposal is to close Out Rawcliffe Church of England Primary School with effect from 31 August 2013.

## **Standards and Diversity**

6. A statement and supporting evidence indicating how the proposals will impact on the standards, diversity and quality of education in the area.

The county council is committed to improving the quality of educational provision to help raise standards for all learners so that every child has the opportunity to receive an excellent education whatever their background and wherever they live. The authority wants to provide excellence for all children in Lancashire.

Out Rawcliffe Church of England Primary School is a small, voluntary aided rural primary school within the Diocese of Blackburn. Pupil numbers have been falling over the past four years: at January 2008 52 pupils were on roll, which has reduced year by year to 16 pupils at January 2012.

The school was inspected in January 2012 and was judged to be satisfactory in all areas (achievement of pupils, quality of teaching and leadership and management) apart from one area (behaviour and safety of pupils) which was judged to be good. The school's overall effectiveness rating was satisfactory. A satisfactory judgement means that features are of a reasonable quality and the school is providing adequately for its pupils.

In recent months, Local Authority Officers and officers representing Blackburn Diocese have been in discussion with school governors over the future of the school. After considering the feasibility of continuing as at present; collaborating or federating with another school; or consulting on the future of the school, on 22 March 2012 the governors agreed to pursue the latter option.

Schools that experience declining numbers of pupils on roll are adversely affected in budgetary terms making in increasingly difficult to provide a broad and balanced curriculum and there is concern about the future financial viability of the school.

The diversity of school provision is illustrated in the table showing the availability of places at primary schools in the Out Rawcliffe area on page 8 of the consultation document. There is one community school, one Church of England school, one Catholic schools and an Academy school within 4 miles of Out Rawcliffe Church of England Primary School.

The standards of education offered by neighbouring schools, as judged by the most recent Ofsted reports are as follows: Great Eccleston Copp CE and St Mary's Catholic– Good; and Nateby Primary and Hambleton Primary Academy – outstanding.

## **Need for places**

8. A statement and supporting evidence about the need for places in the area including whether there is sufficient capacity to accommodate displaced pupils.

There are sufficient places in all of the year groups at neighbouring schools to admit pupils from Out Rawcliffe CE. Great Eccleston Copp is a voluntary aided Church of England school and places are currently available in each of its year groups for any children that wish to continue with a Church of England education.

The Pupil Numbers and Forecasts section in the consultation document on pages 6 to 8 details the availability of places at other schools as at January 2012, including a table showing the numbers on roll in each year group in the two closest schools to Out Rawcliffe Church of England Primary School.

The birth rate in the area is steady and there are currently no plans for a significant amount of new housing. No external factors have been identified that would cause the school's roll to increase in the short to medium term.

9. Where the school has a religious character, a statement about the impact of the proposed closure on the balance of denominational provision in the area and the impact on parental choice.

There are sufficient places in all of the year groups at neighbouring schools to admit pupils from Out Rawcliffe CE. Great Eccleston Copp is a voluntary aided Church of England school and places are currently available in each of its year groups for any children that wish to continue with a Church of England education.

If Out Rawcliffe CE closes, parents will be assisted to find a place for their child in another local school and they will be able to express a preference for their preferred alternative school.

The standards of education offered by neighbouring schools, as judged by the most recent Ofsted reports are as follows: Great Eccleston Copp CE and St Mary's Catholic – Good; and Nateby Primary and Hambleton Primary Academy – outstanding.

In recent months, Local Authority Officers and officers representing Blackburn Diocese have been in discussion with school governors over the future of the school. After considering the feasibility of continuing as at present; collaborating or federating with another school; or consulting on the future of the school, on 22 March 2012 the governors agreed to pursue the latter option.

## **Current School Information**

10. Information as to the numbers, age range, sex and special educational needs of pupils (distinguishing between boarding and day pupils) for whom provision is made at the school.

Out Rawcliffe Church of England Primary School is a co-educational day primary school providing for pupils of all abilities. At the January 2012 termly school census there were 7 male and 9 female pupils aged between 3 and 11 on roll.

Out Rawcliffe Church of England Primary School does not have a designated special educational needs facility or reserved places for pupils with special educational needs. The school does provide for pupils with

statements of special educational needs.

## **Displaced Pupils**

11. Details of the schools or FE colleges which pupils at the school for whom provision is to be discontinued will be offered places, including:

a) any interim arrangements;

b) where the school included provision that is recognised by the LA as reserved for children with special educational needs, the alternative provision to be made for pupils in the school's reserved provision; and

c) in the case of special schools, alternative provision made by LAs other than the authority which maintains the school.

No interim arrangements are proposed.

Out Rawcliffe CE is located in a sparsely populated area and some of the pupils already receive assistance with school transport. The closest alternative schools are St Mary's Catholic, Great Eccleston at 2.28 miles away and Great Eccleston Copp CE 2.77 miles away; Hambleton Academy and Nateby Primary are within 4 miles. Some Out Rawcliffe pupils live closer to alternative schools than they do to Out Rawcliffe CE.

There are sufficient places at neighbouring schools to admit pupils from Out Rawcliffe CE. Great Eccleston Copp is a voluntary aided Church of England school and places are currently available in each of its year groups for any children that wish to continue with a Church of England education.

If Out Rawcliffe CE closes, parents will be assisted to find a place for their child in another local school and they will be able to express a preference for their preferred alternative school.

The local authority does not have provision that is reserved for pupils with special educational needs at Out Rawcliffe Church of England Primary School. Future special educational needs provision will be reviewed in consultation with pupils, parents and possible alternative schools.

12. Details of any other measures proposed to be taken to increase the number of school or FE college places available in consequence of the proposed discontinuance.

The Need for Places section above confirms that there are sufficient places at neighbouring schools to admit pupils from Out Rawcliffe CE.

## Impact on the Community

13. A statement and supporting evidence about the impact on the community and any measures proposed to mitigate any adverse impact.

Out Rawcliffe CE is located in a sparsely populated area and some of the pupils already receive assistance with school transport. The closest alternative schools are St Mary's Catholic, Great Eccleston at 2.28 miles away and Great Eccleston Copp CE 2.77 miles away; and Hambleton Academy, and Nateby Primary are within 4 miles. Some Out Rawcliffe pupils live closer to alternative schools than they do to Out Rawcliffe CE. Given the pattern of alternative school places, and dependent on choices made by parents, it is possible for pupils to attend schools close to their existing communities.

Pupils and families could continue to access community services and facilities near to their homes.

The school site is not owned by the local authority and is subject to a reverter clause requiring it to revert to the trustees (or their descendents) should it no longer be used for a school providing for statutory school age children.

14. Details of extended services the school offered and what it is proposed for these services once the school has discontinued.

Whilst, during the consultation exercise, a number of respondents stated that the school has been / is the focal point for the community, no evidence has been provided as to what activities the school actually provides for the local community.

Since the stage 1 consultation process, the school has been arranging a 'Forest School' which runs in the wood on the school site. This is outdoor based teaching and can run as required from early morning until parents finish work in the evening. The service could also be offered during the school holidays as and when required.

## Travel

15. Details of the length and journeys to alternative provision.

The authority's aim is that primary aged pupils' journeys should not take more than three quarters of an hour and ideally should be within a two mile radius of the school they attend. However, Out Rawcliffe Church of England Primary School is located in a sparsely populated area with some of the pupils already receiving assistance with school transport.

The closest alternative schools measured by walking distance are: St Mary's Catholic, Great Eccleston (2.28 miles away) and Great Eccleston Copp CE (2.77 miles away). Hambleton Academy and Nateby Primary are within 4 miles. Some Out Rawcliffe pupils live closer to alternative schools than they do to Out Rawcliffe CE.

16. The proposed arrangements for travel of displaced pupils to other schools including how they will help to work against increased car use.

A number of pupils attending Out Rawcliffe CE currently receive assistance with home to school transport. It is not possible to estimate whether this proposal will lead to an increased use of transport as it depends on the alternative provision chosen by parents.

It is the policy of the authority to provide assistance with home to school transport for pupils under eight years of age if the school that the pupil attends is the nearest suitable school and it is two miles or more from the pupil's home. The qualifying distance extends to three miles for pupils of eight years of age and over.

For pupils on free school meals or parents receiving the maximum amount of working tax credit (low income families) the qualifying distance remains at two miles when the child reaches eight years of age.

For pupils that do qualify for home to school transport the local authority will assess the most cost effective and reasonable way to do this. Due to the rurality of the area, this may involve the use of taxis.

In the opinion of the local authority, the proposal is not related to other proposals which have been, are, or are about to be, published.

## **Rural Primary Schools**

Out Rawcliffe Church of England Primary is a small, voluntary aided rural primary school within the Diocese of Blackburn. Pupil numbers have been falling over the past four years: at January 2008 52 pupils were on roll, which has reduced year by year to 16 pupils at January 2012. Births in the area are steady and there are currently no plans for significant amounts of new housing, therefore there no external pressures have been identified that would cause the school's roll to increase in the short to medium term. The admission number of the school is 10, the physical capacity is 70 and surplus places currently stand at 77%. Due to the high number of surplus places at the school the LA is required to explain reasons for the surplus and any action it intends to take to the Department for Education on an annual basis.

Given the pattern of alternative school places, and dependent on choices made by parents, it is possible for pupils to attend schools close to their existing communities. During the consultation exercise, no evidence was provided of community activities held at Out Rawcliffe CE and pupils and families could continue to access community services and facilities near to their homes.

The authority's aim is that primary aged pupils' journeys should not take more than three quarters of an hour and ideally should be no more than two miles. Out Rawcliffe Church of England Primary School is located in a sparsely populated area with some of the pupils already receiving assistance with school transport. The closest alternative schools measured by walking distance are: St Mary's Catholic, Great Eccleston (2.28 miles away) and Great Eccleston Copp CE (2.77 miles away). Hambleton Academy and Nateby Primary are within 4 miles. Some Out Rawcliffe pupils live closer to alternative schools than they do to Out Rawcliffe CE and it is not possible to say whether the proposal will lead to an increased use of transport as it depends on parental preferences for alternative provision. However, as the number of pupils is small, any increases travel costs to the LA will be small and more than offset by the amount of funding that has been provided to the school over the past three years in order for it to balance the budget.

Since the 2010/11 financial year, Out Rawcliffe CE has carried forward a deficit budget. The deficit has increased year on year and the school carried forward a deficit of around £29,500 to the 2012/13 financial year, representing around 14% of the Individual School Budget. The only sustainable option for Out Rawcliffe CE is for the school to have a part-time headteacher, or one shared with another school on a permanent basis. Even then, the budget would be extremely tight, leaving very little flexibility to make alternative arrangements for staff cover and other unplanned for events. The local authority has endeavoured to find a primary school that would agree to collaborate or federate with Out Rawcliffe CE and thus make

financial savings through the sharing of senior staff. This has not proved possible. Given this situation, on 22 March 2012, the governing body agreed to a consultation exercise on the closure of the school.

## **Maintained nursery schools**

19. Where proposals relate to the discontinuance of a maintained nursery school, a statement setting out:

a) the consideration that has been given to developing the school into a children's centre and the grounds for not doing so;

b) the LA's assessment of the quality and quantity of alternative provision compared to the school proposed to be discontinued and the proposed arrangements to ensure the expertise and specialism continues to be available; and

c) the accessibility and convenience of replacement provision for local parents.

## Special educational provision

20. Out Rawcliffe Church of England Primary School does not have a designated special educational needs facility or reserved places for pupils with special educational needs (SEN). However, it provides support for pupils with SEN, including those with statements.

When discontinuation proposals are proposed it is important to review the needs of pupils with statements and, following consultations with them and their parents, to name for certain pupils the alternative school where provision would be made for them. Where pupils have special educational needs but are not statemented, action is taken to enable continuity of support to be provided. Out Rawcliffe Church of England Primary School does not currently have any statemented pupil on roll.

Notice is given in accordance with section 15(1) of the Education and Inspections Act 2006 that Lancashire County Council, PO Box 61, County Hall, Preston, PR1 8RJ intends to discontinue Out Rawcliffe Church of England Primary School, Crook Gate Lane, Out Rawcliffe, Preston, PR3 6BH on 31 August 2013.

All relevant statutory requirements regarding consultation on this proposal have been complied with.

There are currently sufficient places available for all displaced pupils to be offered places in schools in all of the year groups at neighbouring schools, one of these schools being a voluntary aided Church of England school for any children that wish to continue with a Church of England education. If Out Rawcliffe CE Primary School closes, Lancashire County Council will work with parents to identify preferred alternative school provision.

The proposed transport arrangements for displaced pupils that were eligible would be made in accordance with the authority's current transport policy.

The local authority's opinion is that this proposal is not related to any other proposals that have been, are, or are about to be published. This Notice is an extract from the complete proposal. ## Consultation on the Proposed Closure of Out Rawcliffe Church of England Primary School

Thank you for your letter, dated 23rd November 2012, requesting additional information on our plan to secure the future of the school.

Firstly this letter confirms that Out Rawcliffe CEPS Governors are committed to enter into a soft federation with Melling (St Wilfrid) CEPS through the sharing of a collaborative Headteacher - Mrs Geraldine Andrews. A second letter is enclosed from the Governing body of Melling (St Wilfrid) CEPS confirming their commitment to enter into a <u>soft</u> federation with Out Rawcliffe CEPS. Since September, both schools have already benefited from our collaboration, with Out Rawcliffe children visiting Melling and then both schools coming together for a Victorian themed educational visit. Entering into a permanent <u>soft</u> federation will strengthen both of our schools.

An indication of a strategy around the delivery of education to pupils in both schools, given the distance between the schools, is attached. The actual distance between our schools is not significant in the proposed arrangements, especially since the majority of the journey is on A-roads and motorway, a journey of approximately 40 minutes. Experience has shown that schools do not have to be close to have a successful effective collaboration, for example Winmarleigh Primary School and Bleasdale *C* of E Primary School which are separated by 10 miles of very rural roads, a 30 minute journey in summer but a much longer and sometimes very difficult journey in winter. On our recent visit to Melling School the conversations on the outward journey prepared the children for the day ahead and on the return journey cemented what had been learnt. The enthusiasm with which the children talked about their shared day was in contrast to conversations following past visits to other larger schools and this confirmed to us the compatibility of our two schools.

Finally information is attached which clearly indicates how our proposals would address the financial situation resulting from the budget deficit at Out Rawcliffe CE School, putting the budget back into positive figures. The financial plan also addresses aspects for improving the quality of teaching and therefore pupil learning. Looking to the future, once our recovery plan has been implemented and our financial situation secured, our proposed nursery unit, which has encouraged an increased interest from within the area, should help create a larger influx of pupils which in turn will allow us to expand our teacher ratio.

We hope that you will look favourably on our plans.

Financial situation:

The proposed budget for Out Rawcliffe looks to provide:

- 0.5 time of a headteacher
- A full time classroom based teacher

(Assistant head paid on the leader ship scale). This would ensure someone who has the necessary expertise and experience to work in this demanding role. They would be responsible for planning and delivering whole school schemes of work through a creative curriculum.

- A full time TA3 who has experience and knowledge of EYFS. They would become key worker for YrR children, and deliver some of the EYFS.
- A part time (every morning) TA2 to support children to access the creative curriculum which would be implemented.

The vision is to work very much whole school, as opposed to two separate classes which is what is happening now.

- Full time bursar role would remain
- 20 hours a week site supervisor role.

If these changes were implemented it would cost  $\pounds 26,404$  less than the current staff and would put the budget of Out Rawcliffe back into positive figures, thus solving the deficit budget problems. As numbers increase the school would look to provide additional hours of teaching through the recruitment of a part -time NQT.

#### A strategy around the delivery of education to pupils in both schools

Melling (St Wilfrid) CEPS is 26 miles from Out Rawcliffe CEPS. However Mrs Andrews lives in Lancaster which is between the two schools. Lancaster to Melling is 11.5 miles, whilst Lancaster to Out Rawcliffe is only 16 miles.

Melling School has a well established, experienced staff who are more than capable of providing a good quality of education on a day-to-day basis.

The re-structuring suggested at Out Rawcliffe would provide a similar level of expertise in delivering a high quality curriculum to the whole school.

The collaborative headteacher role of Mrs Andrews would provide a top layer of strategic leadership to both schools. Since September this has worked successfully with Mrs Andrews splitting her time between the schools on a week-by-week programme depending on need at each school. A full time bursar at Out Rawcliffe means that Mrs Andrews can always be contacted by phone or e-mail to answer any queries.

There are also occasions when both schools have been visited on the same day when the need arises. Not being classroom based releases Mrs Andrews to work in a leadership role very effectively, in order to move the schools forward and improve the achievement of all pupils.

#### What is the Purpose of the Equality Decision-Making Analysis?

The Analysis is designed to be used where a decision is being made at Cabinet Member or Overview and Scrutiny level or if a decision is being made primarily for budget reasons. The Analysis should be referred to on the decision making template (e.g. E6 form).

The Proposed Closure of Out Rawcliffe Church of England Primary School

#### What in summary is the proposal being considered?

Cabinet Member for Children and Schools is the Decision Maker in respect of a proposal made by Lancashire County Council to close Out Rawcliffe CE Primary School with effect from 31 August 2013. The proposal has been brought under procedures established by The Education and Inspections Act 2006 and The School Organisation (Establishment and Discontinuance of Schools)(England) Regulations 2007 which require full consultation prior to taking a final decision. Following consultation with the school's governing body and Blackburn Diocese, the proposal to close the school was made due to concerns about the future educational and financial viability of the school.

Is the decision likely to affect people across the county in a similar way or are specific areas likely to be affected – e.g. are a set number of branches/sites to be affected? If so you will need to consider whether there are equality related issues associated with the locations selected – e.g. greater percentage of BME residents in a particular area where a closure is proposed as opposed to an area where a facility is remaining open.

The proposal, if approved, will directly affect the ten children currently on roll and their families who will need to secure places at alternative education provision. Lancashire County Council and Blackburn Diocese will assist in this process and Lancashire County Council will provide assistance with transport to alternative provision for any children that are eligible under the authority's current transport policy.

The proposal, if approved, could also impact on those who may wish their children to attend Out Rawcliffe CE Primary School in the future in addition to any impact on the residents of the small rural community of Out Rawcliffe.

# Could the decision have a particular impact on any group of individuals sharing protected characteristics under the Equality Act 2010, namely:

- Age
- Disability including Deaf people
- Gender reassignment
- Pregnancy and maternity
- Race/ethnicity/nationality
- Religion or belief

The school provides for mixed gender pupils aged 5 to 11. The Ofsted Inspection Report dated 12<sup>th</sup> January 2012 stated that the school provides for pupils predominantly of White British heritage, with a very low proportion speaking English as a second language. There is a relatively high proportion of children on roll with special educational needs.

Full consultation has taken place in accordance with DfE guidance "Closing a Maintained Mainstream School, a Guide for Local Authorities and Governing Bodies' which included consultation with children during stage 1 of the process.

The result of the stage 1 consultation was reported to Cabinet Member for Children and Schools on 27 September 2012 and the result of the consultation at representation stage is included in the report to Cabinet Member for Children and Schools dated 11<sup>th</sup> January 2013.

#### **Question 3 – Analysing Impact**

It is particularly important in considering this question to get to grips with the actual practical impact on those affected. Whilst the proportion of children with special educational needs was reported as well above average by Ofsted this was based on an overall number on roll of 16 pupils at the time and does not, therefore, represent significant numbers of pupils. Any funding supporting pupils will transfer to the receiving school and parents/ carers will be able to express a preference for alternative provision which accords with their child's needs.

Parents of children displaced by the closure, if approved, will be able to express a preference for alternative schools. The neighbouring schools all have higher educational standards, as assessed by Ofsted, than Out Rawcliffe CE, which will facilitate improved educational attainment for current and future pupils. Should pupils want a place at an alternative Church of England primary school there are places available at a neighbouring Church of England primary school for all the pupils affected by the proposal. Being located in a rural community, some of the pupils on roll at Out Rawcliffe CE already have assistance with school transport from the local authority and all pupils will be assessed for eligibility with transport assistance if the closure proposal is approved, and once they have been allocated a place at an alternative school.

#### **Question 4 – Combined/Cumulative Effect**

Further to the various discussions with you and your colleagues regarding the future of Out Rawcliffe Church of England Primary School following the consultation and statutory notice process together with the letter received from Mr P Jones the Chair of Governors of the school. The Board's position surrounding the education of the pupils to a high standard and to ensure that this is sustainable in the long term, believe that the only option if the school is to continue to remain open is that of a hard federation. To ensure that the practical workings of a hard federation are deliverable the Board would require the following:

- A written confirmation from both school's governing bodies that they are committed to a hard federation and that proof of this will be required both by a letter signed by the respective chairs' of the governing body and a copy of the minutes of both bodies stating the resolution that was approved.
- An indication of a strategy around delivery of education to pupils in both schools, given the significant distance between them.
- Information on how a hard federation would address the financial situation it would inherit as a result of the budget deficit at Out Rawcliffe.
