1. Apologies

Apologies for absence were presented on behalf of County Councillors Geoff Driver, Yousuf Motala and George Wilkins and Councillors Anis Faruki and Biku Patel.

2. Note of the meeting held 2 December 2014

The note of the meeting held on 2 December 2014 was presented and agreed.

An update was requested regarding any action taken in connection with street furniture and A boards on Fishergate Central Gateway. It was reported that Preston City Council's Overview and Scrutiny Committee had established a task group to investigate the issues and the Chair of the task group was to meet with officers within the next two weeks to progress this.

3. Action sheet update from last meeting

Members received an update on the action taken in response to issues raised at the previous meeting. In receiving the update Members made the following comments:

Fishergate Railway Bridge – It was reported that there might be an opportunity for Network Rail to bring forward the timescale for painting the bridge. It was hoped that Preston City Council would match funding provided by the County Council.

It was noted that the amount of graffiti on the bridge was increasing and it was suggested that a letter be sent to Network Rail asking them to address this.

Cycling within Preston – Members wished to express their increasing concern about the lack of progress in negotiations with Network Rail regarding Vicars Bridge; it was an important part of the cycle route into Preston from South Ribble and the delay was most unsatisfactory.

Fishergate Central Gateway – an update on phase 2 of this project had been provided to county councillors by the County Council's media team. Officers would ensure that the update was also provided to other members of this Forum.

4. 2014/15 Quarter 3 Environment Directorate Performance Dashboard

The Environment Directorate's "dashboard" performance for the third quarter of 2014/15 was presented.

In noting the dashboard the following point was made:

Preston Bus Station – regarding the international design competition referred to in the item, it was reported that 8000 youngsters had so far visited the website from 80 different countries with 125 firm registrations so far.

5. Environment Directorate Capital Programme 2015/16 - Road and Footway Schemes

The Environment Directorate Capital Programme 2015/16, which listed A, B and C roads and footway schemes for consideration in Preston was noted.

6. Environment Directorate Capital Programme 2015/16 to 2017/18

The Forum received a report on the Environment Directorate's New Starts Programme 2015/16 to 2017/18.

The Localities Officer undertook to confirm whether the £1m allocated to street lighting was to be used entirely for LED lights.

7. City Deal Update

Marcus Hudson, Head of Planning at the County Council, attended to provide members with an update on the City Deal project.

There was some discussion about the use of in-house workforce and local labour generally. The Forum was assured that, wherever possible, work would be carried out using in-house resources, but this might not always be possible. It was important to find the right balance between cost and quality.

Clarification was sought on whether Bluebell Way/LCC Car Park fell into City Deal.

8. Child Sexual Exploitation/DETER Programme

Ged Docherty, Senior Social Worker, Child Protection attended to advise the Forum about work ongoing to protect children and young people from Child Sexual Exploitation (CSE). He read out the Association of Chief Police Officer's definition of CSE and outlined specialist work ongoing to triage referrals and raise awareness to prevent CSE.

He explained that, for many reasons, CSE is a very complex and contentious issue. The use of social media was creating a network of potential victims and it was difficult to ensure that young people understood the risks. It was important to work creatively and sensitively with partners, without putting young people at further risk.

Members asked that they be provided with the contact points to which concerns should referred and Ged undertook to provide this via the Localities Officer.

9. Transportation of shale gas vehicles through the North of Preston

The Forum received an information note briefly setting out the position regarding the proposed route of shale gas vehicles through the North of Preston.

There was some concern about the tone of the note and the lack of firm information. It was, however, pointed out that the note was just for information and that members would have an opportunity to respond to proposals at the formal consultation stage. Assurance was sought that parish councillors would be among the formal consultees.

10. Lancashire Time Credits

A note was circulated setting out information about a programme between the County Council and Spice Innovations to be rolled out across Lancashire over the next three years and beyond. A copy of the note is attached.

11. Themes for Future Meetings

Members of the Forum were invited to suggest items for the next Preston 3 Tier Forum. Any suggestions would need to be cleared with the Chair.
