1. Apologies

Apologies for absence were presented on behalf of County Councillor Geoff Driver and Councillors Phil Crowe, David Hammond, Brian Rollo and David Walker.

2. Note of the meeting held 8 September 2014

The note of the meeting held on 8 September 2014 was presented and agreed.

3. Action sheet update from last meeting

Members received an update on the action taken in response to issues raised at the previous meeting. In receiving the update Members made the following comments:

Guild Wheel Maintenance – Members wished to congratulate officers on the speed at which they responded to maintenance issues. It was acknowledged that issues were to be

reported via the Customer Contact Centre, though there was a preference for a dedicated number.

Fishergate Railway Bridge – Network Rail were commended for their fast response to graffiti on the bridge. A request was made for the outside of the bridge, which was unsightly, to now be painted. It was suggested that local artists would welcome an opportunity to showcase their work on the bridge.

School Performance Information – An interim report, based on provisional data, was circulated to members who were invited to raise any questions or concerns in the first instance via Mark Wardale.

Parades – It was reported that the County Council's Learning and Development Team was liaising with a training provider to deliver appropriate training by April 2015. It was confirmed that Parishes had received a copy of the Policy document.

Tramway – It was confirmed that regular updates relating to transport would be provided via the action sheet and/or Dashboard.

4. 2014/15 Quarter 2 Environment Directorate Performance Dashboard

The Environment Directorate's "dashboard" performance for the second quarter of 2014/15 was presented.

In noting the dashboard members made the following points:

St Mark's Place – It was confirmed that work on the carriageway had now been completed and the local member wished to place on record his appreciation for a job well done.

Cycling within Preston – There was some discussion about how best to encourage safe cycling. It was acknowledged that the Guild Wheel had generated an upsurge in the amount of cycling in the area, however, there appeared to also be an increase in cyclists using footpaths and causing a hazard to pedestrians

There was anecdotal evidence that new signage had improved the attitude of cyclists toward pedestrians on the stretch of Guild Wheel around Broadgate and The Boulevard, where there had previously been similar concerns.

It was felt that there needed to be proper access to distinct cycle lanes separate from roads.

There was some frustration that no progress had been made in providing access from Avenham Park via the Preston Railway Station Cycle Link despite previous assurances that it would be completed. It was considered important to move forward and have a timescale for completion. Mark Wardale undertook to pursue this.

Regarding the Guild Wheel, it was understood that the original plan had included 'spokes' from the circuit to provide cycle access into the city – confirmation and further detail was sought. Mark Wardale undertook to look into this.

It was suggested that cycle storage provision was generally poor and that many dedicated cycleways were not maintained to the high standard of the Guild Wheel, which discouraged cyclists from using them.

It was suggested that more should be done to publicise all the activity and initiatives being undertaken to promote cycling in Preston.

Fishergate Central Gateway – It was reported that the bollards at the junction of Fishergate and Corporation Street were to be illuminated.

The improvement works were welcomed and it was felt important not to spoil the spacious look of Fishergate by installing too much street furniture. The use of A boards by some businesses was problematic and it was confirmed that the Public Realm manager was working with local businesses to discourage their use. It was reported that Preston City Council's Scrutiny Committee was currently investigating this issue. It was agreed that clear advice was required setting out the rules regarding A boards and the enforcement rights of the local authority.

City Deal Phase Two - There was a request for members to see detailed plans with an outline schedule of works. Mark Wardale undertook to provide these.

Road and Street Maintenance – One member reported a significant rut in Lancaster Road outside the Town Hall (by the second bus stop No. 23) and asked that it be examined as soon as possible.

Trading Standards – There was some concern about the number of vehicles parked on the road side and advertised for sale. Mark Wardale agreed to check whether such practice was legal.

5. Capital Programme 2015/16 - Update

The Environment Directorate Capital Programme 2015/16, which listed A, B and C roads and footway schemes for consideration in Preston was noted.

6. Cycling Routes in Preston for work rather than leisure

This item had been discussed under Item 4

7. Traffic Counts/Congestion in Preston

A briefing note on highway congestion in Preston had been provided. It was reported that traffic was now flowing freely through the city centre.

Regarding Deepdale Retail Park, previous problems appeared to now be resolved and traffic was moving well along Blackpool Road. There was, however, concern about the congestion that had been experienced whilst the works were ongoing, particularly delays caused to people trying to get to the Crematorium to attend funerals. It was suggested that work should have been carried out overnight and also that there should have been more signage warning about delays and directing motorists to alternative routes. There was also

concern about congestion that had occurred on the Ringway delaying public transport and also emergency vehicles.

It was noted that Paragraph 32 of the NPPF (National Planning and Policy Framework) states that 'Development should only be prevented or refused on transport grounds where the residual cumulative impacts of development are severe.' More detail was requested about current and future congestion in light of the Preston and South Ribble City Deal and also for clarification what 'severe' means in this context.

Clarification was sought about access for goods vehicles at certain times throughout the City as some Towns and Cities already restrict access to goods vehicles in order to reduce congestion at key times. Mark Wardale undertook to find out and inform the Forum.

Investment in road schemes was welcomed and it was acknowledged that delays were inevitable during periods of work, however, it was emphasised as also important to consider very carefully how such activity was managed.

8. Themes for Future Meetings

Members of the Forum were invited to submit any suggested items for the next Preston 3 Tier Forum to Mark Wardale <u>mark.wardale@lancashire.gov.uk</u>. Any suggestions would need to be cleared with the Chair.

It was suggested that the Forum be provided with an update on the City Deal from the City Deal Delivery Group.

9. Urgent Business

Construction Traffic

The Chair invited Parish Councillor Eileen Murray to raise a matter which was of concern to Parishes.

She reported that there had already been a noticeable increase in construction traffic as work on the implementation of the City Deal had begun and she asked what measures were to be taken to minimise the effect on residents. She noted that the required 'Approved Construction Method Statement' was not yet in place, yet work had already begun. She suggested that the Construction Method Statement be made public; local residents could then be relied on to report breaches.

Councillor Murray was advised to raise these concerns with Preston City Council's Planning Department.

It was suggested that the Forum be provided with an update on this issue from the City Deal Delivery Group.

Mark Wardale also agreed to follow this up with LCC colleagues.

10. Date of Next Forum

It was noted that the next meeting of the Forum would be held at 6.00pm on Monday 9 March 2015 in the Duke of Lancaster Room, County Hall, Preston.

Preston Bus Station

Since taking ownership of the building on 31 March 14, a full structural condition survey has been carried out on the building by Jacobs who subsequently produced a report highlighting their recommendations as to what remedial works were required to address those issues found during the survey. Consideration has also been given to the other aspects of the overall redevelopment project including; the refurbishment of the bus station concourse, the required highways alteration works, the construction of a new youth zone, and the associated new public realm space which will facilitate improved connectivity to the wider city centre. This work resulted in an order of magnitude of costs schedule being prepared which formed part of the progress report submitted to the County Council's Cabinet in November 14. Since that cabinet meeting the Royal Institute of British Architects have been appointed to administer an international design competition on behalf of the county council and a competition website has been produced, which includes the brief and contract conditions for the competition, which will go live week commencing 23 February 15, upon the launch of the competition. The first draft of the conservation management plan, including the statement of significance, has been prepared and this has been shared with Preston City Council's heritage officer and English Heritage for initial comment, prior to a critical friend being appointed to review and validate the document. Two of the county council's partner contractors are currently carrying out an exercise to consider those figures put forward in the order of magnitude of costs schedule. This exercise will include testing the figures against current market conditions and will be completed by 27 February 15.

Preston Western Distributor

Work continues on the ground in the form of ecological surveys. The Public Consultation Report has been completed and the Cabinet Member for Highways and Transport has adopted the route as the approved route. The delivery team is now working towards submitting a planning application in autumn 2015.

Environment and Community Projects

Callon all- weather pitches - dual use agreement

Work was completed in December 2014 to refurbish the AstroTurf pitch on the site of Fishwick and St Teresa's primary schools in Preston. The refurbishment cost approximately £15,000 with £12,000 from LCC and additional contributions from the two schools.

The funding was conditional on all parties signing up to a dual use agreement of the facility which will secure the future community management and use of it. LCC led the negotiations to develop and secure the agreement with support from LCC legal services. The team will support a new facility user group in the coming months and assist with the official opening and re-launch of the facility in spring 2015.

Broughton Bypass

A public inquiry has now been set for 14th April 2015 at Preston Grasshoppers Rugby Club. The outline business case is progressing, however the value for money statement is still to be finalised. This is expected during quarter 4 2014/15, with indications of a very positive benefit cost ratio.

Programme delivery remains unchanged but this is dependent on when the final Compulsory Purchase Order decision is received. Contract documents are however being finalised in readiness for the tender process.

Traffic Signals

Bridges

New Mill on Eaves Lane (Preston Rural) - due to extensive difficulties with Electricity North West, this project has been delayed. We have now been able to remove the temporary electricity diversion apparatus which has allowed access to finish the renovation of the gabion baskets (large cage with rocks used for erosion control) that were concealed by the electricity diversion scaffolding. These works can only be carried out during favourable weather conditions therefore it is anticipated to complete these works during quarter 4 2014/15.

Between April and November 2014/15, a total of 3,836 highway defects were identified by regular Highway Safety Inspections (HSI) or reported by the public in Preston. 3,802 (99%) of these defects were repaired within 20 working days between April to November.

Trading Standards

Allergen Training

A training course for businesses where English isn't the first language has been developed in partnership with the District Environmental Health Service for catering businesses who will be affected by the changes in food labelling legislation relating to allergens (substance that causes an allergic reaction). The course will provide these businesses with everything they need to be able to meet the requirements of the legislation. Information has also been sent to all catering and manufacturing businesses across the Lancashire to help them

Preparations are ongoing to commence Phase 2 from Winckley Street to the Minster on 16th February. The first areas to be worked on will be Fishergate between Cheapside and Cannon Street and in Guildhall Street. b

There have been 193 LED Street Lighting Lanterns fitted in Preston over the la 12 months. These lanterns provide an additional saving of £5,000 in energy per annum. There are now 1167 LED lighting units out of a total of 19,987 lighting units in Preston saving over £30,000 in energy per annum. 4

The current position for the 2015/16 capital programme

The Environment Directorate is currently preparing its capital programme for 2015/16 and we have now been notified of the final settlements from central government. The proposed maintenance allocations were approved by Full Council on the 12 February 15. Officers are currently finalising the scheme lists for each of the 2015/16 maintenance programmes. The maintenance of assets and road safety programmes are scheduled to be approved by County Councillor Fillis in March 2015.

Members will recall that the county council has adopted a Transport Asset Management Plan (TAMP), which sets out priorities for funding over a 15 year period.

The directorate presented a draft programme of work to the last 3 Tier Forum in line with the principles set out in the TAMP for ABC's and Footways. The ABC list has been further developed and more accurate estimates have been established for the carriageway and inlay schemes. The ABC and footways scheme lists are overleaf for your information.

2015/16 A, B and C Road Programme

The draft countywide ABC programme is listed on pages 3-8. The schemes planned for delivery in your district next year are highlighted in grey. A summary of the schemes being proposed for funding in your district is provided on page 9.

The TAMP promotes a preventative approach to maintenance and recommends the use of surface dressing to prolong the life of the asset. Many of the ABC schemes in the draft programme have been identified for surface dressing in 2015/16. These roads have been pre patched in 2014/15 in preparation for surface dressing, and will be inspected shortly before the start of the surface dressing programme to ensure the sites remain suitable for the treatment. In addition the programme includes a number of sites which require more significant and costly treatments, such as resurfacing, due to deterioration of the road surface beyond a condition which will allow surface dressing. These schemes will be addressing the parts of the network in the poorest condition.

2015/16 Footway Schemes

The footways programme on page 10 comprises those sites which are considered a priority for treatment in your district in 2015/16. They form the second year of a three year programme intended to significantly reduce the numbers of safety defects in the footway network. Further condition information relating to the footway network is continuing to be gathered by video survey, and this information will form the basis of future programmes.

The proposed footway programme has been developed on a district by district basis, by assigning a condition rating for the road, using a 1 - 6 condition rating framework. Local technical engineers have then used their local knowledge and experience to determine the priority of those classed as 6 (poorest condition requiring extensive major work). Other considerations include the number of reported defects, the number of enquiries complaints received, and input from Members.

Child Sexual Exploitation (CSE) in Lancashire

Introduction

Child Sexual Exploitation is a key concern to all those who are involved with keeping children and young people safe and ensuring their safeguarding. No Local Authority or Service can be complacent around this issue and in Lancashire we have worked in partnership to address CSE issues. Indeed it is only through effective partnership working that this issue can be tackled

Working Partnerships

In Lancashire across the new 3 policing divisions we continue to lead the way nationally in terms of the approach we have taken to tackling these issues. Three multi agency CSE teams have been created (one for each police division), which include police, health, children social care and voluntary agencies work to the following ethos.

- Risk management according to a common framework.
- A shared picture of intelligence of the threats.
- Graded responses to the risks identified to safeguard and support victims.
- Early intervention to reduce harm.
- Investigation, prosecution and disruption of perpetrators.
- A collective watching brief.

Statistics

Accurate statistical analysis is key to understanding trends and patterns around CSE. Lancashire has been collating data on the children referred to police and children's social care for a number of years.

The latest data evidences that 62% of referred young people were aged between 13 and 15 and 95% were white, these are similar levels to previous reports. The majority of young people referred for CSE continue to be female.

Over the past 6 months there has been a notable increase in the number of young males referred as potential victims of CSE. Boys now constitute 22% of referrals over the period compared to 8% previously; this will be monitored to ascertain whether it is a longer term trend.

The number of the referrals relates to the number of cases that have had a multi-agency CSE risk assessment, the number of crimes references the crimes identified from the referrals.

To give you some commentary on the positive outcomes, several options are available.

Sanction meaning that the offender has either been charged or cautioned with an offence .

Police Resolution (PR) Restorative Justice (RJ) and triage are recognised alternative disposals aimed at diverting people from the criminal justice system. Lancashire does NOT use alternative disposals for sexual offences as much as some other forces and it is an area we are looking into.

An example of when an alternative disposal may be used is when it comes to light that two children under the age of 16 are engaging in sexual activity. Dependent upon the circumstances it may not be appropriate to take the matter to court, but it may be prudent to do some work with the children on sexual health and education about risk taking behaviour. We may then go down the Police resolution or Restorative Justice route.

Sexual offences reported against children has decreased since 2011-12, however the proportion of those offences where a positive outcome is achieved has increased.

Response to the Jay report

The LSCB sub group has been tasked with benchmarking Lancashire's position in respect of the 15 recommendations of the Jay report and is reporting to the health and well-being board in November 2014.

Key successes in 2013/14

Increased work with all diverse communities regarding awareness of CSE and confidence in the service provided

The Children's Society continue to provide a service known as 'Respect U & Me' in a Lancashire school where two groups of young men of Asian heritage were identified as displaying demeaning behaviour towards females (both their peers and women in general) and there was evidence of some elements of exploitative behaviour in their personal. relationships. The Children's Society worked with the groups on 'respect and healthy relationships' which culminated in the group producing a leaflet on key messages about respecting others this leaflet will be shared with other young men.

Develop approach to targeted organised criminal groups committing CSE

The Constabulary continues to target all those suspected of sexually exploiting children and young people. The publication of the OCC report "if only someone had listened" which was a 2 year inquiry into group and gang activity around CSE has identified best practice and defining principles in tackling OCG activity around CSE. These lessons have been embedded into the new CSE plan and will further enable police and their partners to refine the targeting, investigation and prosecution of organised groups.

Awareness raising activities

September 2013 OP Toledo – The sub-group co-ordinated a week long CSE awareness campaign.

The Constabulary, the Police and Crime Commissioner for Lancashire and many partner organisations worked closely together through Op. Toledo to achieve a highly effective CSE Week of Action, which commenced on Monday 9th September 2013. The main objectives for Op Toledo were to keep children in Lancashire safe from abusers, provide communities with confidence in the service and protection we provide and focus attention on our commitment and effective, innovative approaches to tackling CSE. A further week is planned in November 2014.

To achieve these objectives during the Awareness Week, we delivered a range of activities focusing on prevention, awareness, enforcement and community engagement. These included a major conference attended by 200+ Partners/Police, at which experts in their field identified and shared best practice. We also engaged with a diverse range of communities to raise awareness about CSE and focused on making sure the information reached young people.

Overall, the many and wide ranging activities highlighted how collaborative working with our partners provides powerful tools with which to successfully tackle CSE across Lancashire. Each dedicated CSE team collated information about their daily core activity.

The materials used to raise awareness amongst children, young people, families and organisations have been shared with other LAs and used in the Greater Manchester awareness week this month.

<u>Undertake activity to obtain feedback from young people who have been exploited</u> <u>regarding the service they received in order to continually seek to develop service</u> <u>improvement</u>

The Lancashire co-located teams include statutory and third sector providers. The colocated model provides an essential hub, in which the partners identify the needs of the victim and their family and work together to safeguard, support, investigate and bring offenders to justice. Our VCFS partners are crucial members of the teams and include Brook, The Children's Society, PACE, and Barnardos.

Intensive outreach workers, in the Children's Society's Street Safe Lancashire (SSL), provide valuable support to children and young people, at risk of or involved in sexual exploitation, from report through to the court process. They are co-located in 5 of our divisional teams, where they provide support to victims as part of an integrated package of multi-agency intervention.

Between April 2013 and March 2014, SSL supported 245 children and young people with interventions which raised awareness of grooming, CSE, healthy relationships and protective behaviours. These continued whilst they were needed by the victim and for varying periods from between 2-3 months and a few years, where young people struggled to cope and build resilience. They have also delivered a large number of group sessions in children's homes, schools, colleges and youth groups. SSL have also now employed a worker to work specifically with boys and young men. The worker has worked with 393 boys and young men over the 12 month period and had 154 one to one sessions with 11-18 year olds.

There are now specialist teams within Early Break who are carrying out early intervention outreach work following a successful lottery fund bid being granted to East Lancashire.

Parents Against Child Sexual Exploitation (PACE) parent support workers provide independent, non-judgmental and confidential support to parents, they understand the rights of parents and carers. They listen to concerns, give information on statutory agencies, court procedures and pass on advice from other affected parents. PACE workers help find the best solution for each family. PACE have delivered workshops within Lancashire and have been assisted by parents who themselves have been affected by CSE. Both The Children's Society and PACE are positioned to feedback to the teams the views and opinions of young people and their families of the service they were given and how we, as professionals could improve this experience.

Ofsted Showcase of good practice

Ofsted in November 2013 acknowledged the work undertaken by partner agencies, including The Children's Society in Listening, learning - influencing our response - Harnessing the views of young people to influence the shape of service to combat child sexual exploitation. Listening to and involving children and young people in the development of the services they receive is not an 'add-on' but at the heart of what Lancashire does. Although work with victims and perpetrators of child sexual exploitation poses challenges, the views of children and young people who have experienced abuse are being effectively used to influence policy, procedure and practice across Lancashire. The *Street Safe Lancashire* programme is at the forefront of this work.

Review and Develop training for all frontline professionals re awareness of CSE

The Children's Society and police continue to deliver a CSE training package on behalf of the LSCB to practitioners. They have now further developed a training package to be delivered to Managers.

The one day training is delivered by experienced staff who work in the CSE arena on a daily basis. The feedback from participants of the course has been excellent. Further regular inputs to both practitioners and managers are pencilled in for the next 12 months.

Training to children social care workers is embedded into their training programme with bespoke events facilitated linked to local need.

Online e learning has been available since 2013 with 2345 participants having successfully been accredited.

LGA award 2012

Following a successful pilot a recent commission to support prevention and early help for those children and young people that go missing that fall outside of statutory frameworks

Multi-agency Strategic Plan to tackle CSE

Lancashire's child sexual exploitation strategic plan continues to focus of the following areas to manage the risk that this area of work presents:

- greater awareness of CSE leading to greater management of risk and reassurance in communities;
- protection of vulnerable victims with a clear, proactive approach in protecting those at greatest risk;
- more perpetrators brought swiftly to justice with greater support for victims throughout their involvement with criminal justice services;
- greater collaboration amongst multi-agency teams to achieve the best outcomes for victims and those at risk of exploitation;
- good intelligence shared more widely to inform decisions on the targeting of perpetrators and protection of those at risk;
- strong, effective and well informed leadership within all partner organisations;
- a commitment to ongoing learning and development in a multi-agency environment where best practice is widely shared and consistently applied.

Appendix A Definition

"A form of child abuse ("child" being defined as anyone under 18 years of age). It can manifest itself in different ways but essentially involves children and young people receiving something – for example, accommodation, drugs, gifts, or affection – as a result of them performing sexual activities, or having others perform sexual activities on them. It can occur without physical contact, when children are groomed to post sexual images of themselves on the internet.

In all cases those exploiting the child or young person have power over them, perhaps by virtue of their age or physical strength. Exploitative relationships are characterised in the main by the child's limited availability of choice, compounding their vulnerability. This inequality can take many forms but the most obvious include fear, deception, coercion and violence."

Transportation of shale gas vehicles through the North of Preston

In light of objections to the proposed numbers and routing of HGV's to the Roseacre Wood site the applicant has proposed an alternative route providing for a one way system for HGVs to access the site via the A6 and the B5269 and exit the site via Clifton onto the A583. This proposal was assessed by LCC Highways and found to be unacceptable. Consequently the proposed amended routing was not advertised nor consultations carried out.

However, in view of the deferral of the applications following the submission of further information relating to noise which will need advertising we will take the opportunity of advertising the proposed amended routing as well.

We are only required to advertise the further information in the press but it is likely that we will consult the respective parish councils affected and those properties fronting the route.

We doubt there would be an issue with the proposed increase in traffic associated with the proposed amendment in terms of the impact on overall usage of the cross roads or cumulative impact with other developments due to the short duration of any increase on a periodic basis. The greater concern is the nature of the highway network to accommodate the type of vehicles proposed. However, all of this is set out in the committee report and supporting appendices which can be accessed on the committee web pages or on our own planning register (LCC/2015/0101). Highways have objected to the proposed amended routing already, so in many respects there is no necessity to consider the impact of such on highway issues in the wider area.

All of this will be advertised as soon as possible and currently we have time extensions in place until the end of April.
