1. Welcome and Apologies for Absence

Chair welcomed members to the meeting and apologies were noted from County Councillor Jennifer Mein. In addition, Stephen Decent attended in place of Mark Smith and Anthony Lockley in place of Cllr Simon Blackburn.

2. Declarations of Interest

There were no declarations of interest at this point.

3. Minutes of the meeting held on 26th January 2016

Resolved: Minutes from the last meeting were agreed as an accurate record.

4. Matters Arising

There were no matters arising.

5. Terms of Reference

The updated terms of reference were circulated to the committee.

Resolved: The Committee:

- 1. Noted the amended terms of reference
- 2. Noted that further updates were to be completed to reflect the four Enterprise Zone sites

6. Positioning and Promotion of Lancashire's Enterprise Zone Programme

Kathryn Molloy, Head of LEP Coordination, outlined the report circulated to the Committee which presented options for positioning and promoting Lancashire's Enterprise Zone Programme, including giving consideration to the naming of individual sites as well as the cluster of four sites within the context of the LEP's strategic marketing and communications approach.

Samlesbury

Committee members were advised that the current focus at Samlesbury has been on the conclusion of the land agreement and delivery of the spine road work.

It was confirmed that the spine road work commenced in April 2016 along with the delivery of a new access point to the Enterprise Zone from the A677.

The land deal between BAE Systems' Pension Fund and the County Council has been completed through a land option agreement.

The land agreement supports three development routes. Colliers International have been retained as the commercial agents to identify potential end-users. In addition BAE Systems were reported to be in discussion with companies in their supply chain (nationally and internationally) to locate to the Enterprise Zone.

In relation to securing a North West facility of the Advanced Manufacturing Research Centre (ARMC) at Samlesbury, it was reported that a Growth Deal 3 submission has been made to the LEP. Committee members agreed this was a significant opportunity for Lancashire. In addition, a model to engage with SME's was being considered.

The Training and Logistics facilities were confirmed to be completed in the Autumn. It is expected that 120 apprentices were due to start at the Training Centre in September and 150 jobs are to be created through the opening if the Wincanton Logistics facility.

<u>Warton</u>

The report provided an update following the implementation of a new 10 year Local Development Order. Preparatory work was reported to be underway with BAE Systems to understand possible infrastructure requirements to enable delivery of the Enterprise Zone.

Positioning and Promotion

Ruth Connor, Chief Executive, Marketing Lancashire, was welcomed to the meeting to discuss the positioning and promotion of Lancashire's Enterprise Zones.

It was reported that there were two upcoming national events (Farnborough Air Show in July and MIPIM UK in October). As the Farnborough Air Show is in July, it was suggested it could be used to promote the Samlesbury site of the Lancashire Enterprise Zone. Ruth confirmed that press releases are due to be issued regarding the appointment of Colliers International.

Committee members agreed that this was a good time to focus on marketing and there was a need to give significant time and consideration to ensure a coherent marketing strategy of the four sites which had the right balance between the individual locations (to show the different characteristics of each site) and the collective programme of sites. It was also agreed that there was a need for this to be a collaborative piece of work with local authority partners and landowners as well as wider stakeholders.

A commitment was identified to address any gaps in governance and to agree a set of protocols between the sites to ensure that the right companies are located to the right site and to minimise the potential risk of competition between sites

It was suggested that a marketing group could be set up to come together in the Summer to look at this in greater detail to come back to the next meeting of the Committee in September.

Resolved: The Committee:

- 1. Noted and commented on the contents of the report, including progress made in delivering the Samlesbury and Warton sites of the Lancashire Advanced Engineering and Manufacturing Enterprise Zone
- 2. Considered and agreed the role of Lancashire County Council Developments Ltd, on behalf of Lancashire County Council, in delivering direct development on the Samlesbury Enterprise Zone site
- 3. Considered and discussed options for naming Lancashire's four Enterprise Zone sites, as set out in the report
- 4. Agreed to the appointment of Freshfield to create visual concepts with supporting narratives to inform the naming, positioning and promotion of Lancashire's Enterprise Zone Programme, including the naming of Lancashire's Enterprise Zone cluster and/or its for individual sites
- 5. Approved the use of up to £5,000 from the LEP's agreed Strategic Marketing budget to commission the proposed work from Freshfield
- 6. Requested the Chief Executive of Marketing Lancashire and the Head of LEP Coordination and Development, in consultation with local authority partners and key Enterprise Zone landowners to work with Freshfield to produce visual concepts and naming options for consideration by the Enterprise Zone Governance Committee
- 7. Recommendations 8 and 9 to come back to the September meeting

It was confirmed that there was to be a focus on regular updates for LEP and a request for a specific agenda item for Enterprise Zone updates.

Executive Summary

The report updates the Committee on changes to the Terms of Reference for the Committee which were agreed by the Lancashire Enterprise Partnership Board on the 14 June 2016.

Recommendation

The Enterprise Zone Governance Committee is asked to note the revised Terms of Reference at Appendix 'A'.

Background and Advice

At the meeting of the Lancashire Enterprise Partnership (LEP) on the 5th April, the Board agreed that a formal annual review of the LEP's Assurance Framework would be undertaken by the Board in June of each year.

This review has now been undertaken and attached at Appendix 'A' to this report, is the approved Terms of Reference for the Enterprise Zone Governance Committee.

The main changes to the Terms of Reference for the Enterprise Zone Governance Committee relate to the roles and responsibilities which now reflects the four Lancashire Enterprise Zones.

Members can nominate substitute representatives, with written notification provided to the Clerk in advance of the meeting. Substitutes will be counted towards the quorum and will be entitled to vote. The use of substitutes shall be by exception rather than rule.

Frequency of Meetings

Bi-Monthly, or as required in accordance with operational need.

Observers

The EZ Governance Committee may invite any persons it sees fit to attend meetings as observers. Observers shall be subject to the LEP Assurance Framework protocol on observer attendance at meetings.

Secretary

The Company Secretary of the Lancashire Enterprise Partnership (or their nominee) shall serve as the Secretary ("The Secretary") to the EZ Governance Committee.

The Secretary shall produce minutes of all meetings of the EZ Governance Committee and will maintain a list of conflicts of interests. Future agendas will include a standard item requiring declarations of interests to be made in relation to specific items of business.



Decisions in Writing

A resolution in writing signed by the majority of the members of the EZ Governance Committee for the time being shall be as valid and effectual as if it had been passed at a meeting of the Committee.

Role and Responsibilities

The EZ Governance Committee is a committee of the Lancashire Enterprise Partnership.

The EZ Governance Committee is responsible for setting and overseeing the strategic direction of the Lancashire Enterprise Zone. It will also provide regular reports to the LEP Board, specifically focusing on:

- Regular progress updates on the delivery of infrastructure into Lancashire's 4 Enterprise Zones;
- Regular progress reports on the drawdown/development of land on Lancashire's 4 Enterprise Zone sites;
- Regular progress reports on the generation of commercial leads and enquiries on Lancashire's 4 Enterprise Zone sites;
- Regular financial reports regarding the generation of Business Rates growth at Lancashire's 4 Enterprise Zone sites;
- Regular financial reports on Business Rates Relief providing to companies locating to Lancashire's 4 Enterprise Zone sites;
- Regular financial reports on the provision and repayment of any public investment provided in support of the development of Lancashire's 4 Enterprise Zone sites;
- Regular progress updates on the number of jobs and commercial floor-space created across Lancashire's 4 Enterprise Zone sites; and
- Regular progress reports on planning frameworks and commercial masterplans in place across Lancashire's 4 Enterprise Zone sites.
