1. Welcome and Apologies for Absence

The Chairman welcomed all to the meeting. Apologies for absence were presented from Tim Webber with Vladimir Pejcinovic attending in his place, Frank McKenna with Antony Camm attending in his place and Gillian Bardin.

2. Declaration of Interests

None

3. Minutes of the meeting held on 11th October 2017

Resolved: The minutes of the meeting held on 11th October 2017 were agreed as an accurate record and signed by the Chairman.

4. Matters Arising

The Chairman sought feedback from the LEP Business Support Management Board on recent developments with Northern Rail, he agreed to feed these comments back via the Manchester Local Enterprise Partnership.

5. Presentation on Productivity Study

Val Moon and Professor Susan Smith (both University of Central Lancashire) gave a presentation containing the results of a Productivity Study undertaken.

It was noted that in terms of overall productivity in Lancashire a calculation measuring Gross Value Added (GVA) per hour measured as a percentage relative to UK and the top 10 and lowest 10 scoring regions were presented.

Inner London – East scored over 140 GVA whereas Lancashire scored slightly over 80 GVA.

It was noted that business in Lancashire had been consulted and requested to complete surveys. From this it was concluded that:

- Companies in Lancashire may be overestimating their productivity, some do not regard it as a managerial priority, and not many measure it.
- The notion that workplace flexibility could be used to improve productivity was not being embraced by a significant proportion of businesses.
- Investment in training and skills compared to the previous year was only seen in around a quarter of the businesses responding and only around a fifth had invested in research and development.
- Most of the business leaders in the research described themselves as "good" but fewer than half described themselves as ambitious and yet it has been found that these descriptions can be relevant to business productivity.
- To the extent that growth of businesses can be correlated to growth in number of employees, there is only a core of growing businesses in the region. However, there is ambition and intent amongst SMEs to achieve growth and it seems that SMEs are most interested in differentiation and innovation.
- There is good evidence to link stronger productivity in SMEs to their degree of internationalisation. However, the majority of SMEs surveyed for this work do not export.
- There is ambition and intent amongst SMEs to achieve growth and it seems that SMEs are most interested in new markets, training and innovation.
- The most common suggestion as a potential source of help with reducing obstacles to productivity was the LEP/local authorities.

In terms of recommendations to improve productivity, the board noted the following:

- To devise and deliver a campaign to educate SMEs about productivity and its importance.
- Flexible working practices are well documented as potentially influential in the improvement of productivity. More information and education about the potential benefits of flexible working should be made available and conveyed to SMEs in Lancashire.
- To devise policy and training that will encourage more business leaders to invest in skills and training for their workforce and research and

development for their business.

- It is recommended to increase training, research and development and leadership skills amongst businesses in Lancashire. Given what is known regarding the contributions to productivity by the latter, this is likely to improve productivity.
- To share expertise in the areas of differentiation and innovation.
- The agenda of exporting and internationalisation should be brought even further to the fore amongst SMEs in Lancashire.
- To share expertise in the areas of accessing new markets, training and innovation.
- Services such as the BOOST business gateway and the projects funded by the European Economic Community support this agenda. A contingency/action plan should be created to ensure that this type of initiative continues.

Resolved: That the presentation on the Productivity Study be received and that the actions and recommendations be endorsed. In addition the Business Support Management Board requested that the Head of Service Business Growth, Lancashire County Council produces a report on Productivity and submits it to the full LEP Board meeting scheduled to be held in November 2018.

6. Growth Hub Annual Report 2017-18

Andy Walker, Head of Service Business Growth, Lancashire County Council, presented a report (circulated) regarding the Growth Hub containing an Annual Report for 2017/18.

It was highlighted that it is now a formal condition of BEIS support to the individual Growth Hubs that an Annual Report is presented via the Growth Hub governance structure to the LEP for approval. The report detailed the overall performance and any issues in delivery of the Growth Hub.

It was noted that over the period 1st April 2017 to 31st March 2018 some 2921 enquiries were handled by the Boost Gateway, of which 456 were dealt with at source, 2365 enquiries resulted in referrals of which 2034 were referred to Boost projects and 592 were referred to other business support organisations.

Overall Boost is performing well, with the majority of targets being achieved or just slightly below expectation, however there have been areas of concern. The activity of C2 grants (Growth Vouchers) has consistently fallen behind targets despite intensive support and guidance from Lancashire County Council. This has a knock on effect on the C1 targets (C2 is a subset of C1) and on C6 that represents the private sector contribution to match the Growth Vouchers.

The delivery contractor has indicated that they will not be able to achieve the lifetime target (300) for Growth Vouchers (2016-18) and therefore a revised target of 168 has been agreed together with a reduced C6 target. The resulting deficit of 132 C1 outputs has been resolved in discussions with two of the other Boost delivery organisations who have agreed to increase their performance to make up this shortfall by the end of 2018.

Resolved: The Business Support Management Board considered the detail of the report and recommended that the LEP Board endorses the annual report at its next meeting on 26th June 2018.

7. Forward Plan

It was noted that the next meeting of the Business Support Management Board was scheduled for 19th October 2018. It was agreed that the following items should be considered at the October 2018 meeting:

- Programme of Key Decisions and Procurement Process
- Half Year report on Growth Hub.
- Industrial Strategy Report
- Productivity / Digital Skills.

8. Reporting to Lancashire Enterprise Partnership Board

It was noted that the Growth Hub Annual Report would be referred to the LEP Board for approval.

9. Any Other Business

The Board discussed the role of SME Champion. It was noted that the LEP was currently recruiting three new LEP Directors with the intention that one would become the SME Champion, this should be in place by the time of the next Board meeting.

10. Date of Next Meeting

It was noted that the next meeting of the Business Support Management Board was scheduled to be held at 10:30am, on 19th October 2018 in Committee Room 'B' - The Diamond Jubilee Room, County Hall, Preston

11. Exclusion of the Press and Public

Executive Summary

In addition to providing expertise and oversight of the LEP's direct and commissioned business support activities, the committee also acts as a conduit for the LEP itself to seek the views of Small and Medium Sized Enterprises and to engage key business membership organisations.

Since the resignation of Mike Damms from the committee in 2017, there has been a vacancy on the Business Support Management Board.

Given the increased role of East Lancashire Chamber of Commerce in both policy development and service delivery and the importance or retaining a business voice from east Lancashire, it is recommended that Mike Damms successor as Chief Executive Officer at the East Lancashire Chamber – Miranda Barker, be recommended to the LEP to fill this vacancy.

Recommendation

The Business Support Management Board is asked to recommend that the LEP Board invites Miranda Barker to become a member of this LEP committee.

1. Background and Advice

- 1.1 The LEP's Business Support Management Board requires members who have a clear understanding of operating in the private sector, the pressures which face businesses and how and where publicly funded support interventions can be used to address genuine market failure and enable business growth.
- 1.2 The optimal membership and skills set of Business Support Management Board should also allow the LEP itself to effectively engage and understand the views



of SME's and, via the participation of key business membership organisations, be able to reach a significant proportion of the local business community.

- 1.3 A brief biography of Miranda's experience is attached to this report at Appendix 'A', but it clearly demonstrates a rich and varied experience of working within the private sector and delivering business support in Lancashire and other areas.
- 1.4 Miranda is also extensively engaged in regional / northwest forums particularly those focussed on manufacturing and international trade.

1.5 In addition to her role with the Chamber, Miranda is also:

- a board member of Pendle Vision, and Blackburn Hive,
- a member of Burnley Bondholders, Amazing Accrington
- Chair of Ribble Valley leaders and Rossendale Leaders.
- Sits on the Pennine Lancashire Chief Exectives group.

Executive Summary

As the primary LEP committee dealing with business engagement and support, the Business Support Management Board receives an update on Growth Hub Performance as a standing item of business.

The Boost 2 European Regional Development Fund (ERDF) project is now drawing to its close but continues to perform well both in terms of achieving key funding performance requirements and in terms of wider local impact.

As at the end of Quarter 3 (calendar year) 2018, initial figures show that Boost 2 (2016-18) had delivered:-

1525 business information, diagnostic and brokerage interventions

- 1226 Businesses Supported
- > 352 under 12 months
- > 162 received grant to the value of 420k
- 370 individuals assisted to start a business
- 972 jobs created
- £20million GVA created
- 5600+ referrals made to additional support services

The application for Boost 3 (2019-2021) was approved at the last Lancashire European Structural and Investment Funds (ESIF) Committee and we are currently procuring partners to deliver the programme from the 1st January 2019.



HOW DO WE PERSUADE BUSINESSES TO KEEP INVESTING IN SKILLS?

Andrew Learning: How can we not keep investing in skills? In periods of uncertainty you can't stop doing what you are doing. What you need to do is knuckle down, look at doing more and look at having better, smarter conversations.

It's about how, as business owners, you try to enforce and reinforce the idea that you need your staff and your team to be the very best they can be.

Lisa Moizer: Businesses have to be open to having a conversation. If everything is going well it's very hard to persuade a business to make an investment when they don't see the return on that investment. It comes down to whether or not the see it as beneficial and why there are barriers.

Nigal Davies: You need to know your own business. One of the key things we have looked at and have a clear understanding of is demographics in relation to how we deliver skills and training.

We need to meet the needs of the younger generation coming in but there is still a need to re-skill and refresh the older generation in relation to the changes of our business.

We invested in our training centre because we wanted to look at how we innovate and inspire our existing workforce, but also the next generation

Richard Harrison: Skills Isn't the start of the conversation, it is the end of it. If we look at the productivity gap, we perform well as a country with technology and with process. So you have to improve people to improve producti

Skills provision has to be linked to benefit or impact. If we're selling skills commercially the first thing we need to do is go to a business and talk about the impact and the return on investmen

It's not just the cost of training in terms of pound notes but also the time companies contribute. It's a big investment so organisations need to see a tangible return.

Andrew Lewring: There's a real stareotype out there about training being this really duil, uninteresting load of paperwori and we need to shift the conversation away from training that is passive into training that is dynamic, exciting and invisorating.



Executive Summary

In mid-October, the Northern Powerhouse Investment Fund (NPIF) celebrated the milestone of having backed £100m of investment across the Northern Powerhouse region.

The fund has directly invested £60m in small and medium sized companies since its launch, in deals that have attracted an additional £40m of investment from the private sector.

Investments from the fund cover a broad range of business types with a strong appetite evidenced from manufacturing and high-tech businesses with a total of £11m and £15m invested in these sectors respectively.

To date, NPIF has made over 300 investments in small growing businesses across the 10 Local Enterprise Partnership (LEP) areas it operates in. Examples of recent deals include Lancashire-based Extreme Low Energy, which received £750,000 to double its head count and expand its range of products and a £500,000 investment into a technology company.

The attached presentation details performance of the fund in Lancashire and highlights some case studies in terms of recent investment.







Executive Summary

In 2017 Lancashire Enterprise Partnership commissioned UCLAN to develop a report on productivity issues within the Lancashire Economy. This report is part of a wider evidence base, being developed to inform a refreshed Strategic Economic Plan and/or Local industrial Strategy for the sub-region.

The report comprises an econometric assessment of productivity performance and issues for Lancashire, coupled with desk and survey research focussed on Small and Medium Sized Enterprises and so called "Scale-Up" businesses.

The recent LEP Review (July 2018) prioritises addressing productivity issues as being one of the core responsibilities of LEPs, both in terms of the UK's overall performance against other advanced economies and in terms of addressing regional disparities.

Executive Summary

Supporting the development of the Low Carbon or Clean Growth economy is now central to the government's Industrial Strategy. This report draws together the local energy / low carbon strategic aims for Lancashire, developed in the draft Energy Strategy and the activity which has been commissioned utilising European Structural Funds.

The report also details how the East Lancashire Chamber of Commerce are acting to draw together the low carbon and carbon reduction offer to businesses, to ensure these projects operate in a co-ordinated way and are well understood and easy to navigate for businesses themselves.

Recommendation

The Business Support Management Board is asked to note this report.

1. Background and Advice

- 1.1 The current and future planned provision to be funded through Priority 4 mirrors the local energy / low carbon strategic aims for Lancashire
 - supporting the development of new low carbon technologies within Lancashire.
 - publicising existing and innovative technologies out to our broad SME base and driving their take up.



- Working with the student base and R & D innovation support to embed low carbon expertise within businesses to see low carbon/sustainability initiatives implemented.
- working on our domestic housing stock to improve its energy efficiency / energy generation potential.
- 1.2 Current provision is delivered by UCLAN, Lancaster University and East Lancashire and North & Western Lancashire Chambers of Commerce, all in partnership with BOOST as the Local Growth Hub, with potential future provision also through Together Housing.
- 1.3 All current projects are FREE of charge, for Lancashire based SMEs i.e. 250 or less employees, with a turnover below 50 Million Euros and balance sheet below 43 Million Euros (with less than 25% of their capital owned by any non-SME or group of non-SMEs).
- 1.4 Collectively the 3 current SME focused programs are there to work with 880 SMEs across all sectors, working with them to see energy consumption reduced, on site generation increased, new low carbon technologies embedded, low carbon products / systems of working developed, and new low carbon technologies commercialised, ultimately reducing the greenhouse gas emission across Lancashire whilst stimulating the low carbon technologies sector across the county.

Potential SME customers are those who -

- Want to reduce their energy bills.
- Want to reduce their water use, waste produced or raw material wastage.
- Want to install lower energy consumption equipment.
- Want electric vehicle charging points.
- Want to create on site energy generation capacity for their firm.
- Want solar panels, LEDs etc.
- Or just advice, training and support to be more environmentally sound or energy efficient.
- Across two projects there is grant support available for the capital costs of the low carbon equipment - 50% of up to £8,000 of kit or 30% of up to £25,000 of kit.

At the in-depth end –

- Those who want to develop more brand-new low carbon technologies or systems or ways of working in their business and would like a student based with them to drive that low carbon initiative.
- Those who have new low carbon technology in prototype form but need support to commercialise it manufacture it and find demonstrator customers/first adopters.



All the projects are free for SMEs to access, and we hope will be running for the next 3 to 5 years European structure funding permitting

Specifically -

- Lancaster University project LOCAL-I is there to work with 180 companies and help embed students to support SMEs with Research and Development to develop in depth low carbon innovations within their businesses.
- MACAW (UCLAN) is there to work with 200 SMEs to support SMEs in improving their energy efficiency, resource efficiency and install new low carbon solutions with grant support.
- Chamber Low Carbon is there to work with 500 SMEs to work on site with them to develop energy efficiency and resource efficiency solutions and drive the installation of low carbon technologies with grant support, and to work with 100 low carbon technology innovators to drive the commercialisation, demonstration and manufacture of those products.

Currently all 3 programs are working with 340 Lancashire SMEs delivering audits, workshops and implementation support.

SILVERWOODS WASTE MANAGEMENT

Silverwoods Waste Management offers services in consultancy and environmental permitting, in-vessel composting, land spreading of industrial waste and total waste management. The business has won numerous awards including Lancashire's Rural Business, Green Business and Small Business. Silverwoods are currently managing over 350,000t/yr of a wide range of wastes including lime wastes produced from the cement industry.

PROJECT

The UK cement manufacturing industry produces approximately 100,000 tonnes of waste cement bypass dust (CBD) annually. Currently, CBD is usually disposed of in landfill, but it is increasingly being recognised for its potential to replace conventional fertilisers or lime in agriculture. This project will characterise how CBD from different sources can be used most effectively. The project will also re-assess liming recommendations, since current DEFRA recommendations for lime application may not be appropriate for all soil types. Incorrect liming locks-up nutrients that are essential for crop growth, thus negating potential agricultural benefits. The research will allow CBD to be used as a resource in farming instead being dumped as a waste-product.

MaCaW Project – Brief Outline

In simple terms it is a 4 stage project:

- Stage 1 is a series of workshops and conferences for SMEs to attend in order to learn about the benefits of carbon reduction in their business, possible solutions etc.;
- Stage 2 involves 12 hours of support to the business where we will provide an in-depth audit based on the lifecycle thinking model (we will go out to the business, complete energy audit, water audit, waste audit) followed by an action plan;
- Stage 3 involves 50% match funding grants (up to £8k) for relevant equipment;
- Stage 4 involves monitoring and support.

Not all businesses will go through all stages of the programme – many will just go through stage 2 and not be eligible for a grant, for example. The general overview of the project is below:

Project MaCaW is an academic/industry collaboration designed to assist Lancashire SMEs to overcome the challenges and barriers in moving towards a low carbon economic model. This project aims to engage Lancashire SMEs in implementing low energy practices and processes to reduce their carbon burden, as well as making cost savings to their organisation.

Who is it for?

To benefit from the MaCaW project your business must meet the following eligibility criteria:

- Located in the Lancashire region
- Trade business to business (B2B)
- Employ 250 employees or less
- Have either an annual turnover that is equal to or less than 50million Euros or a balance sheet total that is equal to or less than 43million Euros

What will this involve?

The MaCaW project will work with SMEs across sectors to identify and prioritise these opportunities. This will be achieved through implementation of energy efficiency measures (energy plans), investment in low carbon technology and diversification of resources into low carbon goods. In Integrating Life Cycle Thinking (LCT) with the Green House Gas Protocol, we will assist organisations to manage and report their emissions effectively. This will assist Lancashire to reduce its overall carbon emissions and contribute to the UK carbon target.

Executive Summary

There are currently 26 European Regional Development Fund (ERDF) contracted projects covering Lancashire, committing £41.644 million (excluding Financial Instruments i.e. The Northern Powerhouse Investment Fund). This is the current commitment against an allocation value of £146.502 million, equating to 28%.

A total of 21 pipeline projects totalling £31 million are at outline / full application stages, which gives an overall total £85 million. This gives Lancashire almost 58% of the programme committed if all the projects were contracted. The remaining balance of £61.538 million is yet to be allocated.

Recommendation

The Business Support Management Board is asked to:

- (i) Note this report.
- (ii) Input on further options to ensure that Lancashire effectively utilises the maximum amount of ERDF funding to advance agreed business support, innovation and low carbon ambitions.


