ROAD TRAFFIC REGULATION ACT 1984 LANCASHIRE COUNTY COUNCIL

(VARIOUS ROADS, LANGHO, LONGRIDGE AND MELLOR, RIBBLE VALLEY BOROUGH) (REVOCATION AND 20MPH SPEED LIMIT) ORDER 201*

The County Council of Lancashire, in exercise of its powers under Section 84 and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

1. Revocation

The 'The Lancashire County Council (St Mary's Gardens Area Zone, Mellor, Ribble Valley Borough) (20mph Speed Limit) Order 2002' is hereby revoked in full.

2. 20mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 20mph on any of the lengths of road as set out in Schedule 1 to this Order.

3. Exemption

No speed limit imposed by this order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those Regulations.

4. Commencement of Order

This Order shall come into force on the ** day of ** 201* and shall be cited as the "Lancashire County Council (Various Roads, Langho, Longridge And Mellor, Ribble Valley Borough) (Revocation And 20mph Speed Limit) Order 201*".
