

ROAD TRAFFIC REGULATION ACT 1984

LANCASHIRE COUNTY COUNCIL

(BAY GATEWAY, CATON ROAD, FOLLY LANE, GREEN LANE, HADRIAN ROAD, HALTON ROAD, LANCASTER ROAD AND POWDER HOUSE LANE, LANCASTER, LANCASTER DISTRICT) (REVOCATION, DE-RESTRICTED ROAD, RESTRICTED ROAD, 20MPH, 30MPH, 40MPH AND 50MPH SPEED LIMIT) ORDER 201*

The County Council of Lancashire, in exercise of its powers under Sections 84(1)(a), 83(2) and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

1. Revocation

Those parts of the following Orders, as set out in schedule 1 to this Order, are hereby revoked:

- a) The "Lancashire County Council (Speed Limit Management) (Various Roads, Lancaster City Area) (Part Revocation, 30, 40, 50 and 60mph Speed Limit) (No 1) Order 2010";
- b) The "Lancashire County Council (A6 Lancaster Road, Slyne-with-Hest, Lancaster City) (Restricted Road) Order 1994";
- c) The "The City Council of Lancaster (A683, Caton Road, Lancaster and Quernmore) (40 m.p.h. Speed Limit) (No. 1) Order 1988";
- d) The "Lancashire County Council (Morecambe South Area, Morecambe and Heaton-With-Oxcliffe (Various Road), Lancaster City) (20mph Speed Limit) Order 2013".

2. 20mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 20mph on the length of road as set out in Schedule 2 to this Order.

3. 40mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 40mph on any of the lengths of road as set out in Schedule 3 to this Order.

4. 50mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 50mph on the length of road as set out in Schedule 4 to this Order.

5. De-Restriction (National Speed Limit Will Apply)

The length of road as set out in schedule 5 to this Order shall cease to be restricted road for the purposes of Section 81 of the Act.

6. 30mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 30mph on the length of road as set out in Schedule 6 to this Order.

7. Exemption

No speed limit imposed by this order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those Regulations.

8. Commencement of Order

This Order shall come into force on the ** day of ** 201* and shall be cited as the "Lancashire County Council (Bay Gateway, Caton Road, Folly Lane, Green Lane, Hadrian Road, Halton Road, Lancaster Road And Powder House Lane, Lancaster, Lancaster District) (Revocation, De-Restricted Road, 20mph, 30mph, 40mph And 50mph Speed Limit) Order 201*".

Schedule 1 – Revocations

- a) Schedule 3.
- b) In full.
- c) In full.
- d) Hadrian Road.

Schedule 2 - 20mph Speed Limit

Hadrian Road, Morecambe, the entire length.

Schedule 3 - 40mph Speed Limit

- a) A683 Bay Gateway, Morecambe, from the centre of its junction with A589 Morecambe Road for a distance of 1030 metres in a north easterly direction;
- b) A683 Bay Gateway, Morecambe, from the centre of its junction with A589 Morecambe Road to its junction with Mellishaw Lane;
- c) A683 Bay Gateway, Halton, from a point 291 metres east of the centreline of Carus Bridge (which carries Kellet Lane (C485) over the A683 Bay Gateway) for a distance of 455 metres in an easterly direction;
- d) A683 Bay Gateway, Halton, from a point 50 metres north of the centreline of its junction with A589 Caton Road for a distance of 590 metres in a northerly direction.

Schedule 4 - 50mph Speed Limit

A683 Bay Gateway, Slyne, from a point 1030 metres from the centre of its junction with A589 Morecambe Road for a distance of 1161 metres in a north easterly direction.

Schedule 5 – De-Restriction (National Speed Limit Will Apply)

A683 Bay Gateway, Slyne, from a point 67 metres west of the centreline of Lancaster Road Bridge which carries A6 Lancaster Road over A683 Bay Gateway, for a distance of 400 metres in an easterly direction.

Schedule 6 – 30mph Speed Limit

Halton Road, Halton, from the centreline of Kellet Lane, for a distance of 1282 metres in north easterly direction.
