Executive Summary

This report requests approval of a proposed programme of work to be funded from the Highways Projects and Resources (Planned Works) allocation of £3million approved by Cabinet on 20 July 2017.

Recommendation

The Cabinet is recommended to approve the proposed process, as outlined in the report, for developing a programme of works to be funded from the Highways Projects and Resources (Planned Works) allocation of £3million approved by Cabinet on 20 July 2017.

Background and Advice

On 20 July 2017, Cabinet approved revisions to the 2017/18 Budget including an additional £5million of capital funding for highway maintenance. Of this, £3million was allocated to fund planned capital works in line with the county council's approved Transport Asset Management Plan (TAMP).

The TAMP identifies the key strategic priorities of the county council as the local highway authority and sets out how the county council will manage its transport assets up to 2029/30. Recent analysis suggests that this investment strategy will result in:

- Condition targets for the classified (A, B & C) network achieved earlier than envisaged.
- Less investment in the rural unclassified road network being required than in the urban unclassified network (residential streets) to prevent



deterioration and ensure improvements to both networks are advanced at the same rate.

In light of this analysis, on 10 August 2017 Cabinet considered the proposed criteria to allocate this funding and approved that this allocation be used to reduce the rate of deterioration to the urban unclassified network. A programme of work was subsequently developed based on a technical assessment and presented to Cabinet in September 2017. Cabinet agreed to defer a decision in the light of feedback that county councillors would welcome the opportunity to be involved in the process.

It is therefore proposed that briefing sessions be arranged, on a district basis, for county councillors to discuss the urban unclassified (residential streets) locations that are considered priorities for investment from a highway technical assessment. It is proposed that a programme of work then be presented to Cabinet in February 2018 to allow the programme of works to be delivered in the financial year 2018/19.
