Executive Summary

Friends Groups have long been one of the ways that cultural organisations engage with their users and there are many functioning friends groups linked to Library and Information Services in the UK. This report outlines proposals to revise the 'Friends of Lancashire Libraries Constitution' (and associated documents) to reflect the approach to community set out in the recently revised Library Strategy. These documents will complement existing policies and procedures in place within the County Council, such as the Premise Use Policy.

Recommendation

The Cabinet is recommended to:

- (i) Review and agree the revised 'Friends of Lancashire Libraries Constitution'.
- (ii) Review and agree the associated 'Using Friends Groups to enhance Libraries' staff guidance document.
- (iii) Review and agree the 'Friends of Lancashire Libraries Donation Form' document.

Background and Advice

The *Strategy for Lancashire's Libraries 2016-21* identifies Friends Groups as of key importance in moving forward as a library service, both as a way of funding additional events and activities, and as a way of engaging with the wider community. Therefore, libraries will work collaboratively with our Friends Groups to develop exciting and meaningful services for our communities, recognising the individual nature of each community and the resources available locally. In doing so we aim to remain relevant to our communities and deliver truly asset based services.

Friends Groups are open to any individual who wants to get involved and support their library. Many groups have started with small numbers and have grown over time. Our experience is that a small group can still be very effective in making a positive difference.

In adopting the revised constitution and associated documents we have a more consistent and co-ordinated approach to establishing and working in collaboration with library Friends Groups throughout Lancashire. By increasing the number of Friends Groups we will get greater community involvement and increased sense of ownership in their own local library, while increasing the opportunities for attracting additional external funding via the Friends Groups which can be invested in our libraries.
