In the middle of the 20th Century, Leyland & Farington was a hive of industry with the Leyland Motors (later British Leyland), three rubber companies, bleach works, Leyland Paints, four cotton mills, gold thread works, gas works and various small manufactories. There were approximately 30,000 people in various workforces.

As these industries have declined and closed, the workforce's stories of what went on in the factories have not been recorded. In order to commemorate Leyland Historical Society's 50th Anniversary the Society has decided to record the workforce memories before they disappear. The Society has over 75 contacts from previous events.

The Society intends to open a temporary Heritage Centre in the main shopping street to reach all the local population and demonstrate the Society's work over the last 50 years. We will take this occasion to publicise the oral history project, interviewing ex-employees then or at a later date with the assistance of students from the University of Central Lancashire.

The resulting archive will then be available in CD, video, book and on website for the use of various museums, libraries, schools and colleges who have expressed their interest in using the archive in their curriculum

## 4.4 How will the money benefit people in the Councillor(s) division(s)?

The oral heritage will be recorded by sound and/or video and book so that future generations will know what the various workforces of Leyland made and how they lived while working for the companies of the town. The oral history project will be added onto the Society's award winning website which receives an average of 7000 hits per month so anyone researching the history of the Leyland's industries can obtain information there.

As the Society does not know how large the project may extend, we have only been able to make rough calculations for the costs of books, cds and dvds. The Society aims to provide databases of oral or visual histories at sites of old works or in front of old photographs and plans of the various sites. We aim to develop the skills of both the members of the Society and the students of UCLAN so any future interviewing project can be undertaken with ease.

By having the Heritage Centre at the core of the whole project, we can educate the younger generations as well as their older relatives with the displays mentioned above whilst the Society will be obtaining the Information from their parents and grandparents in respect of the oral history project. One of the Society's aims is to make history more relevant to the younger generation by showing them what used to be there, by photos, videos etc.
