Executive Summary

This report presents an application from a local organisation requesting £600 towards hair and beauty equipment and arts materials from the Deputy Leader of Lancashire County Council's Local Member Grant Budget for 2017/18.

Recommendation

The Deputy Leader of Lancashire County Council is requested to consider and approve the request for grant funding as set out in Appendix 'A' attached.

It should be noted that the outstanding amount being requested by organisations for grant applications comes to a combined total of £1,750. The total amount of funding available in County Councillor Atkinson's budget is £1,415.

Therefore the maximum amount of funds that can be approved for outstanding grant requests is £1,415.
