Sporting Challenge are a charity set up by a group of Parent/Carers who from 2008 have been providing sporting activities for around 50 people with learning disabilities in West Lancashire to keep them fit and healthy. These evening and weekend activities include Ten Pin Bowling, Aerobics, Computer Courses, Walks, Swimming and Boccia /Kurling at local Sports Centres. We provide Sessional Workers who will collect them from where they live because many live in rural areas where transport links are poor, then support the people whilst they are at the activities and return them home afterwards. £100 would pay for some of our varied sessions.

4.4 How will the money benefit people in the Councillor(s) division(s)?

Many people with a learning disability do not take part in any exercise activity because the family/carers who support them are not motivated or are unable to take them on such activities and they can't go on their own. They live in areas such as Tarleton, Banks, Scarisbrick, Newburgh, Rufford, Burscough, Parbold, Ormskirk, Bickerstaffe, Aughton, Skelmersdale and Up Holland. Our activities take place in Ormskirk, Skelmersdale, Burscough and Southport.

The regular physical activities and social contact improves peoples' health, mental and physical wellbeing leading to further opportunities as their confidence and independence skills grow.

The parent /carer will be also to be able to have a short break each week helping also to improve their quality of life and general well-being.

We also work with Local Statuary and Voluntary Bodies to ensure that we are helping to meet the needs of the community and feel that by providing these activities for people with learning disabilities we have really made a difference to their quality of life, health and wellbeing.

Funding will help towards the cost of our activities. Many of our beneficiaries live in rural areas where public transport is poor or even none existent, so it is important that we are able to provide transport to and from the activities. We are growing 6 new people have started attending this year already. Our sessions help people make new friends, learn new sports skills, take part in exercise and improve the quality of life of the adults and their families.

We support around 50 people in the West Lancashire area to access a variety of activities by providing transport to and from their homes and the appropriate sessional workers to support them whilst carrying out the activities.

This number is set to grow over the years to come We are working with Lancashire County Council to provide support/ sessions for adults transition aged (16-22) this can be a difficult time for the adults and their families. There is a lot of change and they can easily move from school/ college and not keep their friendships. We are currently seeing many new members joining of this age range.

This is the last year of this Local Member Grant scheme, we fully appreciate all the support the scheme has given us. If any councillor has any unused funding this year it would be a great help.


