

NOTICE OF PROPOSAL
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(PRESTON CITY CENTRE, PRESTON CITY)
(REVOCATION AND BUS LANES) ORDER 201*

NOTICE IS HEREBY GIVEN that Lancashire County Council propose to make the above Traffic Regulation Order under Sections 1, 2 and 4 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to:

1. Revoke "The Borough of Preston (Fishergate and Fishergate Hill) (Bus lanes and One way) Road Traffic Order 1993" in full;
2. Revoke the "Borough of Preston (Fishergate) (Prohibition and Restriction of Traffic) Order 1979" in full;
3. Revoke the "Preston Borough Council, Borough of Preston (Fishergate) (Bus Priority Lane) Order 1998" in full;
4. Revoke the "Lancashire County Council (Fishergate, Preston, Preston City) (Bus Gate and Bus only Street) Order 2017" in full;
5. Revoke the "Preston Borough Council, Borough of Preston (Church Street) (Bus Priority Lane) Order 1998" insofar as it relates to the whole of the First Schedule;

6. Introduce a Bus Gate in Fishergate (Eastbound carriageway only), Preston, from a point 13 metres east of its junction with Butler Street for a distance of 10 metres in an easterly direction;
7. Introduce a Bus Only Street, on any day between 11am and 6pm, in Fishergate, Preston, from its junction with Mount Street to its junction with Corporation Street;
8. Introduce a Bus Only Street, at all times, in Fishergate, Preston, from its junction with Glovers Court to its junction with Canon Street;
NB in accordance with section 3(2) of the Road Traffic Regulation Act 1984, the council is satisfied that it is requisite that the provisions of section 3(1) of the Act should not apply to the restriction referred to herein;
9. Introduce a Bus Lane on Fishergate Hill, Preston, on the north-east bound carriageway for its entire length, from its junction with Strand Road (A5072) to its junction with Butler Street.
