### Notice of Addition of 6th Form and Change of Age Range

Notice is given in accordance with section 19(3) of the Education and Inspections Act 2006 that the Governing Body of Moor Park Business & Enterprise School intends to make a prescribed alteration to Moor Park Business & Enterprise School (a Foundation School without a trust) Moor Park Avenue, Preston, PR1 6DT from 01 September 2013.

The Governing Body of Moor Park Business & Enterprise School propose to change the age range of the School from 11 -16 years to 11 - 19 years from 1st September 2013 by the addition of a sixth form to be established in the existing premises in collaboration through a soft governance federation with Ashton Community Science College, Community High School, Aldwych Drive, Ashton, Preston PR2 1SL.

The current capacity of the school is 540 and the proposed capacity with the sixth form will be 620. The current admission number for the school in Year 7 is 100 and the proposed admission number for Year 7 will remain at 100.

The proposed admission number for Year 7 is below the indicated admission number of 108. The proposed admission number for Year 12 in September 2013 will be 60. The proposed combined number of places in Years 12 and 13 (from September 2014) will be 120
