**Brief Summary**

This report presents an application from an organisation requesting £500 towards the cost of equipment for activities, hire of banks hub and their 20th anniversary celebrations, from the Champion for Older People budget.

**Recommendation**

That consideration be given to the request for grant funding as set out in this report.

**Detail**

The role of Champion was first established in 2002 and the county council currently has six Champions, whose role is to support the Leader and individual Cabinet Members within their remits.

The six county council Champions are as follows:

- Armed Forces and Veterans
- Disabled People
- Mental Health
- Older People
- Parishes
- Young People

For the financial year 2023/24, each Champion has been given an annual allocation of £10,000 for use at their discretion to finance their activities, to which any unspent

balance up to a maximum of £2,500 from the previous financial year could be added, giving a maximum budget of £12,500 in any one financial year. The Champion for Older People total budget is set out in the financial section of the report.
