ROAD TRAFFIC REGULATION ACT 1984 LANCASHIRE COUNTY COUNCIL (FAIRFIELD ROAD AREA, LANCASTER, LANCASTER CITY) (REVOCATION, PART REVOCATION PROHIBITION OF WAITING, RESTRICTION OF WAITING, DISABLED PARKING PLACES AND RESIDENTS PERMIT HOLDERS PARKING PLACES) ORDER 201*

The County Council of Lancashire ("the Council") in exercise of its powers under Sections 1, 2, 4, 45 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. Definitions and Interpretation

For all the purposes of this Order the following terms described in this Article shall have the meaning specified:

a) "disabled parking place "means an area comprised within the carriageway of a road, the boundary of which is:-

b) marked in accordance with the Traffic Signs Regulations and General Directions 2002 ("the regulations") and accompanied by a sign in accordance with the Regulations indicating the restrictions on the use of the parking place; and for which the restrictions on use are described in Article 6 of this Order

c)"disabled person's vehicle" means a vehicle displaying a disabled person's badge in the circumstances prescribed in Regulations 13, 14, 15 or 16 of The Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000.

d) "**disabled person's badge**" means the form and size of a badge shown in Part 1 of Schedule 2 of the Disabled Persons (Badges for Motor Vehicles) Regulations 1982 as amended by The Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000

e) "parking disc" means a device which:

- i) is 125 millimetres square and coloured blue, if issued on or after 1st April 2000, or orange if issued before that date;
- ii) has been issued by a local authority and has not ceased to be valid; and
- iii) is capable of showing the quarter hour period during which a period of waiting has begun.

f) Civil Enforcement Officer'' means a person authorised by or on behalf of Lancashire County Council in accordance with Section 76 of the Traffic Management Act 2004

g) "vehicle" means a motor vehicle, a passenger vehicle, a dual-purpose vehicle, a goods vehicle, a motorcycle or an invalid carriage or any other vehicle of any description whether drawn or propelled along a road by animal or mechanical power.

h) "Parking Permit" means a parking permit issued by the issuing authority authorising the parking of prescribed vehicles in any parking place designated for use by Zone J residents

i) A vehicle displays a resident's parking permit, disabled persons badge or parking disc in the **relevant position** if-

- I. The badge is exhibited on the dashboard or fascia of the vehicle, or
- II. Where the vehicle is not fitted with a dashboard or fascia, the badge is exhibited in a conspicuous position on the vehicle so that the front of the badge is clearly legible from outside the vehicle.

j) issuing authority" means the council or its local agent or authority

k) permit holder" means a person to whom a permit has been issued under the provisions contained within article 13 of this Order

I) "Resident's parking place" means any area on a highway described in Schedule 7 to this Order;

m) "**resident**" means a person whose place of abode is at premises where the postal address of which satisfies the eligibility criteria detailed in **Article 16** of this Order

2. <u>Revocation</u>

The Orders as specified in **Schedule 1** to this Order is hereby revoked in full.

3. Part Revocation

Those parts of the "Lancashire County Council (Lancaster City Area) (On Street Parking Places, Prohibition and Restriction of Waiting) Consolidation Order 2009" as specified in **Schedule 2** to this Order are hereby revoked.

4. Amendment

I. The City Council of Lancaster (Parking Permits and Charges) Order 2004 is hereby amended to include in Schedule 1 thereof, all references in schedule 3 of this Order.

II. The City Council of Lancaster (Parking Permits and Charges) Order 2004 is hereby amended to include in schedule 2 thereof, all references in schedule 4 of this Order.

5. No Waiting At Any Time

Save as is hereinafter provided no person shall, except upon the direction or with the permission of a police constable in uniform, or a civil enforcement officer, cause or permit any vehicle *to* wait, at any time, on any day, in any of the lengths of road specified in **Schedule 5** to this Order

6. Disabled Parking Places

Save as in hereinafter provided no person shall except upon the direction or with the permission of a police constable in uniform or a civil enforcement officer, cause or permit any vehicle to wait at any time on any day in the following lengths of road as specified in **Schedule 6** to this Order.

7. Permit holder Parking Places

Save as in hereinafter provided no person shall, except upon the direction or with the permission of a police constable in uniform or a civil enforcement officer, cause or permit any vehicle to wait at any time, on any day in the following lengths of road as Specified in **Schedule 7** to this Order.

8. Restriction of Waiting

- a. Save as is hereinafter provided no person shall, except upon the direction or with the permission of a police constable in uniform, or a civil enforcement officer, cause or permit any vehicle to wait, Monday to Saturday each day from 8am-6pm in any of the lengths of roads specified in **Schedule 8** to this Order;
- b. Save as is hereinafter provided no person shall, except upon the direction or with the permission of a police constable in uniform, or a civil enforcement officer, cause or permit any vehicle to wait for a period exceeding 4 hours No Return Within 4 Hours Mon-Sat 8am-6pm except Resident Permit Holders in any of the lengths of roads specified in Schedule 9 to this Order
- c. Save as in hereinafter provided no person shall, except upon the direction or with the permission of a police constable in uniform or a civil enforcement officer, cause or permit any vehicle to wait for a period exceeding 3 hours, no return within 6 hours, Mon-Sat 8am-6pm except Resident Permit Holders in the following lengths of road specified in **Schedule 10** to this Order
- d. Save as in hereinafter provided no person shall, except upon the direction or with the permission of a police constable in uniform or a civil enforcement officer, cause or permit any vehicle to wait for a period exceeding 1 hour no return within 2 hours Mon-Sat 8am 6pm except Resident Permit Holders in the following lengths of road as specified in Schedule 11 to this Order
- e. Save as in hereinafter provided no person shall, except upon the direction or with the permission of a police constable in uniform or a civil enforcement officer, cause or permit any vehicle to wait for a period exceeding 30 minutes no return within 1 hour in the following lengths of road as specified in **Schedule 12** to this Order
- f. Save as in hereinafter provided no person shall, except upon the direction or with the permission of a police constable in uniform or a civil enforcement officer, cause or permit any vehicle to wait for a period exceeding 2 hours no return within 4 hours Mon-Sat 8am 6pm except Resident Permit Holders in the following lengths of road as specified in Schedule 13 to this Order

9. Exemptions for disabled person's vehicle

- a. Nothing in **Article 5 or 8 a** of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of road referred to therein for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same lengths of roads on the same day) if the vehicle is a disabled person's vehicle which displays in the relevant position both a disabled person's badge and a parking disc marked to show the quarter hour period during which the period of waiting began.
- b. Nothing in **Articles 6, 8 (a) (b) (c) (d) (e)** or (f) of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of roads referred to therein if the vehicle is a disabled person's vehicle which displays in the relevant position both a disabled person's badge and a parking disc marked to show the quarter hour period during which the period of waiting began.

10. Exception for Resident Permit Holders

Nothing in Article 7 of this Order shall render it unlawful to cause or permit any vehicle to wait in the parking places referred to therein, if the vehicle displays a residents parking permit in respect of the parking place in which the vehicle has been left in accordance with Article 17 of this Order.

11. General Exceptions

Nothing in **Articles 5 6 7 and 8 a b c d e or f** of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of road referred to therein for so long as may be necessary to enable:-

- a) a person to board or alight from the vehicle;
- b) goods to be loaded on to or unloaded from the vehicle;
- c) the vehicle, if it cannot conveniently be used for such purpose in any other road to be used in connection with any of the following:
 - i) building, industrial or demolition operations;
 - ii) the removal of any obstruction to traffic;
 - iii) the maintenance, improvement or reconstruction of the said lengths of roads;
 - iv) the laying, erection, alteration or repair in, or in land adjacent to, the said lengths of road of any sewer or of any main, pipe or apparatus or the exercise of any other statutory power or duty for the maintenance and supply of gas, water or electricity or of any telecommunications system as defined in Section 4 of the Telecommunications Act 1984;
- d) the vehicle to be used for the purposes of a local authority in pursuance of statutory powers or duties if it cannot conveniently be used for such purpose in any other road.
- e) A Royal Mail liveried vehicle engaged in the collection and/or delivery of letters in accordance with the statutory provisions as defined in the Postal Services Act 2000
- f) the vehicle to be used for fire brigade, ambulance or police purposes in pursuance of statutory powers or duties;
- g) the vehicle to wait at or near to any premises situated on or adjacent to the said lengths of road for so long as such waiting by the vehicle is reasonably necessary in connection with any wedding or funeral.

12. Additional Exceptions

Nothing in **Articles 5 6 7 and 8 a b c d e** or f of this Order shall render it unlawful to cause or permit any vehicle to wait in the length of road referred to therein when the person in control of the vehicle

- a) Is required by law to stop
- b) Is obliged to stop in order to avoid an accident; or

c) Is prevented from proceeding along the road due to circumstances beyond his/her control.

13. Application For and Issue of Residents Parking Permits

- a) Any resident may apply to the issuing authority, for the issue of a permit to leave a vehicle within that area. Any such application shall be made on a form issued by and obtainable from the issuing authority and shall include the particulars and information required by such form to be supplied and shall be accompanied by a remittance for the appropriate fee (details of which are obtainable from the issuing authority in respect of the permit for which application is being made)
- b) The issuing authority may at any time require an applicant for a permit or a permit holder to produce to their duly authorised officer such evidence in respect of an application for a permit made to them as they may reasonably require to verity any particulars or information in respect of any permit issued as they may reasonable require to verify that the permit is valid.
- c) On receipt of an application made under the forgoing provisions of this Article and of the appropriate fee, the issuing authority, upon being satisfied that the applicant is a resident within the area specified in paragraph a) of this Article, shall issue to the applicants two residents parking permits for the leaving of vehicles during the permitted period in a parking place to which such permit relates, by the owner of such vehicles, or by any person using such vehicles with the consent of the owner other than a person to whom such vehicles has been let for hire or reward

14. Surrender, Withdrawal and Validity of Permits

- a) The permits shall only be valid from the date of issue to the date of expiry shown on the permit and only when displayed in vehicles waiting in the street(s) parking place or zone named on the permit
- b) A permit holder may surrender a permit to the issuing authority at any time and shall surrender a permit to them on occurrence of any of the events set out in paragraph d) of this Article
- c) The issuing authority may, by notice in writing served on the permit holder by sending the same by recorded delivery service to the permit holder at the address shown by that person on the application for the permit or at any other address believed to be that person's place of abode, withdraw a permit if it appears to them that any of the events set out in paragraph d) of this Article has occurred and the permit holder shall surrender the permit to them within 48 hours of the receipt of the aforementioned notice
- d) The events referred to in the foregoing provisions of this Article are:
 - i) The permit holder ceasing to be a resident
 - ii) The withdrawal of such permit by the issuing authority under the provisions of paragraph b) of this article;
 - iii) The vehicle in respect of which such permit was issued is issued for any unlawful purpose;
 - iv) The issue of a duplicate permit by the issuing authority under the provisions of **Article 19** of this Order;

- v) The permit ceasing to be valid pursuant to the provisions of paragraph e) of this Article
- e) Without prejudice to the foregoing provisions of this Article, a permit shall cease to be valid at the expiration of the period specified thereon (which period shall be that in respect of which payment has been made) or on the occurrence of any one of the events set out in paragraph d) i) ii) or iv) whichever is the earlier.
- f) Where a permit is issued to any person upon receipt of a cheque and the cheque is subsequently dishonored, the permit shall cease to be of any effect and the issuing authority shall by notice in writing served on the person to whom such permit was issued by sending the same by recorded delivery service to the permit holder at the address shown by that person on the application for the permit or at any other address believed to be that person's place of abode, require that person to surrender the permit to the issuing authority within 48 hours of the receipt of the aforementioned notice.

15. Form of Resident's Parking Permit

- a) A resident's parking permit shall include the following particulars:
 - i) The unique serial number of the permit that has been issued
 - ii) The area in which the permit is valid
 - iii) Subject to the provisions of **Article 14**, the date up until which the permit shall remain valid; and
 - iv) An indication that the permit has been issued by the issuing authority
- b) If the resident's parking permit is a vehicle specific permit as referred to in **article 1 k)** and **article 16** to this Order that permit shall also include the vehicle registration details for which the permit has been issued.

16. Eligibility Criteria and Charges for Permits

- a) All properties with an address in **Zone J**, **Lancaster**, **Lancaster City** are eligible to apply for a resident parking permit, subject to the applicant having not had a permit withdrawn from them in accordance with **article 14 c**)
- b) Each eligible property may purchase one vehicle specific parking permit and one general residents parking permit at a combined cost of **forty pounds (£40) per annum**

Provisions Relating to Residents Permits, Visitor Permits, Tradesmen's Permits and Carers Permits

- I. The provisions relating to the validity of Residents Permits, Visitor Permits, Tradesmen's Permits and Carers Permits for use in a parking space authorized by this Order shall be determined by reference to the Articles and Schedules of this Order and by reference to the ' City Council of Lancaster (Parking Permits and Charges) Order 2004 (the 2004 Order) as amended or substituted by any subsequent enactment.
- II. The provisions relating to the issue, the amount of charge, replacement and renewal of Residents Permits, Visitor Permits, Tradesmen's Permits and Carers permits shall also be determined by reference to the 2004 Order referred to in Article 16(I) above, as amended or substituted by any subsequent enactment.

• Display of Parking Permit

A Residents Parking Permit issued under the provisions of this Order shall be displayed in the vehicle in respect of which the Residents Parking Permit has been issued in a conspicuous position so that the date and time of issue are clearly visible to a person standing at the front or kerbside of such vehicle for the whole of the time during which the vehicle is left.

<u>Restriction on the Removal of Permits</u>

Where a permit has been displayed on a vehicle in accordance with the provisions of Article
 17 of the Order no person, not being the driver of the vehicle, shall remove the permit from the vehicle unless authorised to do so by the driver of the vehicle.

Damage to/loss of Permit

- If a permit is mutilated or accidentally defaced or the figures or particulars thereon have become illegible or the colour of the permit has become altered by fading or otherwise, the permit holder shall either surrender it to the issuing authority or apply to them for the issue of a duplicate permit so marked and upon such issue the original permit shall become invalid
- j) If the permit is lost or destroyed, the permit holder may apply to the issuing authority for the issue of a duplicate permit and they, upon being satisfied as to such loss or destruction shall issue a duplicate permit so marked and upon such issue the original permit shall become invalid
- k) The provisions of this Order shall apply to any duplicate permit or application for a duplicate permit

Manner of standing in a Parking Place

- i) The driver of a motor vehicle using a parking place shall stop the engine as soon as the vehicle is in position in the parking place and shall not start the engine except when about to change the position of the vehicle, or to depart from, the parking place.
- j) Every vehicle left in a parking place in accordance with the foregoing provisions of this Order shall be left so that every part of the vehicle is within the limits of the parking place.
- k) A driver of a vehicle shall not use a parking place so as unreasonably to prevent access to any premises adjoining a road or the use of a road by other persons or so as to be a nuisance.

<u>Alteration of position of a vehicle in a Parking Place</u>

Where any vehicle is left standing in a parking place in contravention of the provisions of **Article 19** of this Order, a police constable in uniform or a civil enforcement officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions.

• Removal of a Vehicle from a Parking Place

Where a police constable in uniform or a civil enforcement officer is of the opinion that any of the provisions contained in **Article 19** of this Order have been contravened or not complied with in respect of a vehicle left in a parking place, he/she may remove or cause to be removed

the vehicle from the said parking place, and where it is so removed, shall provide for the safe custody of the said vehicle.

• Movement of a Vehicle in a Parking Place in an Emergency

- i) A police constable in uniform or a civil enforcement officer may in case of emergency move or cause to be moved any vehicle left in a Parking Place to any place he thinks fit and shall provide for the safe custody of the vehicle.
- j) A person causing or permitting a vehicle to wait in a Parking Place by virtue of the provisions of paragraph a) of this Article shall take all such steps as are necessary to ensure that in the case of a Parking Place it shall stand in accordance with Article 19 so that every part of the vehicle is within the limits of the Parking Place.

Power to suspend use of Parking Places

- i) The Council's duly authorised officer may suspend the use of Parking Place or any part thereof whenever he/she considers such suspensions reasonably necessary and make such charge for the administration of this service, as may from time to time be determined by the Council.
- j) A police constable in uniform may suspend for not longer than 7 days the use of a Parking Place or any part thereof whenever he/she considers such suspension reasonably necessary for the purpose of mitigating congestion or obstruction of traffic or a danger to or from traffic in consequence of extraordinary circumstances.
- k) Any persons suspending the use of a Parking Place or any part thereof in accordance with the provisions of paragraphs a) or b) of this Article shall thereupon place or cause to be placed in or adjacent to any part of that Parking Place the use of which is suspended, a Traffic Sign or cone indicating that waiting by vehicles is prohibited, as specified by Schedule 12 Part II of the Traffic Signs Regulations and General Directions 2002.
- I) No person shall cause or permit a vehicle to be left in any part of a Parking Place during such period when a Traffic Sign or cone is placed in or adjacent to that part of the Parking Place pursuant to paragraph c) of this Article provided that this paragraph shall not apply to a vehicle:
 - i) being used by the respective Fire or Police Authority or Ambulance Health Trust to deal with an emergency; or
 - ii) being used for any purpose specified in Article 12; or
 - iii) left in such Parking Place with the permission of the person suspending the use of the Parking Place.

<u>Restrictions of use of a vehicle in a parking place</u>

While any vehicle is in a parking place, no person shall use the said vehicle in connection with the sale of any article to any person in or near the parking place or in connection with the selling of or offering for the sale of his/her skills or services.

<u>Effect of Contravention</u>

Failure by a person to comply with any prohibition or restriction contained within this Order shall constitute a contravention of the same and shall result in the issue by Lancashire County

Council and/or its Agents of a Penalty Charge Notice which shall be payable by such persons in accordance with legislation

<u>Miscellaneous</u>

The prohibitions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made, or having effect as if made, under the Act, or by or under any other enactment.

• Commencement of Order

This Order shall come into force on **day of***201* and may be cited as the "Lancashire County Council Lancaster City Area (Revocation, Part Revocation, Prohibition of Waiting, Restriction of Waiting, Disabled Parking Places and Resident Parking Places) Order 201*"

Statement of Reasons

Controls proposed for Zone J are designed to promote resident parking on the days and hours proposed. The main reason for proposing permit parking is to prioritise residents' parking and preserve residents' amenities in the streets where they live. Permit parking will also help reduce overall demand for parking and any associated unsafe or obstructive parking. The Council also proposes a number of yellow line waiting restrictions for safety and access reasons and disabled badge holder parking bays to compliment the permit parking proposals.

The council also proposes to provide long stay limited waiting bays on Sunnyside Lane and Wingate Saul Road to assist users of Fairfield Allotments. There are also proposals for short stay limited waiting bays on Sibsey Street and Sylvester Street to provide parking near to the businesses located within the zone
