ROAD TRAFFIC REGULATION ACT 1984

LANCASHIRE COUNTY COUNCIL

(BOCHOLT WAY, RAWTENSTALL AND BLACKBURN ROAD, HASLINGDEN, ROSSENDALE BOROUGH)

(REVOCATION AND RESTRICTED ROADS) ORDER 201*

The County Council of Lancashire, in exercise of its powers under Section 82 and 83(2) of and part 1V of schedule 9 of the Road Traffic Regulation Act 1984 as amended ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. Revocation

Revoke in full, schedule 2 of the "Lancashire County Council (Speed Limit Management) (various roads, Rossendale) (Revocation, 30, 40 and 50 mph Speed Limit) (No1) Order 2011" insofar as it relates to the following lengths of roads:

- 1. Bocholt Way, Rawtenstall, from its junction with Bury Road to its junction with Bacup Road for a distance of approximately of 900 metres.
- 2. Blackburn Road, Haslingden, from a point 27 metres north of its junction with Brook Street in a northerly direction to a point 227 metres south of its junction with Oak Avenue incorporating the roundabout at the junction of the A56.

2. Restricted Road (30mph Speed Limit will apply)

The lengths of roads specified in Schedule 1 to this Order shall become Restricted Roads (as defined in section 82 of the Road Traffic Regulation Act 1984), and no persons shall drive any motor vehicle at a speed exceeding 30 miles per hour.

3. Exemption

No Speed Limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.

4. Commencement of Order

This Order may be cited as the "Lancashire County Council (Bocholt Way, Rawtenstall And Blackburn Road, Haslingden, Rossendale Borough) (Revocation And Restricted Roads) Order 201*" and shall come into force on the **** *****, 201*.

Introduce a Restricted Road (30 mph speed limit will apply) on the following lengths of roads:

- 1. Bocholt Way, Rawtenstall, from its junction with Bury Road to its junction with Bacup Road, a distance of approximately of 900 metres.
- 2. Blackburn Road, Haslingden, from a point 27 metres north of its junction with Brook Street in a northerly direction to a point 227 metres south east of its junction with Oak Avenue incorporating the roundabout at the junction of the A56.
