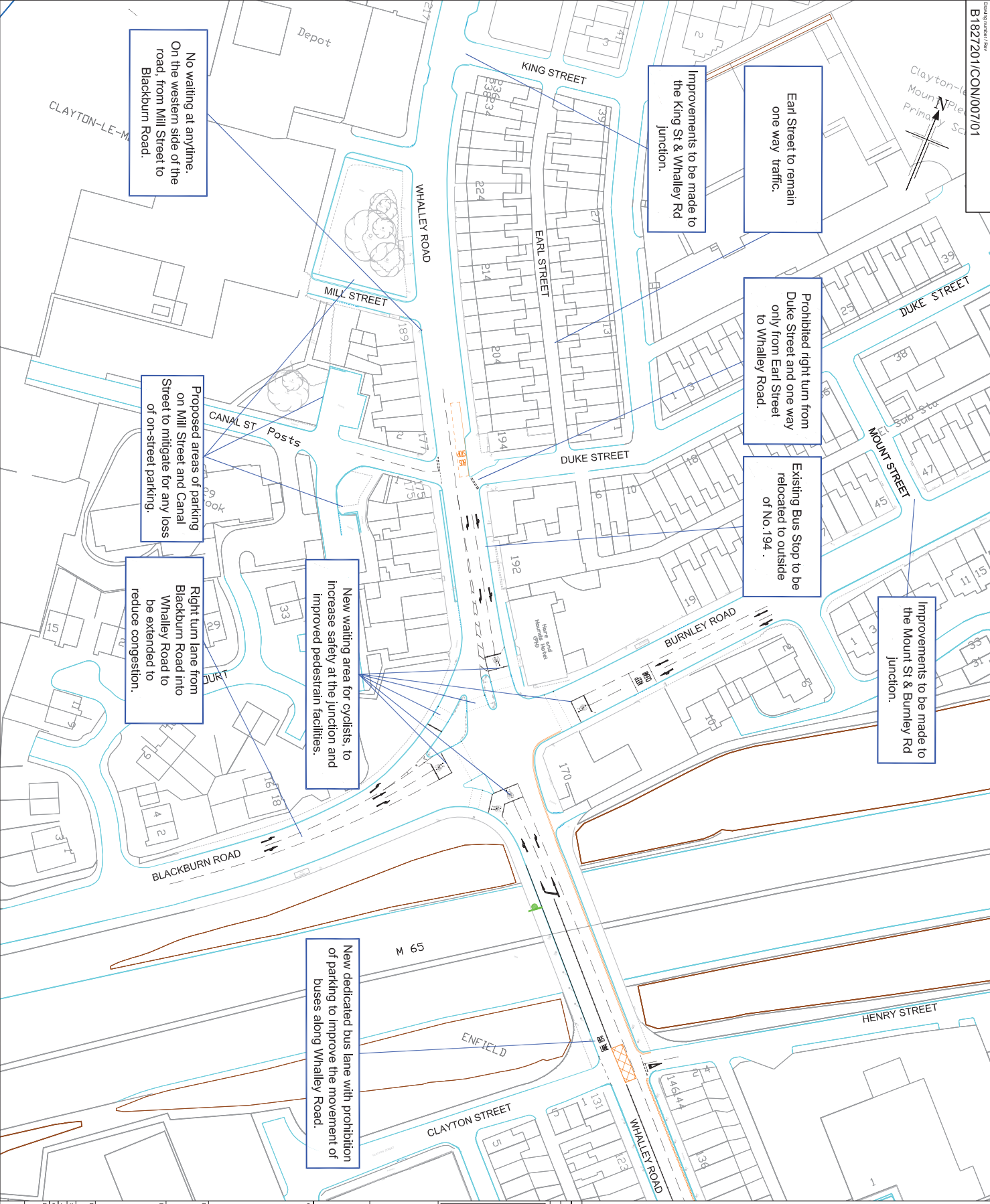

No waiting at anytime. On the western side of the road, from Mill Street to Blackburn Road.

Improvements to be made to the King St & Whalley Rd junction.

Earl Street to remain one way traffic.

Prohibited right turn from Duke Street and one way to Whalley Road.

Existing Bus Stop to be relocated to outside of No. 194.

Improvements to be made to the Mount St & Burnley Rd junction.

Proposed areas of parking on Mill Street and Canal Street to mitigate for any loss of on-street parking.

Right turn lane from Blackburn Road into Whalley Road to be extended to reduce congestion.

New waiting area for cyclists, to increase safety at the junction and improved pedestrian facilities.

New dedicated bus lane with prohibition of parking to improve the movement of buses along Whalley Road.
