

NOTICE OF PROPOSAL
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(GREAVESTOWN LANE, LARCHES LANE, WHINFIELD LANE,
PRESTON, PRESTON CITY)(ESTABLISHMENT OF A ROAD
JUNCTION TABLE AND SPEED CUSHIONS)



NOTICE IS HEREBY GIVEN that Lancashire County Council propose to make the above Traffic Regulation Order under Section 90A of the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to:

- 1) Introduce a 27m long Junction Table on Larches Lane at its junction with Larches Avenue.
- 2) Introduce Speed Cushions on the following lengths of road:
 - (a) Greaves Town Lane:
 - (i) 60 metres south from the Centreline of Blackpool Road.
 - (ii) 39 metres north from the Centreline of Westerlong.
 - (b) Larches Lane:
 - (i) 24 metres west from the Centreline of Preesall Road.
 - (ii) 8 metres west from the Centreline of Thistleton Road.
 - (iii) 9 metres east from the Centreline of The Woodlands.
 - (iv) 10 metres west from the Centreline of Westleigh Road.
 - (c) Whinfield Lane:
 - (i) 56 metres west from the Centreline of Whinfield Place.
 - (ii) 83 metres east from the Centreline of Whinfield Place.
 - (iii) 27 metres west from the Centreline of Pedders Lane.

The junction table and speed cushions will have a maximum height not exceeding 65 millimetres with approach and exit ramps not exceeding 1:15. The Speed Cushions will have a total length of 3.5 metres.

Statement of Reasons

To reduce vehicle speeds which will give drivers more time to react and reduce the frequency and severity of collisions.
