


NOTICE OF PROPOSAL
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(GARSTANG ROAD, PRESTON, PRESTON CITY) (BUS LANE AND
WEIGHT RESTRICTION) ORDER 201*

NOTICE IS HEREBY GIVEN that Lancashire County Council propose to make the above Traffic Regulation Order under Sections 1, 2 and 4 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to:


- 1) Introduce a 7.5 tonne weight limit except for access and public service vehicles in the following lengths of road:
 - a. Garstang Road, Preston, from its southerly junction with the A6 Broughton Bypass circulatory carriageway of the roundabout, in a northerly direction to a point 16 metres south east of the centreline with Whittingham Lane (B5269);
 - b. Garstang Road, Preston, between points 16 metres and 421 metres north west of its centreline with Whittingham Lane (B5269).
- 2) Introduce a bus only lane in Garstang Road, Preston, from a point 105 metres south east of the centreline of Church Lane, southbound on the more southerly slip road, to its junction with the A6 Broughton Bypass.


Broughton Village Corridor
