

STATEMENT OF REASONS

Chorley

(Rivington Lane, Rivington)

"The introduction of a 40 mph speed restriction on Rivington Lane, Rivington is to reduce vehicle speed on the approach to the existing 30 mph section and school location."

Fylde

(Ballam Road, Westby-with-Plumpton – Peel Road, Westby-with-Plumpton)

"The purpose of this proposed order is to reduce the potential for accidents and increase journey safety for all road users."

Fylde

(Mythop Road, Weeton)

"The purpose of this proposed order is to confirm, clarify, and tidy up a selections of traffic orders that have been identified in the Fylde area."

Hyndburn

(A679, Burnley Road, Accrington – B6535, Lee Lane, Rishton – B6535, Harwood Road, Rishton)

"The purpose of this proposed order is to confirm, clarify, and tidy up a selections of traffic orders that have been identified in the Hyndburn area.
