14. To consider Notices of Motion Submitted under Standing Order B36

1. It was moved by County Councillor Samara Barnes and seconded by County Councillor Anna Hindle that:

This council notes:

That we are seeing a crisis of food poverty born out of the political choices and systemic failings created over the past four decades, which have now reached a tipping point for so many in our communities. The figures are devastating for one of the richest nations in the world and highlight the inequality of the UK in 2022.

Need for food banks is already at a record high. Food banks in the Trussell Trust network gave out 2.1 million emergency food parcels between April 2021 and March 2022, a 14% rise on the year 2019/20. This comes on top of year-on-year increases in need. With inflation at a record high and the worst cost of living crisis in living memory the pressures on many families will be unbearable across Lancashire. The cost of living crisis will lead to a massive increase in child poverty across Lancashire. Recycling Lives, a charity that works across Lancashire and Cumbria, has gone from delivering 4,000 trays of food per week during lockdown to 6,500 now. In West Lancashire alone, 4,580 households experience food insecurity, with over 2,000 children under 16 living in food insecure households. Food banks in Chorley and East Lancashire are reporting increases in demand from 30% to 50%, whilst donations are down by as much as 80%, and it's the same picture across the whole County.

We also note the Government's National Food Strategy which reported in July 2021 and was the first independent review of England's entire food system for 75 years, and its subsequent response. The 'Right to Food' campaign believes that the 11 million people currently living in food poverty must be central to the response from Government.

This council further believes:

Enshrining the 'Right to Food' into law would clarify Government obligations on food poverty and would introduce legal avenues to hold Government bodies accountable for violations.



This council resolves:

- (i) To call for the Right to Food to be incorporated in the Government's White Paper in response to the National Food Strategy. We ask the Chief Executive to write to the Prime Minister to further this request.
- (ii) To formally declare as a Right to Food Council and join with other councils across the country to continue to push for a Right to Food enshrined in law.
- (iii) To appoint a food security champion for Lancashire County Council.

The following Amendment was proposed by County Councillor Michael Green and seconded by County Councillor Sue Whittam:

This council notes:

That the cost of food has real consequences for people across Lancashire and that the broader affordability of food, and individuals' access to food, is an important key element of the government's approach to tackling poverty, as we learn to live with recent events and manage the impact of cost-of-living pressures.

Food banks in the Trussell Trust network gave out 2.1 million emergency food parcels between April 2021 and March 2022, a 14% rise on the year 2019/20. This comes on top of year-on-year increases in need. With inflation approaching 10% in the latest ONS figures (still significantly below their peak of around 24% in August 1975) and the worst cost of living pressures in living memory.

Recent interventions by government have reduced the pressures on many families across Lancashire. This support is to be welcomed, without which, the cost of living pressures could have led to increases in child poverty across Lancashire.

Recycling Lives, a charity that works across Lancashire and Cumbria, has gone from delivering 4,000 trays of food per week during lockdown to 6,500 now. In West Lancashire alone, 4,580 households experience food insecurity, with over 2,000 children under 16 living in food insecure households. Food banks in Chorley and East Lancashire are reporting increases in demand from 30% to 50%, whilst donations are down by as much as 80%, and it's the same picture across the whole County.

The Independent Review titled 'National Food Strategy' led by Henry Dimbleby, and supported by an Advisory Panel of experts from across the food system with extensive experience of the issues, reported in July 2021 and was the first independent review of England's entire food system for 75 years.

The subsequent response by government was published in the White Paper 'Government Food Strategy' in June 2022.

This council further believes:

That this strategy clearly sets out the government's ambitions and priorities to create a more prosperous agri-food sector that delivers healthier, more home-grown and



affordable diets for all, regardless of where people live or their income, and importantly that this strategy is the only the beginning of this conversation.

This council resolves:

- (i) To ask the Chief Executive to write to Henry Dimbleby to thank him and the members of the Advisory Panel for their contributions to the Independent Report 'National Food Strategy'.
- (ii) To increase the funding available from Lancashire County Council's 'Community Food Grant Scheme' to £250,000 for the year 2022/23.
- (iii) To request that Lancashire County Council's Health and Adult Services Scrutiny Committee reviews the effectiveness of the 'Community Food Grant Scheme'.

Following a brief adjournment, the Notice of Motion was withdrawn.

2. It was moved by County Councillor Julie Gibson and seconded by County Councillor John Fillis that:

This Council notes the recent decision of the Department for Transport to reject the latest bid for infrastructure funding for Skelmersdale Railway Station.

This Council further notes the long-term cross-party support for this project alongside West Lancashire Borough Council and West Lancashire MP, Rosie Cooper.

This Council believes that a new railway station in the heart of Skelmersdale linking with both Liverpool and Manchester would open-up a world of opportunities for Skelmersdale residents to access wider education, training, employment and social opportunities and that inward investment would be drawn to the new town centre benefitting the whole of the West Lancashire and wider Lancashire economy.

This council also believes that government support for the Skelmersdale Railway Station project would be a significant indicator of the government's 'levelling up' agenda and that the campaign for a Station must continue. It rejects the Department for Transport's statement that this project is 'poor value for money' - a direct contradiction to the principle of levelling up.

This Council resolves to ask the Chief Executive to write to the Secretary of State for Transport, the Secretary of State for Levelling Up, Housing and Communities and the Prime Minister to ask them to honour their 2019 commitment to funding Skelmersdale Railway Station.

Notice was given by County Councillor Charles Edwards of an amendment at which point County Councillor Julie Gibson requested that her Notice of Motion be withdrawn.

3. It was moved by County Councillor Steve Holgate and seconded by County Councillor Jackie Oakes that:

Lancashire County Council recognises most junior schools in Lancashire have formed eco or green councils made up of pupils from across the age range to help



ensure they are doing all in their power to initiate projects to help reduce their carbon footprint and promote biodiversity both at school, traveling to and from school, and at home.

Many schools are now looking at ways in which they can help towards hitting the Government target of providing over 300,000 Electric Vehicle charger units across the country by 2030.

To this end:

- (i) Lancashire County Council commits to identifying ways it can support every school in Lancashire that indicates a wish to provide single or multiple Electric Vehicle charger points on school premises, for the use of both staff and visitors alike.
- (ii) Lancashire County Council will provide a single point of contact to co-ordinate and support this objective and let it be known this service and support is available.
- (iii) Lancashire County Council is delighted with the many environmental initiatives, of which this is just one being promoted and led by young people across Lancashire and will write to every school governing body setting out the support available.
- (iv) Lancashire County Council's electrical vehicle strategy will include a section working and supporting schools.

The following friendly Amendment was proposed by County Councillor Shaun Turner in accordance with Standing Order B42:

Lancashire County Council recognises junior schools in Lancashire have formed eco or green councils made up of pupils from across the age range to help ensure they are doing all in their power to initiate projects to help reduce their carbon footprint and promote biodiversity both at school, traveling to and from school, and at home.

Many schools are now looking at ways in which they can help towards hitting the Government target of providing over 300,000 Electric Vehicle charger units across the country by 2030.

To this end:

- (i) Lancashire County Council commits to identifying ways it can support every school in Lancashire that indicates a wish to provide single or multiple Electric Vehicle charger points on school premises, for the use of both staff and visitors alike.
- (ii) Lancashire County Council will regularly update schools and signpost them towards available support such as government grants and advise on any changes to EV charging infrastructure policy.
- (iii) Lancashire County Council is delighted with the many environmental initiatives, of which this is just one being promoted and led by young people across Lancashire and will support these wherever it can.



(iv) Lancashire County Council's electrical vehicle strategy will outline how it intends to work with all our partners, including schools, when it is published by the end of the year.

The friendly Amendment was accepted by County Councillor Holgate and became the substantive Motion.

The substantive Motion, as amended by County Councillor Turner's friendly Amendment, was then put to the vote and was CARRIED. It was therefore:

Resolved: - That:

Lancashire County Council recognises junior schools in Lancashire have formed eco or green councils made up of pupils from across the age range to help ensure they are doing all in their power to initiate projects to help reduce their carbon footprint and promote biodiversity both at school, traveling to and from school, and at home.

Many schools are now looking at ways in which they can help towards hitting the Government target of providing over 300,000 Electric Vehicle charger units across the country by 2030.

To this end:

- (i) Lancashire County Council commits to identifying ways it can support every school in Lancashire that indicates a wish to provide single or multiple Electric Vehicle charger points on school premises, for the use of both staff and visitors alike.
- (ii) Lancashire County Council will regularly update schools and signpost them towards available support such as government grants and advise on any changes to EV charging infrastructure policy.
- (iii) Lancashire County Council is delighted with the many environmental initiatives, of which this is just one being promoted and led by young people across Lancashire and will support these wherever it can.
- (iv) Lancashire County Council's electrical vehicle strategy will outline how it intends to work with all our partners, including schools, when it is published by the end of the year.

At the invitation of the Chairman, and prior to County Councillor Dowding moving the Motion, the Monitoring Officer provided Full Council with legal advice in relation to the subject matter.

4. It was moved by County Councillor Gina Dowding and seconded by County Councillor Andy Fewings that:

This Council notes:

(i) That the Government introduced a moratorium on fracking on 2 November 2019 due to evidence of the relationship between hydraulic shale gas fracturing ("Fracking") and seismic events in Lancashire.



- (ii) The moratorium was hugely welcomed by large numbers of people of Lancashire following years of disruption including not only earthquakes, but noise, traffic, and distress caused by the risks to health and environment associated with the Fracking industry as it tried to set up in Lancashire.
- (iii) The lack of support for Fracking by local communities in Lancashire.
- (iv) That the new Prime Minister has lifted the ban on Fracking but has said resumption of fracking in England would also be dependent on "where there is local support for it".
- (v) That Lancashire County Council has committed to pursuing measures to combat the climate emergency.

Therefore, Lancashire County Council:

- (i) Resolves to follow examples of good practice in climate policy in its review of the Lancashire Minerals and Waste Plan due for review this autumn. The Plan will, subject to statutory obligations, advice and guidance, and to agreement with Blackpool and Blackburn with Darwen, include a commitment that any application to extract hydrocarbons would have to fully reflect the "net zero impact on climate change" objective, in line with commitments the Government made in the 2008 Climate Change Act and as signatories to the Paris Climate Agreement.
- (ii) Asks the government to engage with Lancashire and other local authorities as soon as possible to clarify the criteria for determining "local support".

The following Amendment was proposed by County Councillor Aidy Riggott and seconded by County Councillor John Singleton:

This Council notes:

- (i) That the Government introduced a moratorium on fracking on 2 November 2019 due to evidence of the relationship between hydraulic shale gas fracturing ("Fracking") and seismic events in Lancashire.
- (ii) The moratorium was welcomed by people in Lancashire following years of disruption to the lives of local residents and a significant burden on the public purse as a result.
- (iii) That consent for Fracking by local communities in Lancashire, has yet to be tested and determined, following the recent lifting of the moratorium on shale gas extraction.
- (iv) That the new Prime Minister has lifted the ban on Fracking but has said the government would "only press ahead with fracking in areas where there is local community support".
- (v) That Lancashire County Council has committed to pursuing measures to combat climate change.

Therefore, Lancashire County Council resolves:



- (i) To follow examples of good practice in its review of the Lancashire Minerals and Waste Plan. The Plan will, be subject to statutory obligations, advice and guidance, and to agreement with Blackpool and Blackburn with Darwen.

The following friendly Amendment was proposed by County Councillor Azhar Ali in accordance with Standing Order B42: Add point (iii) as follows:

"Asks the Government to commit to decision-making on fracking to remain solely with locally elected councillors in the local strategic planning authority".

The friendly Amendment was accepted by County Councillor Dowding and became the substantive Motion.

Following a brief adjournment, and legal advice, it was agreed that the word 'strategic' be removed from County Councillor Ali's friendly Amendment. The Chief Executive and Monitoring Officer clarified for Full Council that Lancashire County Council was the local planning authority with responsibility for the approval of the Lancashire Minerals and Waste Plan.

The substantive Motion, as amended by County Councillor Riggott's friendly Amendment together with County Councillor Ali's friendly Amendment, with the deletion of the word 'strategic', was then put to the vote and was CARRIED. It was therefore:

Resolved: - That:

This Council notes:

- (i) That the Government introduced a moratorium on fracking on 2 November 2019 due to evidence of the relationship between hydraulic shale gas fracturing ("Fracking") and seismic events in Lancashire.

Brief Summary

This report sets out the recommendation of the Independent Remuneration Panel in relation to the council's Members' Allowance Scheme for 2022/23, following an informal meeting of the Panel on 22 November 2022 and subsequent written confirmation of the Panel's recommendation.

Recommendation

Full Council is asked to:

- (i) Consider the recommendation of the Independent Remuneration Panel, as set out in the report and at Appendix 'A', relating to the county council's Members' Allowance Scheme; and
- (ii) Subject to (i) above, approve the revised Members' Allowance Scheme for 2022/23 and authorise the Director of Corporate Services to make any consequential changes to the Constitution.

Detail

The county council is required to establish an Independent Remuneration Panel and have regard to its recommendations before any changes are made to its Members'

Allowance Scheme. The county council is also required to approve its Members' Allowance Scheme before the beginning of each financial year.

The Members' Allowance Scheme sets out that:

"The amounts specified in paragraphs 1.0, 2.0, 3.0 and 5.0 (Basic Allowance, Special Responsibility Allowance, Dependants' Carers' Allowance and the Council's Chairman/Vice-Chairman Allowance respectively) of Schedule 'A' are subject to an annual uprating on 1 April. This uprating shall equate to the average annual percentage increase in employees' pay under the National Joint Council for Local Government Services pay structure"

The 2022/23 Members' Allowance Scheme was approved by Full Council at its meeting on 24 February 2022, although at that time the staff pay award had not been finalised.

The staff pay award has now been agreed. However, whilst in most years the pay increase for staff is expressed as a percentage, for 2022/23 a flat rate increase has been agreed for all staff of £1,925, regardless of their current grade or salary. The offer also includes a permanent extra day's leave per year for all staff from 1 April 2023, and an uprating of 4.04% on allowances (such as travel, accommodation, overtime etc).

As the main increase has not been expressed as a percentage, it was necessary to convene a meeting of the Independent Remuneration Panel to consider what the appropriate increase for councillors would be. This meeting was held on 22 November 2022. The meeting was inquorate and thus the Panel's recommendations were confirmed in writing by all Panel members after the meeting.

The following information was presented to the Panel to assist its review of the Scheme:

- A copy of the existing Members' Allowance Scheme for 2022/23;
- A basic comparison of allowances paid to elected members of Lancashire County Council and those paid to elected members of other, similarly sized county councils, including neighbouring Cumbria County Council;
- The information and advice of officers on possible increases to councillors' allowances and the financial context.

Having considered the information presented, the Panel recommended to Full Council that the Basic, Special Responsibility, Dependents' Carers', and Chairman/Vice Chairman Allowances be increased by 4.04% for 2022/23, with effect from 1 April 2022.

Full Council will note that uprating the Basic Allowance, Special Responsibility Allowances, Dependents' Carers' Allowance, and the Chairman/Vice Chairman Allowance by 4.04% as recommended by the Panel would increase the total



members' allowance budget by £60,000. Details of the recommended changes to members' allowances are set out at Appendix 'A'.

Full Council is asked to consider the recommendation of the Independent Remuneration Panel as set out above and approve any changes to the Members' Allowance Scheme for 2022/23. Any changes approved will be backdated to 1 April 2022.

Appointment of New Employer and Member Representatives on the Lancashire Local Pension Board

Brief Summary

This report relates to the appointment of new employer and scheme member representatives on the Lancashire Local Pension Board.

Recommendations

That Full Council approves:

- (i) The appointment of the two new employer representatives and two new scheme member representatives on the Lancashire Local Pension Board, and the length of the terms, as set out in the report.
- (ii) That if the appointments referred to at (i) above are approved, all new Board members are bound by the county council's Code of Conduct with immediate effect.

Detail

The Terms of Reference for the Local Pension Board state that the Board shall consist of nine members on the basis of an independent Chair, four Scheme member representatives (drawn from the membership of the Fund) and four employer representatives, comprising of:

- Two nominated by Lancashire County Council.
- One nominated by the Unitary, City, and Borough Councils and the Police/Fire bodies.
- One nominated following consultation with the other employers within the Fund.

During the first half of 2023 the 4 Local Pension Board members listed below come to the end of their 8-year terms of appointment.

- Steve Thompson Employer representative Unitary, City, and Borough Councils and the Police/Fire bodies
- Kathryn Haigh Member Representative
- Yvonne Moult Member Representative
- Carl Gibson Employer representative other employers within the Fund

Fund officers have undertaken a recruitment exercise to ensure that new members are recruited in advance of the four listed members leaving their posts.

At the July 2022 Local Pension Board meeting, a report was considered which set out the process for appointing new Employer and Scheme Member representatives to fill the four positions on the Board, when they became vacant.

The report outlined some key drivers around the planning for recruitment which included the staggering of the new appointments as set out below to reduce the risk of several Board members reaching the end of their term of appointment at, or around, the same time in the future.

- Two of the new appointments will be of 2 years initial duration plus a 4-year extension option.
- The other two appointments will be of 4 years initial duration plus a 4-year extension option.

The roles were subsequently advertised through the relevant channels and upon receipt of the applications, the Head of Fund undertook a shortlisting exercise with the Chair of the Local Pension Board.

Due to the number of applications received it was necessary to undertake an interview exercise which was conducted by a panel comprising of the Chair of the Local Pension Board, two Local Pension Board members and an officer of the Fund.

Following these interviews, the four candidates below were identified as having the necessary skills and knowledge to fulfil the role and have provisionally been offered the positions, subject to approval by Full Council:

• Employer Representative – Unitary, City, and Borough Councils and the Police/Fire bodies - Tony Wilkinson (Lancashire Constabulary) to be appointed for 4 years with effect from 1 January 2023 with an option to extend the term by a further 4 years.



- Employer Representative other employers in the Fund Stephen Dunstan (Blackpool Coastal Housing) to be appointed for 2 years with effect from 1 April 2023 with an option to extend the term by a further 4 years.
- Scheme Member Representative Gayna Hart to be appointed for 4 years with effect from 1 May 2023 with an option to extend the term by a further 4 years.
- Scheme Member Representative Shima Maka to be appointed for 2 years with effect from 1 May 2023 with an option to extend the term by a further 4 years.

The proposed appointments were reported to and noted by the Pension Fund Committee on 25 November 2022.

Should the appointments be approved by Full Council the new Board members will be bound by the county council's Code of Conduct with immediate effect to enable them to receive agenda (part I and part II reports) and, where possible, attend a meeting of the Pension Board as an observer prior to formally taking up their roles as Board members.

Any extension to the initial term of appointment will be referred to Full Council for approval.

The term of office will come to an end for the new representatives if:

Employer Representatives:

- Ceases to be employed by their current employer.
- Is appointed to a role with responsibility for the management or administration of the Fund.
- Has a conflict of interest which cannot be managed in accordance with the Conflict of Interests Policy.
- Fails to attend meetings, undertake any training, or otherwise comply with the requirements of being a member of the Pension Board.

Scheme Member Representatives:

- Ceases to be a member of the Lancashire Local Government Pension Scheme.
- Is appointed to a role with responsibility for the management or administration of the Fund.
- Has a conflict of interest which cannot be managed in accordance with the Conflict of Interests Policy.
- Fails to attend meetings, undertake any training, or otherwise comply with the requirements of being a member of the Pension Board.

With the exception of the Independent Chair of the Local Pension Board, members do not receive a salary but are able to claim expenses in accordance with the Terms of Reference of the Board.

Local Government Reform Cumbria Pension Arrangements

Brief Summary

It is proposed that that Lancashire County Council agrees to the Westmoreland and Furness Council delegating its pension fund administration function to Lancashire County Council pursuant to section 101 of the Local Government Act 1972.

Local government reorganisation in the Cumbria County Council area takes effect in April 2023. Lancashire County Council currently discharges the pension administration functions of Cumbria County Council, which in turn are delivered by Local Pension Partnership Administration Limited. The reorganisation requires that revised discharge of functions agreements are made with Westmoreland and Furness Council, to replace the existing agreement with Cumbria County Council.

Recommendation

Full Council is asked:

- (i) To approve the delegation of the pension fund administration function of Westmoreland and Furness Council to Lancashire County Council pursuant to section 101 of the Local Government Act 1972 subject to the council entering into appropriate legal agreements with the parties.
- (ii) That the Director of Corporate Services be authorised to agree the final legal agreements on behalf of Lancashire County Council.

Detail

Local government reorganisation is due to fully take effect within Cumbria from 1 April 2023 and will have implications for pension administration arrangements.

Current Position

Lancashire County Council provides pension administration services to other local authorities by way of a formal delegation of powers pursuant to section 101 of the Local Government Act 1972. Pension administration services have been provided by the administration arm of the Local Pensions Partnership Limited (LPPL), a company owned by Lancashire County Council and the London Pensions Fund Authority since 2016. Pension administration services are delivered by the administration subsidiary company of LPPL, Local Pensions Partnership Administration Limited (LPPA).

A delegation is currently in place between Lancashire County Council and Cumbria County Council, which passes its agreed budget for pension administration services to Lancashire County Council which in turn instructs LPPA to deliver the services with the funding being passed through to LPPA. The arrangement, whilst not being of a commercial nature, is governed by a formal written agreement involving Cumbria County Council, LPPA and Lancashire County Council.

The delegation covers Cumbria Local Government Pension Scheme and the Cumbria Fire and Rescue Services.

Reorganisation

The six district Councils within the Cumbria region and Cumbria County Council will transition to two new unitary authorities – Cumberland Council and Westmoreland and Furness Council – with effect from 1 April 2023. The new unitary authorities will provide Council services for their areas.

The decision has been made to keep one Local Government Pension Fund - Cumbria Local Government Pension Scheme - and the new administering authority will be Westmoreland and Furness Council. Whilst Cumbria Local Government Pension Scheme does not wish to dissolve the discharge arrangement, the nature of the local government reorganisation process in Cumbria is such that Cumbria County Council will cease to exist at midnight on 31 March 2023. This will effectively result in the dissolution of the arrangement at midnight on 31 March 2023. This reorganisation requires that a replacement delegation is set up with Westmoreland and Furness Council.

The replacement delegation will not continue to cover administration for the Cumbria Fire and Rescue Service. This is because the Cumbria Fire and Rescue Service is moving to sit under the Cumbria Police and Crime Commissioner – rather than under Cumbria County Council – and the Cumbria Police and Crime Commissioner is looking into entering into a delegation arrangement.

Officers of Lancashire County Council are liaising with Westmoreland and Furness Council on the appropriate legal agreements that will be required to implement these arrangements.



Consultations

Cumbria County Council LPPA

Implications:

Risk management

The impact of this reorganisation is limited to a change in administering authority of the Cumbria Local Government Pension Scheme and it will not impact on the scope of services provided by LPPA and pension administration service costs. Whilst there is some scope for errors to be made by LPPL which could lead to losses, this has been addressed in the agreement between Lancashire County Council, LPPA and the customer authority. LPPA will indemnify Lancashire County Council so that the risk to Lancashire County Council is minimal.

Legal

Both parties are able to enter into this arrangement pursuant to the powers available to them under Sections 101 and 102 of the Local Government Act 1972 and the Local Government Act 2000.

Legal Services is currently in the process of reviewing and agreeing the necessary legal agreements with Cumbria County Council.

Lancashire County Council and LPPL are also currently engaged in a wider piece of work, reviewing the provision of pension administration services by LPPL under agreements between the parties. This review is likely to take some time but does not affect the delegation recommended in this report.

Financial

It is expected that there will be no financial impact for Lancashire County Council as, in practice, LPPA operates on a cost basis. As part of the annual budget setting process, LPPA estimates costs to be incurred in operating the business and these costs are pro-rated to each Pension Fund client. A monthly payment is then made by each client to LPPA to cover the pro-rated costs. At the end of the year, a 'true up' payment may be requested from each client in the event that actual costs exceed budgeted costs.

Delivering Cost of Living Support in Lancashire

Cabinet considered a report setting out the county council's intentions in relation to delivering cost of living support in Lancashire.

Resolved: That

- i. The Director of Public Health be authorised, in consultation with the relevant Cabinet Members and officers, to implement the initiatives as set out in the report, including entering into contractual arrangements as appropriate;
- ii. All County Councillors be provided with an information sheet containing contact details for all targeted advice and support initiatives as set out in the Delivering Cost of Living Support in Lancashire report;

Bus Stop Clearway, Lyndhurst Road, Burnley

Cabinet considered a report to relocate two bus stops and associated clearway on Lyndhurst Road, Burnley. The report summarised the results of the public consultation and it was noted that objections had been received.

Resolved: That the merging and relocation of 2 existing bus stops on Lyndhurst Road, Burnley, to a new location outside numbers 40 to 54 Lyndhurst Road, as shown on the plan attached at Appendix 'A' of the report, be approved.

Review of Charging for Attachments to Lighting Columns



REPORT OF THE LANCASHIRE COMBINED FIRE AUTHORITY (CFA) HELD 3 OCTOBER 2022

HIS MAJESTY'S INSPECTORATE OF CONSTABULARY AND FIRE AND RESCUE SERVICES – INSPECTION REPORT

The Authority received a report that detailed the inspection of the Service which concluded on 24 January 2022 by His Majesty's Inspectorate of Constabulary and Fire & Rescue Services (formerly Her Late Majesty's Inspectorate).

It was noted that while some Fire and Rescue Services had improved in some areas, most services had lost gradings due to the inspection being more detailed. Furthermore, where gradings had remained the same this demonstrated that an improvement had been made.

The Chairman drew Members' attention to a statement from Matt Parr, His Majesty's Inspector of Fire and Rescue Services who said:

"I congratulate Lancashire Fire and Rescue Service on its excellent performance across all three areas of our assessment. Since its last inspection in 2018, it has improved in almost all areas."

MEMBER CHAMPION ACTIVITY

The Authority appointed its Member Champions at its Annual meeting in June and current Member Champions are:

- Community Safety Councillor Jean Rigby
- Equality, Diversity and Inclusion Councillor Zamir Khan
- Health and Wellbeing County Councillor Andrea Kay
- Road Safety County Councillor Ron Woollam

Reports relating to the activity of the Member Champions are provided on a regular basis to the Authority. This report related to activity for the period June – August 2022. During this period all Champions had undertaken their respective role in accordance with defined terms of reference.

FIRE PROTECTION REPORTS

The Authority discussed a report that summarised Lancashire Fire and Rescue Service prosecutions pertaining to fire safety offences and convictions resulting from 8 arson incidents which had progressed via the criminal justice process.

Fire Protection and Business Support information was also included in the report to provide Members with an update on the continually evolving regulatory position and how the Service was developing and adapting both its services and workforce to ensure it kept pace with the changes to keep public and firefighters safe in the built environment.

BUSINESS CONTINUITY

The Chief Fire Officer provided Members with a brief summary of the responsibilities of the Combined Fire Authority with regards to business continuity and gave a broad overview of the background and current approach to business continuity in times of industrial action.

Liverpool has been selected as the host City for the 67th Eurovision Song Contest. Following the war in Ukraine, Britain opened its doors to welcome thousands of Ukrainians into our communities and homes in Lancashire.

Lancashire has a proud tradition of warmly welcoming refugees from all parts of the world and is proud of the way communities have welcomed and supported our Ukrainian visitors.

These people have been, and continue to be, an inspiration to all of us having left loved ones to fight against the aggression of Putin.

This Council resolves to ask the Chief Executive to write to the Mayor of the Liverpool City Region, Steve Rotherham, and the Secretary of State for Digital, Culture, Media and Sport, asking them to provide 'free' complimentary tickets to Ukrainian refugees from Lancashire for events in and around Eurovision 2023.

170,000 people carry the 'Just Can't Wait Card' across the Country including in Lancashire where the number is rising. Thousands of people across Lancashire suffer from illnesses/conditions which can be debilitating ranging from incontinence to stoma surgery. These conditions can lead to them needing the emergency use of toilet facilities urgently.

The Bladder and Bowel community have established the 'Just Can't Wait Toilet Scheme' which enables people to carry a card and enables businesses and organisations to allow emergency access to toilet facilities.

People have told the Bladder and Bowel Community that they are trapped in their own homes due to the lack of public toilets and the fear of being caught short. There are over 14 million people in the UK living with a bladder condition and 6.4 million with a bowel condition with thousands suffering across Lancashire desperately in need of emergency access to toilet facilities.

Therefore, this Council resolves:

- (i) That Lancashire County Council becomes a partner for the 'Just Can't Wait Card' scheme and commits to making all Lancashire County Council public buildings accessible for those carrying this card.
- (ii) To promote the scheme to other Local Authorities in Lancashire, partners and businesses, including via social media.

3. By County Councillor Whittam:

This Council notes:

During September/October this year the 3 Dads walking group walked 600-miles across the UK to each of the devolved parliaments raising awareness of suicide and ensure the topic is spoken about in schools in a safe and age-appropriate way.

The 3 Dads came together after their daughters took their own lives. They have also launched a petition to get suicide prevention added to the school curriculum and this has now reached over the 100,000 signatures which will enable a debate in Parliament. The debate is yet to take place, but the petition asks for suicide to be spoken about as part of Relationships, Sex and Health Education (RSHE) lessons and for the Department for Education (DfE) to include suicide prevention within the statutory guidelines of the new curriculum.

In 2020, the Government made discussion about mental health as part of the RSHE curriculum mandatory. They will review their statutory guidance in 2023 with an aim to bring in the revised guidance in 2024. The Government is also offering a grant of £1,200 for eligible schools and colleges in England to train a senior mental health lead to develop and implement a whole school or college approach to mental health and wellbeing.

This Council resolves:

- (i) To ask the Leader to write to the 3 Dads Walking Group to support their aim to include suicide awareness in schools on the curriculum.
- (ii) To ask the Chief Executive to write to the Secretary of State for Education to request that suicide awareness and prevention is included in the new guidance as a mandatory part of the RSHE curriculum, and to also ask for the grants to be extended to train senior mental health leads in schools beyond March 2023.
- (iii) To ask the Cabinet Member for Education and Skills and the Cabinet Member for Health and Wellbeing to promote resources to all our schools and colleges and to encourage our eligible schools and colleges to apply for the grant to train a senior mental health lead to develop and implement a whole school or college approach to mental health and wellbeing.

4. By County Councillor Ashton:

Nature-based solutions in tackling the impacts of climate change

This authority notes the importance of nature-based solutions in tackling the impacts of climate change and the collaborative work with partner organisations needed to help with nature recovery and reducing emissions.

Lancashire County Council has recently helped restore 755 Hectares of peatland and planted 150,000 trees on its estate over the past decade. It is crucial we progress this work to help achieve our corporate priority to protect our environment and play our part in meeting the government commitment to net zero by 2050.

This authority resolves that the Cabinet Member for Environment and Climate Change will:

- (i) Prepare a comprehensive strategy for nature recovery for Lancashire.
- (ii) Continue to work with partner organisations to build on the excellent work to date and prepare large-scale tree planning and peatland restoration programmes in Lancashire.
- (iii) Invite the Scrutiny Management Board to consider including engagement in the development of the strategy in the scrutiny work programme.
