Brief Summary

To consider awarding the status of Honorary Alderman or Alderwoman on persons who have, in the opinion of the county council, rendered eminent services to the county council as past Members, but who are no longer serving county councillors.

Recommendation

That Full Council considers the six nominations set out in the report for the awarding of the status of Honorary Alderman or Alderwoman.

Detail

The title of Honorary Alderman may be conferred on persons who have, in the opinion of the county council, rendered eminent services to the county council as former county councillors but who are no longer serving. Those offered the status may choose to be known as "Honorary Alderman" or "Honorary Alderwoman".

The county council uses as its starting point for recognising "eminent services" those councillors who have served at least four terms on the county council.

The following six nominees have each achieved 16 years or more past service as members of Lancashire County Council:

Mr Albert Atkinson	1993 - 2021
Mr Terry Burns	1989 - 2009 and 2013 - 2021
Mrs Susie Charles	2005 - 2021
Mr Kevin Ellard	2001 - 2021
Mrs Elizabeth Oades	2005 - 2021
Mr George Wilkins	2005 - 2021

In accordance with Section 249 of the Local Government Act 1972, nominees must receive the support of not less than two-thirds of the members voting thereon at this extraordinary meeting convened for the purpose of considering the award.
