The Committee considered whether there had been a breach of the code. The views of the Independent Person were sought. Following consideration of those views it was:

Resolved: That, having regard to the views of the Independent Person, the conduct of County Councillor Driver at the meeting on 21 May amounted to a breach of the Code of Conduct in that he had failed to treat Cllr Winlow with respect.

The committee then considered the appropriate sanction. The views of the Independent Person were again sought. Following consideration of these views, it was:

Resolved: That,

- i. having regard to the views of the Independent Person, County Councillor Driver should provide a written apology to Cllr Winlow in respect of Councillor Driver's conduct at the meeting on 21 May.
- ii. the terms of the apology were not prescribed.
