## **ROAD TRAFFIC REGULATION ACT 1984**

## LANCASHIRE COUNTY COUNCIL

(HORROBIN LANE, RIVINGTON, COCKER BAR ROAD, MARL COP, AND NORTH ROAD, BRETHERTON, CHORLEY BOROUGH) (REVOCATION, 30MPH, 40MPH AND 50MPH SPEED LIMITS, AUGUST 2019) ORDER 201\*

The County Council of Lancashire, in exercise of its powers under 83(2) and Section 84 and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

#### 1. Revocation

The "Lancashire County Council (North Road, Cocker Bar Road, Marl Cop, Bretherton, Chorley Borough) (50 mph Speed Limit) Order 2008" is hereby revoked in full.

#### 2. <u>30mph Speed Limit</u>

No person shall drive any motor vehicle at a speed exceeding 30mph on the length of road as set out in Schedule 1 to this Order.

## 3. 40mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 40mph on any of the lengths of road as set out in Schedule 2 to this Order.

## 4. <u>50mph Speed Limit</u>

No person shall drive any motor vehicle at a speed exceeding 50mph on the length of road as set out in Schedule 3 to this Order.

#### 5. Exemption

No speed limit imposed by this order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those Regulations.

#### 6. Commencement of Order

This Order shall come into force on the \*\* day of \*\* 201\* and shall be cited as the "Lancashire County Council (Horrobin Lane, Rivington, Cocker Bar Road, Marl Cop, And North Road, Bretherton, Chorley Borough) (Revocation, 30mph, 40mph And 50mph Speed Limits, August 2019) Order 201\*".

## Schedule 1 - 30mph Speed Limit

Horrobin Lane, Rivington, from a point 230 metres south-west of its junction with Rivington Lane for a distance of 415 metres in a south-westerly direction.

## **Schedule 2 - 40mph Speed Limit**

- a) Cocker Bar Road, Bretherton, from its junction with Marl Cop and North Road for a distance of 120 metres in an easterly direction.
- b) Marl Cop, Bretherton, from its junction with North Road for a distance of 439 metres in a south-westerly direction.
- c) North Road, Bretherton, from its junction with Carr House Lane to its junction with Marl Cop and Cocker Bar Road in a general easterly direction.

# Schedule 3 - 50mph Speed Limit

Cocker Bar Road, Bretherton, from a point 120 metres east of its junction with Marl Cop and North Road for a distance of 763 metres in a general easterly direction.
