Executive Summary

This report relates to the replacement of County Councillor Aidy Riggott by County Councillor Joan Burrows as Lead Member for Economic Development and Cultural Services.

Reason for Urgency

This decision is urgent and cannot await the next meeting of Cabinet on 14 January 2021. The reason for this is to enable the Lead Member change to be made effective from 4 December 2020. This decision is therefore being taken on behalf of Cabinet by the Leader of the Council in accordance with the provisions of Standing Order C16(1).

Recommendation

The Leader of the County Council is asked to approve the replacement of County Councillor Aidy Riggott by County Councillor Joan Burrows as Lead Member for Economic Development and Cultural Services with effect from 4 December 2020.
