## NOTICE OF PROPOSAL ROAD TRAFFIC REGULATION ACT 1984 LANCASHIRE COUNTY COUNCIL

## (ELKER LANE AND ELKER MEADOWS, BILLINGTON, RIBBLE VALLEY BOROUGH) (PROHIBITION OF WAITING) ORDER 202\*

**NOTICE IS HEREBY GIVEN** that Lancashire County Council propose to make the above Traffic Regulation Order under Sections 1, 2 and 4 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to introduce a prohibition of waiting in the following lengths of road:

- 1) Elker Lane, Billington, the west side, between points 47 metres north and 55 metres south of its junction with the Centreline of Elker Meadows;
- 2) Elker Meadows, Billington, the east side, from its cul-de-sac end for a distance of 25 metres in a southerly direction;
- 3) Elker Meadows, Billington, the north side, from its junction with the Centreline of Elker Lane for a distance of 47 metres in a westerly direction;
- 4) Elker Meadows, Billington, the north east side, from a point 40 metres south of its cul-de-sac end for a distance of 15.5 metres in a south easterly direction;
- 5) Elker Meadows, Billington, the south side, from is junction with the Centreline of Elker Lane for a distance of 17 metres in a westerly direction;
- 6) Elker Meadows, Billington, the south west and west side, from a point 32 metres west of its junction with the Centreline of Elker Lane, in a westerly direction, to its cul-de-sac end.
