Background and Advice

There are currently six "Champion" roles and each Champion has been provided with an annual budget of £10,000 to support their work in their respective roles, making a total annual budget of £60,000.



The Champions for the year 2020/21 were:

- Champion for Armed Forces and Veterans County Councillor Alf Clempson
- Champion for Disabled People (now former) County Councillor Peter Steen
- Champion for Mental Health County Councillor Eddie Pope
- Champion for Older People County Councillor Joan Burrows
- Champion for Parishes County Councillor Paul Rigby
- Champion for Yong People (now former) County Councillor David Foxcroft

The annual budget of £10,000 for each Champion is allocated for use at their discretion to finance activities including organising and attending meetings, seminars and conferences and other similar events; the payment of a grant or loan to individuals and outside bodies or organisations within the scope of their remit; and other incidental costs necessary to enable them to fulfil their roles.

Each Champion is required to submit an annual report to the Cabinet setting out how their allocation has been spent.

Attached at Appendices 'A' - 'F' are the annual reports for 2020/21 for each Champion and former Champion, which outlines the activities undertaken and expenditure incurred between 1 April 2020 and 31 March 2021 in their respective roles.
