RESTRICTIONS, MARCH 20 (NO1)) ORDER 202*



NOTICE IS HEREBY GIVEN that Lancashire County Council proposed to make the above named Traffic Regulation Order under Sections 1, 2, 4, 45 and 46 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended. Following consultation, it is now proposed to modify the proposed Order as titled above, to make the order in part, giving effect to the proposal as previously set out, with the exception of the restrictions set out below, which are proposed to be deferred.

For the avoidance of doubt, it is now proposed that the restrictions set out below will be deferred and that in the future the council may consider:

- a) Abandoning these proposals;
- b) Deferring a decision on their introduction; or
- c) To introduce the restrictions, either in whole or part.

Proposals to be deferred

Introduce a prohibition of waiting in the following lengths of road:

- a) Carrwood Road, Walton-le-Dale, both sides, from its junction with the A6 London Way roundabout to its junction with The Cawsey in a general south westerly direction;
- b) Carrwood Way, Bamber Bridge, both sides, from its junction with the centreline of Carrwood Road roundabout for a distance of 30 metres in a southerly direction;
- c) Clough Avenue, Walton-le-Dale, both sides, from its junction with the centreline of Carrwood Road for a distance of 13 metres in a northerly direction:
- d) Eagleton Way, Penwortham, both sides, from its junction with the centreline of The Cawsey for a distance of 15 metres in a westerly direction;
- e) Firs Drive, Penwortham, both sides, from its junction with the centreline of The Cawsey for a distance of 10 metres in an easterly direction;
- f) Handshaw Drive, Penwortham, both sides, from its junction with the centreline of The Cawsey for a distance of 15 metres in a south easterly direction;
- g) Loxwood Close, Walton-le-Dale, both sides, from its junction with the centreline of Carrwood Road for a distance of 13 metres in a north westerly direction;
- h) Millwood Road, Lostock Hall, both sides, from its junction with the centreline of Carwood Road for a distance of 15 metres in a south easterly direction;
- Saxon Place, Penwortham, both sides, from its junction with the centreline of The Cawsey for a distance of 15 metres in a north westerly direction;
- j) The Oaks, Walton le Dale, both sides, from its junction with the centreline of Carrwood Road for a distance of 13 metres in a southerly direction;
- k) Valley View, Walton-le-Dale, both sides, from its junction with the centreline of Carrwood Road roundabout for a distance of 30 metres in a north westerly direction;
- The Cawsey, Penwortham, both sides, from its junction with Leyland Road roundabout to its junction with Carrwood Road in a general north easterly direction;

Statement of Reasons

Having considered the consultation responses it is now proposed to re-review the proposals on the above roads with the intention of proposing a less restrictive scheme which will alleviate the concerns raised during the consultation.
