

NOTICE OF MODIFICATION
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(VARIOUS ROADS, VARIOUS LOCATIONS, CHORLEY, FYLDE,
PENDLE, PRESTON, ROSSENDALE, SOUTH RIBBLE, WEST
LANCASHIRE AND WYRE) (REVOCATIONS, AMENDMENT TO
PERMIT PARKING PROVISIONS, AND VARIOUS PARKING
RESTRICTIONS, MARCH 20 (NO1)) ORDER 202*



NOTICE IS HEREBY GIVEN that Lancashire County Council proposed to make the above Traffic Regulation Order under Sections 1, 2, 4, 45 and 46 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended. Following consultation carried out between 27th April 2021 and 28th May 2021, it is now intended to modify the proposed Order as titled above, as set out below.

- a) Insert Item ii) into Schedule 1H of that Order;
- b) Remove Items cc), dd) and ee) from Schedule 3 of that Order;
- c) Remove the text from Item ff) of Schedule 3 of that Order and replace it with the following "Merchant Road, Ormskirk, both sides, from its junction with the Centreline of Pinfold Road for a distance of 13 metres in an easterly direction."
- d) Remove the text from Item gg) of Schedule 3 of that Order and replace it with the following "Merchant Road, Ormskirk, both sides, from its junction with the Centreline of Mulberry Close for a distance of 11.5 metres in a westerly direction."
- e) Remove the text from Item ii) of Schedule 3 of that Order and replace it with the following "Mulberry Close, Ormskirk, the west side, from a point 14 metres south of its junction with the Centreline of Merchant Road, in a northerly direction, to a point 2 metres south of its junction with the Centreline of Spinner Mews."
- f) Remove the text from item jj) of Schedule 3 of that Order and replace it with the following "Pinfold Road, Ormskirk, both sides, from its junction with the Centreline of Wigan Road (A577) in a southerly direction, to a point 60 metres north of its junction with the Centreline of Merchant Road."
- g) Remove the text from item kk) of Schedule 3 of that Order and replace with the following "Pinfold Road, Ormskirk, the east side, between points 13 metres north and 12.5 metres south of its junction with the Centreline of Merchant Road."
- h) Remove all text from Schedule 7 of that Order and replace it with the following:
 - a) Merchant Road, Ormskirk, the south side, from a point 13 metres east of its junction with the Centreline of Pinfold Road, in an easterly direction, to a point 11.5 metres west of its junction with the Centreline of Mulberry Close.
 - b) Pinfold Road, Ormskirk, the east side, from a point 12.5 metres south of its junction with the Centreline of Merchant Road for a distance of 24.5 metres in a southerly direction.
 - c) Pinfold Road, Ormskirk, the east side, between points 13 metres north and 60 metres north of its junction with the Centreline of Merchant Road.

Statement of Reasons

The purpose of the amendment to this proposal is to rectify an error in the original proposal on the north side of Merchant Road and to clarify the exact measurements of the proposals in line with the informal consultation carried out in July 2020. Due to an administration error a section of No Waiting at Any Time (double yellow lines) was incorrectly advertised as being introduced on the north side of Merchant Road. There is no intention of extending the double yellow line restriction past the informally consulted junction protections at both the Pinfold Road and Mulberry Close ends. This amendment is to rectify any confusion or concern that may have occurred as a result of this error.
