

# **STATEMENT OF REASONS**

This proposed order covers Chorley, Fylde, Pendle, Preston, Rossendale, South Ribble, West Lancashire and Wyre for the following types of restrictions

- New proposals in Chorley, Fylde, Pendle, South Ribble, West Lancashire and Wyre
- Formalising of existing restrictions in Wyre
- Revocations Only in Pendle and Burnley
- Rectification of discrepancies in current order in Pendle, Preston and Rossendale

#### **Reasons under Section 1 of the RTRA**

- (a) for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising;
- (c) for facilitating the passage on the road or any other road of any class of traffic (including pedestrians);
- (d) for preventing the use of the road by vehicular traffic of a kind which, or its use by vehicular traffic in a manner which, is unsuitable having regard to the existing character of the road or adjoining property, or
- (f) for preserving or improving the amenities of the area through which the road runs

#### 1) New proposals to address safety concerns

"The purpose of these proposals are to address safety concerns of vehicles parking causing serious problems with regard to safe traffic movement and obstruction of driver's visibility impeding access and egress to adjacent properties in particular for emergency service vehicles and larger deliveries and refuse collection vehicles.

Grimeford Lane and A673 Bolton Road, Grimeford Village, Anderton	The purpose of this proposal it to prohibit parking which is causing serious problems with regard to safe traffic movement and obstruction of driver's visibility along these roads

The proposal reduces the extent of the existing 'Permit Holders Only' parking north of the proposed vehicle crossing, however, introduces an additional 'Permit Holders Only' parking area south of the proposed vehicle crossing.
Boston Road and Clitheroe Road, St Annes	FYLDE         Following investigations concerning junction sightline issues, particularly in the immediate vicinity of the Primary School a Prohibition of Waiting is being proposed to address potential road safety issues which may arise.         The purpose of the proposal is to remove obstructive parking and assist with the general movement of traffic along the roads and at their junctions with other roads, whilst improving access for deliveries to the residential properties and improving general road safety for all highway users.

Beach Street and Rear 23 – 35 Church Road, Lytham	Following receipt of access concerns and compromised sightlines caused by parked vehicles within the immediate vicinity of a junction it is proposed to introduce a Prohibition of waiting to address these safety concerns.
	The purpose of this proposal is to remove obstructive parking which is causing serious problems with regard to safe traffic movement and obstruction of driver's visibility along these roads. The proposals will assist with the general movement of traffic along the roads and their junctions with other roads, improve access for deliveries to the residential properties and improve general road safety for highway users.

Earby Road, Salterforth	Following receipt of concerns relating to obstructive parking it is proposed to extend the existing Prohibition of Waiting to address these safety concerns. The purpose of this proposal is to remove obstructive parking and assist with the general movement of traffic along the road and at the junctions with other roads.
Gisburn Road, Higherford	The purpose of this proposal is to extend the current Prohibition of Waiting to include the south side of Gisburn Road to assist with the general movement of traffic along the road and at the junctions caused by obstructive parking.
	SOUTH RIBBLE
Cuerdale Lane and Spring Lane, Samlesbury	Following recent concerns regarding significant verge damage predominantly caused by the issue of HGVs parking around these locations and also the issue of HGVs parking too close to the junction of Spring Lane & Cuerdale Lane it is proposed to introduce a Prohibition of Waiting restriction.
	The purpose of this proposal is to remove obstructive parking and assist with the general movement of traffic along the roads and at their junction with other road whilst improving access for deliveries to the residential properties
	The proposal will also preserve the amenities of the area whilst improving general road safety for all highway users.

Service Road Fronting 72a to 84 Turpin Green Lane, Leyland	Vehicles parking at the mouth of this service road are causing obstruction issues when entering and exiting onto Turpin Green Lane. In addition to this, these vehicles are parking on mobility crossings and are causing issues for disabled pedestrians. The purpose of this proposal is to introduce a Prohibition of Waiting to remove obstructive parking and protect the mobility crossings improving the general road safety for all highway users including pedestrians.
Lourdes Avenue and St Gerrards Avenue, Lostock Hall	The purpose of this proposal is to address safety concerns regarding the junction of Lourdes Avenue and St Gerrards Road which have been highlighted as having problems with the free movement of traffic and pedestrian safety as a result of parked cars. The proposed restrictions will assist with the general movement of traffic along the roads and their junctions with other roads, improve access for deliveries to the residential properties and improve general road safety for highway users.
Carrwood Road; The Cawsey; Millwood Road; Clough Avenue; The Oaks; Valley View; Carrwood Way; Loxwood Close; Firs Drive; Eagleton Way; Handshaw Drive; Saxon Place, Penwortham and Walton le Dale	The purpose of this proposed order is to remove parked vehicles from a strategic route to facilitate the free flow of traffic and to remove parked vehicles which have been compromising sightlines at specific junctions along the strategic route. These restrictions are being proposed following receipt of significant road safety concerns regarding compromised sightlines at junctions and free flow of traffic on this primary strategic route. These restrictions will remove obstructive parking and assist with the general movement of traffic along the roads and at their junctions whilst improving access to the residential properties and improve general road safety for all highway users.

Holland Court, Crawford Road, Up Holland	Following concerns of obstructive parking at the junctions and along the access road which are causing traffic flow and parking issues it is proposed to introduce a Prohibition of Waiting.
	The purpose of this proposal is to remove obstructive parking at the junctions and along the access road which is causing traffic flow and parking issues assisting with the general movement of traffic along the road and improving movement through the junctions.
Pinfold Road, Merchant Road, Warpers Way and Mulberry Close, Ormskirk	The purpose of this proposal is to prohibit parking along these roads to remove unnecessary and inconsiderate hospital parking that is causing serious problems with regard to safe traffic movement and obstruction of driver's forward visibility along these roads.

Broadway and Melbourne Avenue, Fleetwood	Following receipt of road safety concerns specifically regarding compromised sightlines in the immediate vicinity of the school crossing point outside Cardinal Allen RC High School it is proposed to introduce a Prohibition of Waiting around and opposite the junction of these roads.
	The purpose of these proposals is to remove obstructive parking and to assist with the general movement of traffic along the roads and at their junctions with other roads, whilst improving access for deliveries to residential properties and improving general road safety for all highway users.

	The purpose of these proposals is to clarify, simplify and tidy up a selections of traffic orders that have been identified in the Preston area. The orders are to improve the safety of all highway users (including pedestrians) whilst providing parking amenities where necessary.

### 3) Formalisation of Existing Advisory Disabled Parking Bays

"The purpose of these proposals is to formalise the current residential Disabled Parking Bays that are currently being misused to allow for effective enforcement.

The proposals seek to clarify the restrictions on site with no material change to any access provisions for type of vehicles being able to park."

The original Disabled Parking Bay was advertised in 2015 and the objections were not upheld, it was approved by cabinet on 12/02/2015, however unfortunately never implemented.
88 Warren Street, Fleetwood	The purpose of this proposal is to formalise the existing advisory Disabled Parking bay outside the Hall at 88 Warren Street which is being misused, to allow for enforcement.
