### Brief Summary

To approve the nomination of Angie Ridgwell, Chief Executive and Director of Resources, as the Local Authority Partner Member of the Lancashire and South Cumbria Integrated Care Board.

### Reason for Urgency

This decision is urgent and cannot await the next meeting of Cabinet on 9 June 2022. The reason for this is that nominations to this are required to be made by 25 May 2022. This decision is therefore being taken on behalf of Cabinet by the Leader of the Council in accordance with the provisions of Standing Order C16(1).

### Recommendation

The Leader of the County Council and Cabinet Member for Resources, HR and Property (Deputy Leader) are asked to approve the appointment of Angie Ridgwell to be the Local Authority nominated Partner Member on the Lancashire and South Cumbria Integrated Care Board be approved

This decision should be implemented immediately for the purposes of Standing Order C29 as any delay could adversely affect the execution of the County Council's responsibilities. The reason for this is that nominations are required to be made by 25 May 2022 to what will be an extremely significant body in future health and social care services.

## **Detail**

The Lancashire and South Cumbria Integrated Care Board will be established from 1 July 2022.

The Board will have one voting partner nominated by the upper tier local authorities in the area of the Integrated Care Board. Following discussions with Cumbria, Blackburn with Darwen and Blackpool councils, it has been agreed that Angie Ridgwell, Chief Executive and Director of Resources at Lancashire County Council, will be the nominated representative.

This appointment will be added to the list of Outside Body appointments approved by Cabinet for the future.
