

NOTICE OF MODIFICATION
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(VARIOUS ROADS, PRESTON CITY AREA) (REVOCATION AND INTRODUCTION OF PARKING PLACES)
ORDER 202*

NOTICE IS HEREBY GIVEN that Lancashire County Council proposed to make the above Traffic Regulation Order under Sections 1, 2, 4, 45 and 46 to the **Road Traffic Regulation Act 1984**, as amended. Following consultation carried out between 20 January 2023 and 17 February 2023, it is now intended to modify the proposed Order as titled above, as set out below.

1. Amend Schedule 2 Eligible Properties, as follows:
 - a) Remove Guildford Street from AV2.
 - b) Insert Guildford Road into AV2.
 - c) Remove the Eligible Properties for 12 Bairstow Street in AV1.
 - d) Insert the following Eligible Properties for Bairstow Street in AV1:
12 Lowden House Flats 1-6 Only
 - e) Remove the Eligible Properties for West Cliff 68-Parkinson House in WC1.

2. Amend Schedule 3 Permit Holders Only, as follows:
 - a) Remove Item (30)b East Cliff Road.
 - b) Insert the following:

 - c) Remove Items (41)a(i), (41)a(ii), (41)a(iii), (41)a(iv), (41)b(i), (41)b(ii), (41)b(iii), (41)b(iv), (50)(i), (50)(ii), (57)a(i), (57)a(ii), (57)a(iii), (57)b(i), (57)b(ii), (57)b(iii) and (57)b(iv).

3. Introduce Permit Holders Only and 1 Hour Limited Waiting With No Return Within 1 Hour in the following lengths of road:

			b) the south west side	(i) from a point 77.5 metres south east of its junction with the centreline of Fishergate Hill for a distance of 57 metres in a south easterly direction (ii) from a point 43 metres south east of its junction with the centreline of Fishergate Hill for a distance of 28.5 metres in a south easterly direction (iii) from a point 7 metres south east of its junction with the centreline of Hind Street for a distance of 15 metres in a south easterly direction (iv) from a point 140.5 metres south east of its junction with the centreline of Fishergate

4. Remove Item (5) from Schedule 10.

5. Amend Schedule 19 as follows:

- a) Amend the Schedule title to Pay and Display Parking 8am – 6pm Max Stay 2 Hours No Return within 2 Hours;
- b) Remove Items (4)b)(ii) Cross Street and (6) Guildhall Street;
- c) Add the following Items:

For the avoidance of doubt, it is now proposed that the restrictions set out below will be deferred and that in the future the council may consider:

- a) Abandoning these proposals;
- b) Deferring a decision on their introduction; or
- c) To introduce the restrictions, either in whole or part.

6. The following items are to be deferred from Schedule 3:

(29)a and (29)b Driscoll Street, (31)a), (31)b) and (31)c) East Street, (32)(i), (32)(ii) and (32)(iii) East View, (33)a) and (33)b) Edmund Street, (51)(i) and (51)(ii) Holstein Street, (52) Hopwood Street, (70)a) and (70)b) Shaw Street, (75)(i) and (75)(ii) St Ignatius Square (Eastern Leg), (76) St Ignatius Square (Western Leg), (77a) and (77)b) St Pauls Square (Eastern Leg), (78)a)(i), (78)a)(ii) and (78)b) St Pauls Square (Northern Leg), (79)a) and (79)b) St Pauls Square (Southern Leg), (81) St Barnabas Place, (82) St Ignatius Place, and (86)(i), (86)(ii) and (86)(iii) Stanleyfield Road.

8. The following Items are to be deferred from Schedule 8:

(1)(i) and (1)(ii) East Street, and (2) St Pauls Square (Northern Leg).
