

NOTICE OF MODIFICATION
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL

**(VARIOUS ROADS, PRESTON CITY AREA) (REVOCATION, PROHIBITION AND RESTRICTION
OF WAITING, PROHIBITION OF LOADING, LIMITED WAITING PARKING PLACES AND
DISABLED PARKING PLACES) ORDER 202***

NOTICE IS HEREBY GIVEN that Lancashire County Council proposed to make the above Traffic Regulation Order under Sections 1, 2, 4, 45 and 46 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended. Following consultation carried out between 20 January 2023 and 17 February 2023, it is now intended to modify the proposed Order as titled above, as set out below.

1. Amend Schedule 1b - Revocation as follows:
 - a) Remove Items (131)a)(ii), (131)a)(iii), (137)c), (138)b)(i), (138)b)(ii), (229)a), (231), (370)a), (394)a), (394)b), (399)a), (400)a), (401)b), (408)a), (408)b), (409)a)(i), (409)a)(ii), (409)a)(iii), (409)a)(iv), (409)b), (409)c)(i), (409)c)(ii), (410)a), (410)b)(i), (410)b)(ii), (423)b)(i), (423)b)(ii), and (423)b)(iii) of Schedule 10.01;
 - b) Remove Items (68), (72)(i), (72)(ii), (72)(iii), (201)(i) and (201)(ii) of Schedule 11.075;
 - c) Remove Items (7)a)(ii), (7)a)(iii), (13)(i), (13)(ii), (23), (29), (32)a), (32)b)(i) and (32)b)(ii) of Schedule 12.085;
 - d) Remove Items (18)a), (18)b), (40)(i) and (40)(ii) of Schedule 12.105;
 - e) Include Items (199)a)(i), (199)a)(ii), (199)b) and (199)c)(i) of Schedule 10.01;
 - f) Include Items (19)a)(i) and (19)a)(ii) of Schedule 13.01.
2. Amend Schedule 1g – Revocation as follows:
 - a) Include Items c) and d) of Schedule 5;
 - b) Include Item c) of Schedule 7.
3. Revoke the "Lancashire County Council (Fishergate Phase 2, Various Roads, Preston, Preston City) (Revocation and Various Parking Restrictions) Order 2016" insofar as it relates to:

 - c) Item v) of Schedule 13;
 - d) Item b) of Schedule 16;
 - e) Schedule 21.
4. Amend Schedule 2 -Prohibition of Waiting as follows;
 - a) Remove Items x) Bromley Street, y), Bromley Street, z) Bromley Street, pp) Church Avenue, zzzz) Hind Street, cccc) Hind Street, uuuuu) Maddy Street, vvvvv) Maddy Street, wwwww) Maddy Street, mmmmm) Spa Street, nnnnn) Spa Street, ooooo) Spa Street, ppppp) Spa Street, zzzzz) St Marks Place East, aaaaaa) St Marks Place East, bbbbbb) St Marks Place East, cccccc) St Marks Place West, ddddd) St Marks Place West, eeeee) St Marks Place West, fffff) St Marks Road, ggggg) St Marks Road, hhhhh) St Marks Road, jjjjj) St Marks Road, lllll) St Marks Road, mmmmm) St Marks Road, ooooo) St Marks Road, ssssss) Wellington Street, ttttt) Wellington Street, uuuuuu) Wellington Street, vvvvvv) Wellington Street, xxxxxxx) Wellington Street, yyyyyyy) Wellington Street, bbbbbb) Wellington Street.
 - b) Insert the following lengths of road:
 - i) Guildhall Street, Preston, the east side, from its junction with the centreline of Cross Street for a distance of 16.5 metres in a northerly direction;
 - ii) Guildhall Street, Preston, the east side, from a point 53.5 metres north of its junction with the centreline of Cross Street for a distance of 28.5 metres in a northerly direction;
 - iii) Guildhall Street, Preston, the east side, from a point 106 metres north of its junction with the centreline of Cross Street for a distance of 40.5 metres in a northerly direction;
 - iv) Guildhall Street, Preston, the west side, from its junction with the centreline of Cross Street for a distance of 146.5 metres in a northerly direction;
 - v) Hind Street, Preston, both sides, from a point 70.5 metres south west of its junction with the centreline of Grafton Street to its junction with the centreline of South Meadow Lane.

- vi) Maddy Street, Preston, both sides, from its junction with the centreline of Wellington Street to its junction with the centreline of West View Terrace.
5. Amend Schedule 3 – Prohibition of Loading and Unloading to insert the following:
 - a) Guildhall Street, Preston, the east side, from its junction with the centreline of Cross Street for a distance of 16.5 metres in a northerly direction;
 - b) Guildhall Street, Preston, the east side, from a point 53.5 metres north of its junction with the centreline of Cross Street for a distance of 28.5 metres in a northerly direction;
 - c) Guildhall Street, Preston, the east side, from a point 106 metres north of its junction with the centreline of Cross Street for a distance of 40.5 metres in a northerly direction;
 - d) Guildhall Street, Preston, the west side, from its junction with the centreline of Cross Street for a distance of 82 metres in a northerly direction.
 6. Remove Schedule 5.
 7. Amend Schedule 6 – Restriction of Waiting Monday to Saturday 8am – 6pm by inserting the following lengths of road:
 - a) East Cliff Road, Preston, the north east side, from its junction with the centreline of East Cliff for a distance of 7 metres in a south easterly direction;
 - b) East Cliff Road, Preston, the north east side, from a point 40 metres south east of its junction with the centreline of East Cliff for a distance of 10 metres in a south easterly direction;
 - c) East Cliff Road, Preston, the south west side, from its junction with the centreline of East Cliff for a distance of 50 metres in a south easterly direction.
 8. Amend Schedule 7 – Restriction of Waiting Monday to Saturday 8am – 6:30pm as follows:
 - a) Remove Item a) Cross Street;
 - b) Insert the following:
 - i) Cross Street, Preston, the south side, from a point 14 metres east of its junction with the centreline of Avenham Road to a point 29 metres west of its junction with the centreline of Chaddock Street;
 - ii) Guildhall Street, Preston, the east side, from a point 121.5 metres north of its junction with the centreline of Cross Street for a distance of 25 metres in a northerly direction.
 9. Amend Schedule 13 – Limited Waiting 2 Hours No Return Within 2 Hours Monday to Saturday 8am – 6pm to insert the following length of road:

East Cliff Road, Preston, the north east side, from a point 31 metres south east of its junction with the centreline of East Cliff for a distance of 9 metres in a south easterly direction.
 10. Introduce a restriction of loading/unloading Monday to Saturday between 8am and 6:30pm in Guildhall Street, Preston, the east side, from a point 121.5 metres north of its junction with the centreline of Cross Street for a distance of 25 metres in a northerly direction.
 11. Introduce a disabled persons parking place between 7am and 7pm in Guildhall Street, Preston, the east side, from a point 82 metres north of its junction with the centreline of Cross Street for a distance of 24 metres in a northerly direction.
 12. Introduce a taxi stand between 7pm and midnight and midnight and 7am in Guildhall Street, Preston, the east side, from a point 82 metres north of its junction with the centreline of Cross Street for a distance of 24 metres in a northerly direction.
 13. The following items are to be deferred from Schedule 2 Prohibition of Waiting:
