Brief Summary

This report presents an application from a local organisation requesting £2,000 towards the cost of new carpets from the Local Member Grants Scheme.

The organisation has submitted a multi-division application requesting a total amount of £2,000 from the Local Member Grants Scheme towards the same project. Recommendation

That consideration be given to the request for grant funding as set out in this report.

It should be noted that the outstanding amount being requested by organisations for grant applications comes to a combined total of £825. The total amount of funding

available in County Councillor Margaret Pattison's budget is £550.

Therefore, the maximum amount of funds that can be approved for outstanding grant requests is £550.

Detail

On 16 December 2021, Full Council approved the reintroduction of the Local Member Grants Scheme. Under the scheme, each county councillor has been given a specific budget which they can spend to enhance the economic, social, and environmental well-being of people who live in their division. Following the reintroduction, using powers in the Local Government and Public Involvement in Health Act 2007, the Leader of the County Council has authorised individual county councillors to take formal decisions on behalf of the county council.

For the financial year 2024/25, each county councillor has a budget of £2000. Each councillor can also carry forward a maximum of £200 that was unspent in the previous financial year. County Councillor Margaret Pattison's total budget is set out in the financial section of the report.

What are you going to spend the grant on?	
<p>Our Morecambe Building is the centre of our charity and houses our advisers and admin teams who provide our service across the district when they aren't out and about. The building is in desperate need of new carpets throughout as they are threadbare and starting to become dangerous.</p> <p>Our clients also use the Morecambe building when they come to see us in person, and we'd like the building to be smarter and more welcoming. In addition, we would like our carpets to have increased insulation to help insulate and lower our heating bills.</p>	
Date of your project / event or the purchase of goods	
<p>We intend to purchase carpets in the next 12 months, and we are applying to a number of different charitable funds to cover the cost.</p>	
How will the money benefit people in the councillor(s) division(s)?	
<p>Our service supported over 7,500 residents across Lancaster District (all divisions) in 2023/4 who were facing over 28,000 different problems. Our work directly benefitted our clients by over £14.9m in reduced debts, benefits claimed, and other costs secured to ensure that residents are getting all the money they are entitled to. Our office in Morecambe is where all our central operations take place and our advisers work across the district in all ward divisions.</p>	
Please give a detailed breakdown of your expenditure for your activity / equipment.	
<p>We have received quotes from three different suppliers based near to our office and the cheapest quote for the whole building (which has 18 rooms that need new carpets) is £9,000 to include installation and an insulating underlay.</p>	
If you are not asking for the full amount of the cost of your activity / equipment, please give us details of where the rest of the funding is coming from. Please also explain what you will do if we give you the grant, but you do not get the other funding.	
<p>The total amount of the new carpets will be £9,000.</p> <p>We have applied to The Hobson Trust, The Jules Thorn Charitable Trust and the Garfield Weston Awards too, to try to cover the costs through several different grants.</p> <p>If we do not get grant funding from these sources, we will continue to apply but we will also use money raised from our fundraising activity this year to cover the cost.</p>
