**Brief Summary**

This report presents an application from a local organisation requesting £2,500 towards the cost of soloists and musicians to perform at the Ernest Tomlinson centenary celebration concert from the Local Member Grants Scheme.

The organisation has submitted a multi-division application requesting a total amount of £2,500 from the Local Member Grants Scheme towards the same project. Requests have been made to each of the following county councillors and a separate report will be submitted to each councillor for their determination:

- County Councillor Andrew Gardiner - £625
- County Councillor Margaret Pattison - £625
- County Councillor Stuart Morris - £625
- County Councillor Charles Edwards - £625

**Recommendation**

That consideration be given to the request for grant funding as set out in this report.

**Detail**

On 16 December 2021, Full Council approved the reintroduction of the Local Member Grants Scheme. Under the scheme, each county councillor has been given a specific budget which they can spend to enhance the economic, social, and environmental well-being of people who live in their division. Following the reintroduction, using powers in the Local Government and Public Involvement in

Health Act 2007, the Leader of the County Council has authorised individual county councillors to take formal decisions on behalf of the county council.

For the financial year 2024/25, each county councillor has a budget of £2000. Each councillor can also carry forward a maximum of £200 that was unspent in the previous financial year. County Councillor Margaret Pattison's total budget is set out in the financial section of the report.

<p>Ernest Tomlinson was a Lancashire-born, light music composer, well known for his work on the BBC Light Programme from 1948 to 1960's and beyond, both as composer, arranger, and conductor. His styles of composing/arranging are renown throughout the music profession, and he is seen as a doyen of light orchestral music compositions. As well as broadcasts, he made many recordings conducting his own music and other light music composers. The benefits to Morecambe, Lancaster City District, NW Region and beyond, is to hear some of his works performed together in a dedicated concert. The main work is his exciting, but rarely heard, <b>Concerto for Five</b>, written for five different saxophones and orchestra, fusing jazz, blues, and light orchestral sounds in one work. The five soloists are professional-standard students</p>	



from the Royal Northern College of Music in Manchester, where, indeed, both the composer and conductor studied many years before when the Royal Manchester College of Music. These students will benefit from the promotion of the work, themselves as an opportunity for young musicians to perform such music in public, while audience members will experience such skills first-hand and appreciate and enjoy the craft of some of Tomlinson's compositions. Publicity will include local schools, colleges, and universities. Care Homes, Defying Dementia and affiliated local arts groups will be encouraged to attend the concert and experience live music. All areas of social and public media will be used and hoping for radio and television coverage. Ticket prices are very reasonably priced at £16 with FREE tickets for accompanied children, as well as carer/assistant. Over the 17 years of over 65 performances since formed, the PCO has also commissioned new works from young composers at the start of their careers; engaged young soloists as they embark on their careers and local young instrumentalists working in the orchestra as RNCM Junior School students, before going on to full-time music studies. We hope to access regional/national interest with this, the only known concert in the country promoting and performing an entire concert dedicated to Ernest Tomlinson's music. In our 17 years existence, we have performed at least 20 of his works and arrangements. The PCO is the only concert orchestra in between Manchester and Glasgow on the West Coast, and across the North, as it specialises in light orchestral music, and the only large Palm Court orchestra in the country performing our annual Music from the Palm Court concert.
