**Brief Summary**

The re-allocation of the county council's 12 votes from CC Phillippa Williamson to CC Graham Gooch at the annual meeting of the Local Government Association's General Assembly on 2 July 2024.

**Reason for the use of the Urgent Business Procedure**

The next meeting of Full Council is not scheduled until 17 October 2024 and the meeting of the General Assembly of the Local Government Association takes place on 2 July 2024 with representatives and voting allocations required to be notified to the Local Government Association by 10 June 2024.

**Recommendation**

Subject to the views of the Chair and Deputy Chair of the Urgency Committee, the Director of Law and Governance proposes to approve the re-allocation of the county council's 12 votes from County Councillor Phillippa Williamson to County Councillor Graham Gooch at the annual meeting of the General Assembly of the Local Government Association on 2 July 2024.

At the Annual General Meeting of Full Council on 23 May, approval was given, as part of the annual appointments to outside bodies, to the county council's representation at the Local Government Association's meeting of the General Assembly on 2 July 2024. The representatives appointed were:

County Councillor Michael Green  
County Councillor Matthew Tomlinson



County Councillor Williamson can no longer attend the meeting and wishes to re-allocate the county council's voting rights to County Councillor Gooch.
