Brief Summary

This report presents an application from a local organisation requesting £2000 towards the Crowdfund Lancashire symposium project from the Local Member Grants Scheme.

The organisation has submitted a multi-division application requesting a total amount of £200 from the Local Member Grants Scheme towards the same project. Recommendation

Detail

On 16 December 2021, Full Council approved the reintroduction of the Local Member Grants Scheme. Under the scheme, each county councillor has been given a specific budget which they can spend to enhance the economic, social, and environmental well-being of people who live in their division. Following the reintroduction, using powers in the Local Government and Public Involvement in Health Act 2007, the Leader of the County Council has authorised individual county councillors to take formal decisions on behalf of the county council.

For the financial year 2024/25, each county councillor has a budget of £2000. Each councillor can also carry forward a maximum of £200 that was unspent in the previous financial year. County Councillor Steven Holgate's total budget is set out in the financial section of the report.

How will the money benefit people in the councillor(s) division(s)?

There are refugee's, drug and alcohol recovery communities, domestic abuse survivors, carers and the neuro diverse that will be exhibiting and leading presentations residing across the board throughout the councillor's divisions. These participants will not only be representing their own life stories but also where they call home, and where they've come to call home.

The benefits to the wider community in the councillor divisions are cultural, social and community development orientated. The aim of the symposium is to promote the celebration of difference and highlight the strengths of individuals and the talents of people living in them through participatory storytelling and discussion of lived experience.

The exhibiting participants will transpose their visual storytelling into literacy-based forms of their choosing through a series of workshops that will enable and support this discovery. They will also lead discussions and presentations on their work as well as lead participatory photography activities with the audience.

Each participant will distribute copies of the zine in their locality to places and people they feel would benefit from being informed of the work they have done and they life they live. The audience themselves will also receive copies of the zine to take back to their communities as well as the experience of participating in the production of new cultural knowledge and being part of a legacy project.

Schools, and various community groups as well as individuals will be invited from the relevant divisions to be active in the symposium and co-create work with the participant exhibitors.

We would especially like to invite councillors to the symposium as active attendee's to become a part of the wider story and witness the testimonies and creative journey's the exhibiting participants have produced.

This would benefit the people in the division as their voices are being heard by people who can influence future outcomes and benefits the councillor's in seeing authentic narrative and discussion on society in true participatory forms that will contribute to cross cultural awareness and enrich community.

The project is being crowdfunded through numerous avenues including small funds, charitable donations from individuals, companies, and other socially focused organisations.

If the full amount is not reached the project, there are two options.

The first is to cut deliverables that do not hinder skills development and the communications aspects of the symposium itself as the commitment to improved literacy and community development will not be scaled back as this is paramount to the project itself.

If cuts would be required, then the zine as an output cost would be preferable to cut then the education and communication side of the symposium.

It is not anticipated that this cut would be needed and much less anticipated would be cuts further than the removal of the zone and its associated costs.

The second option is to extend the funding process and seek further funding avenues. This would require delaying the project to early 2025 and is not preferred.

The project is funded through multiple stakeholders and a grant offer less than asked for should not negatively affect the outcome of the project. It will potentially add further fundraising time to the process and/or require an element to be removed as described in section 9.

Although this is not anticipated the concept of targets not being reached is considered and a delay in delivery of the full project while in pursuit of required funds would be the preferred solution.
